From North

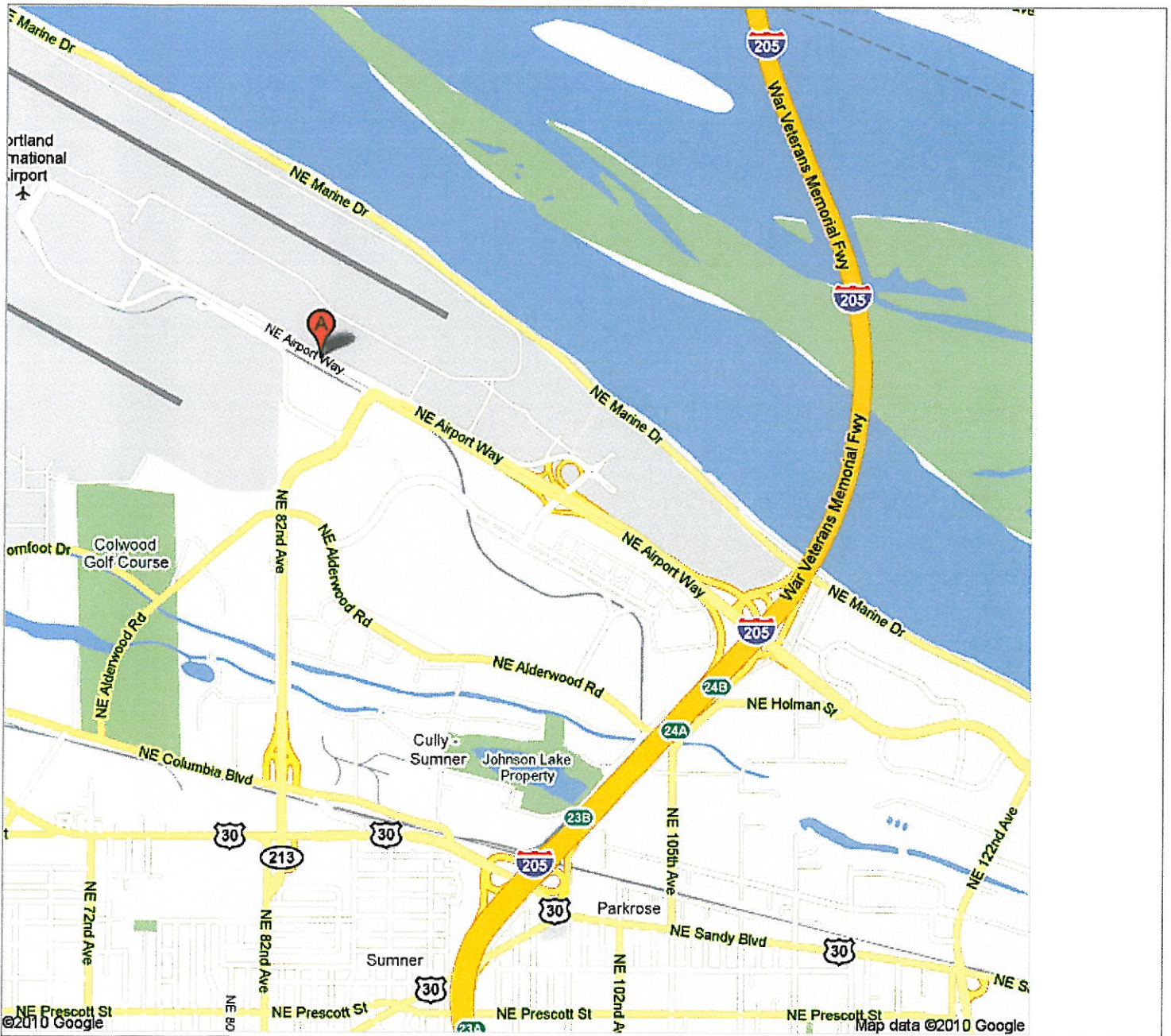

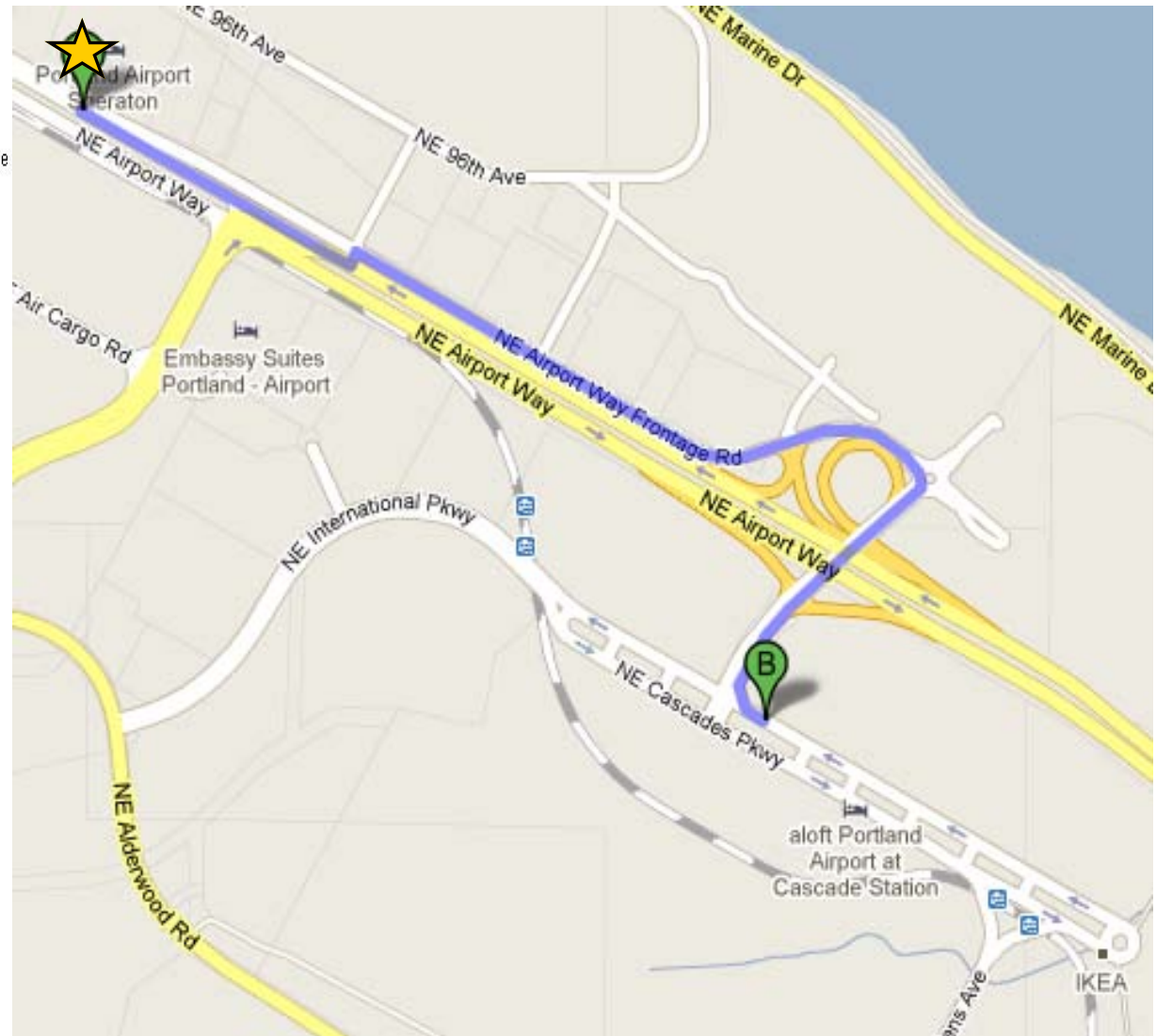
