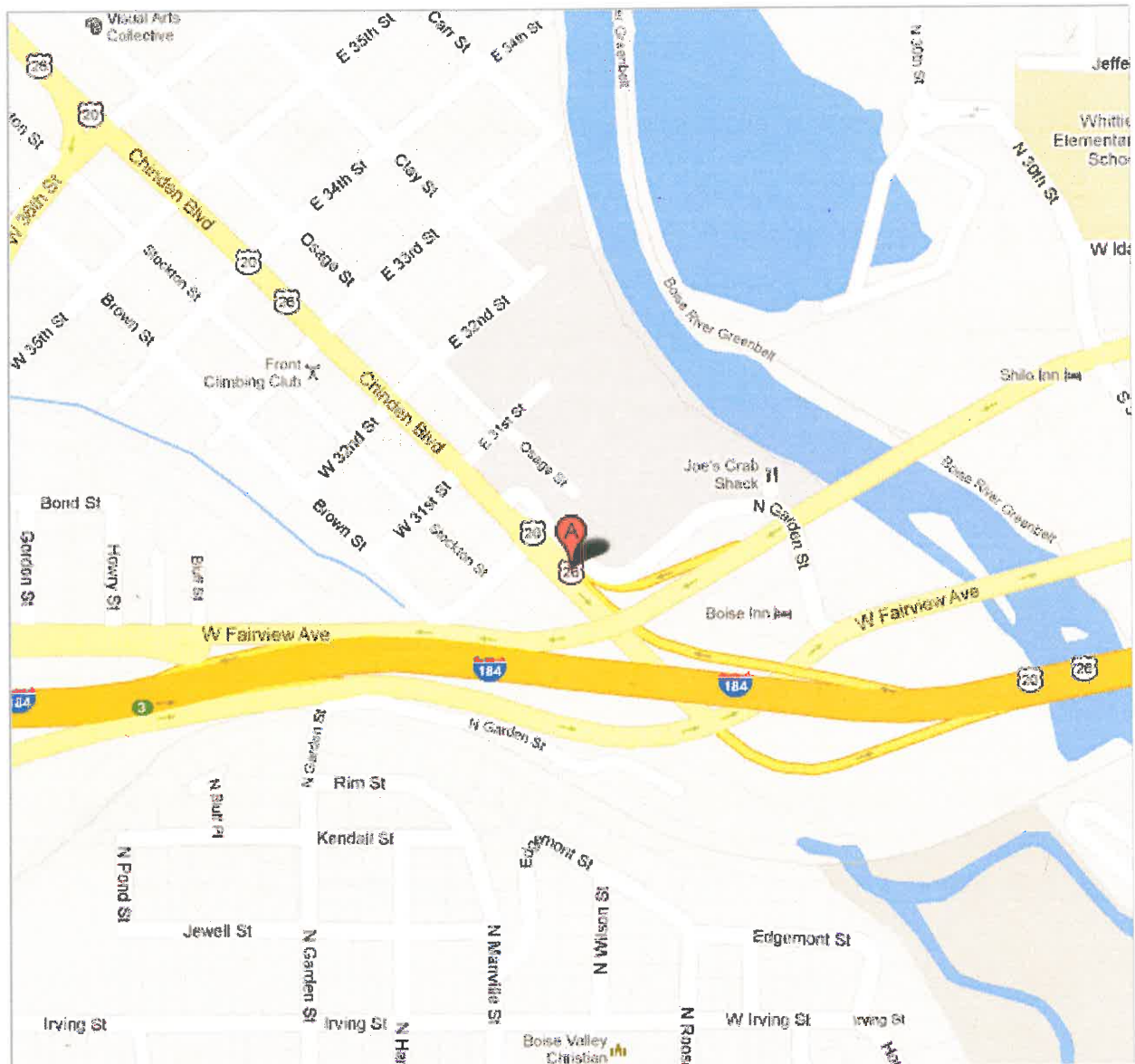

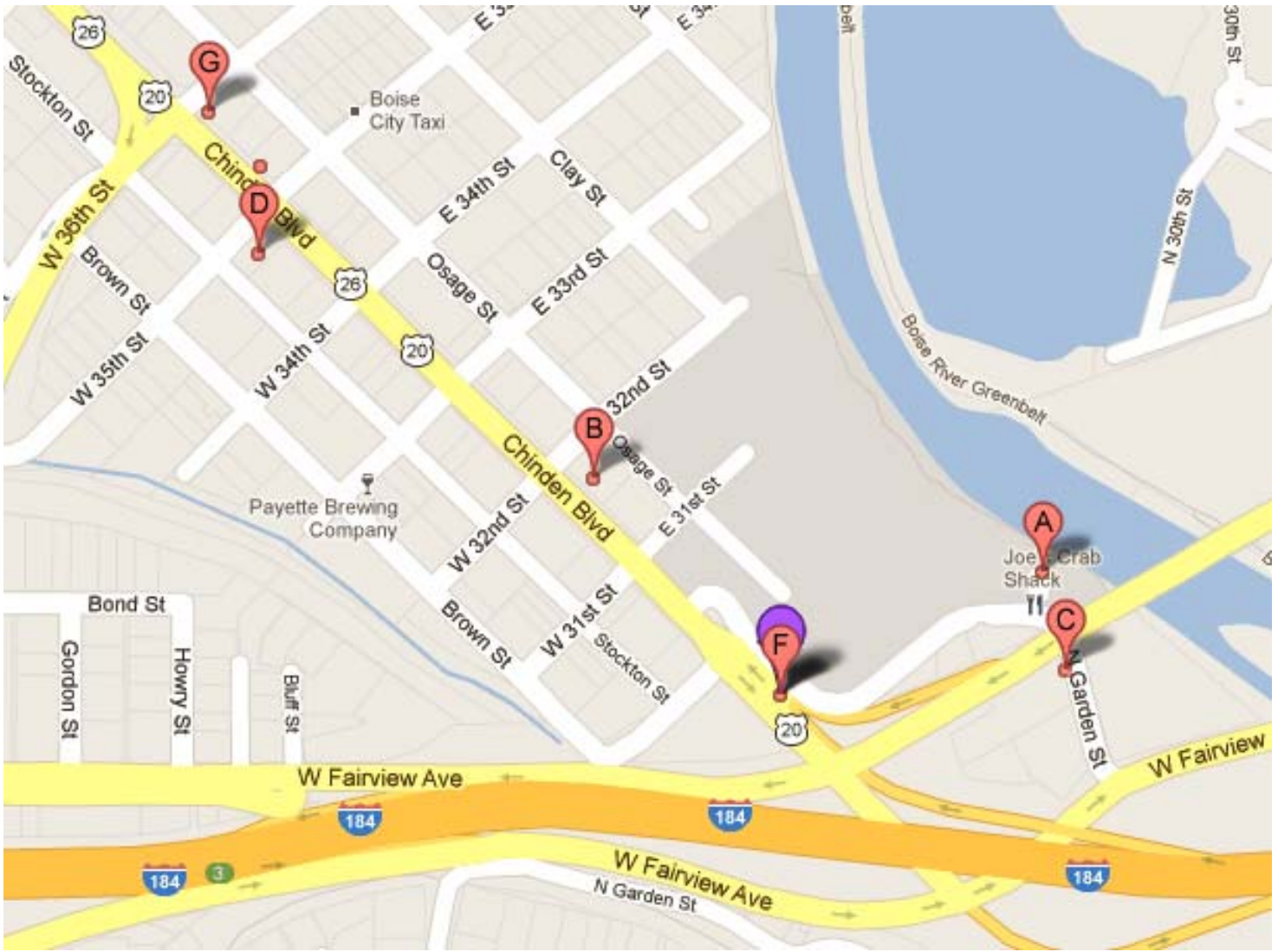

Among Boise hotels, The Riverside Hotel is conveniently and centrally located just off the connector into downtown Boise and Boise Towne Square Mall.

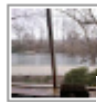

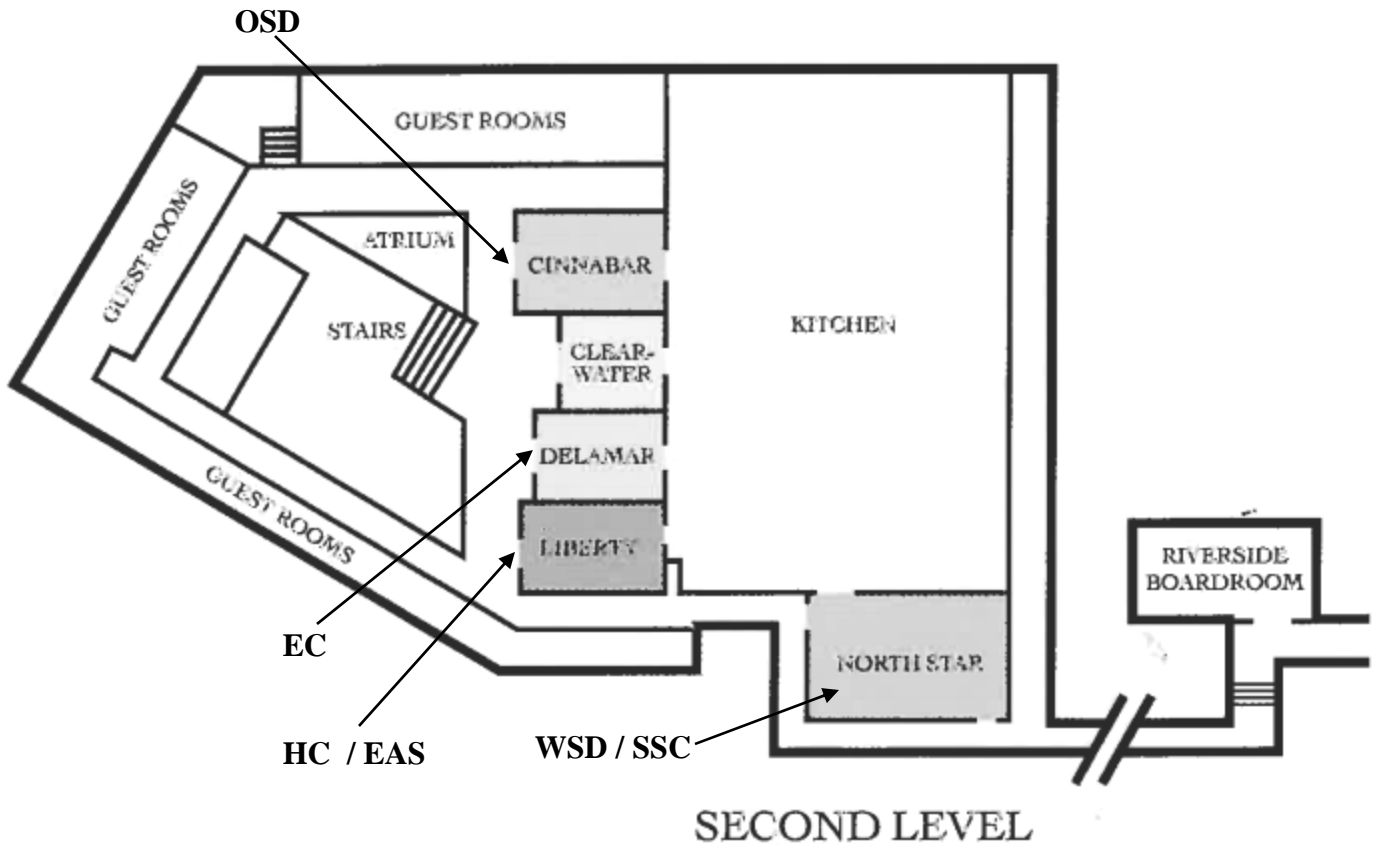
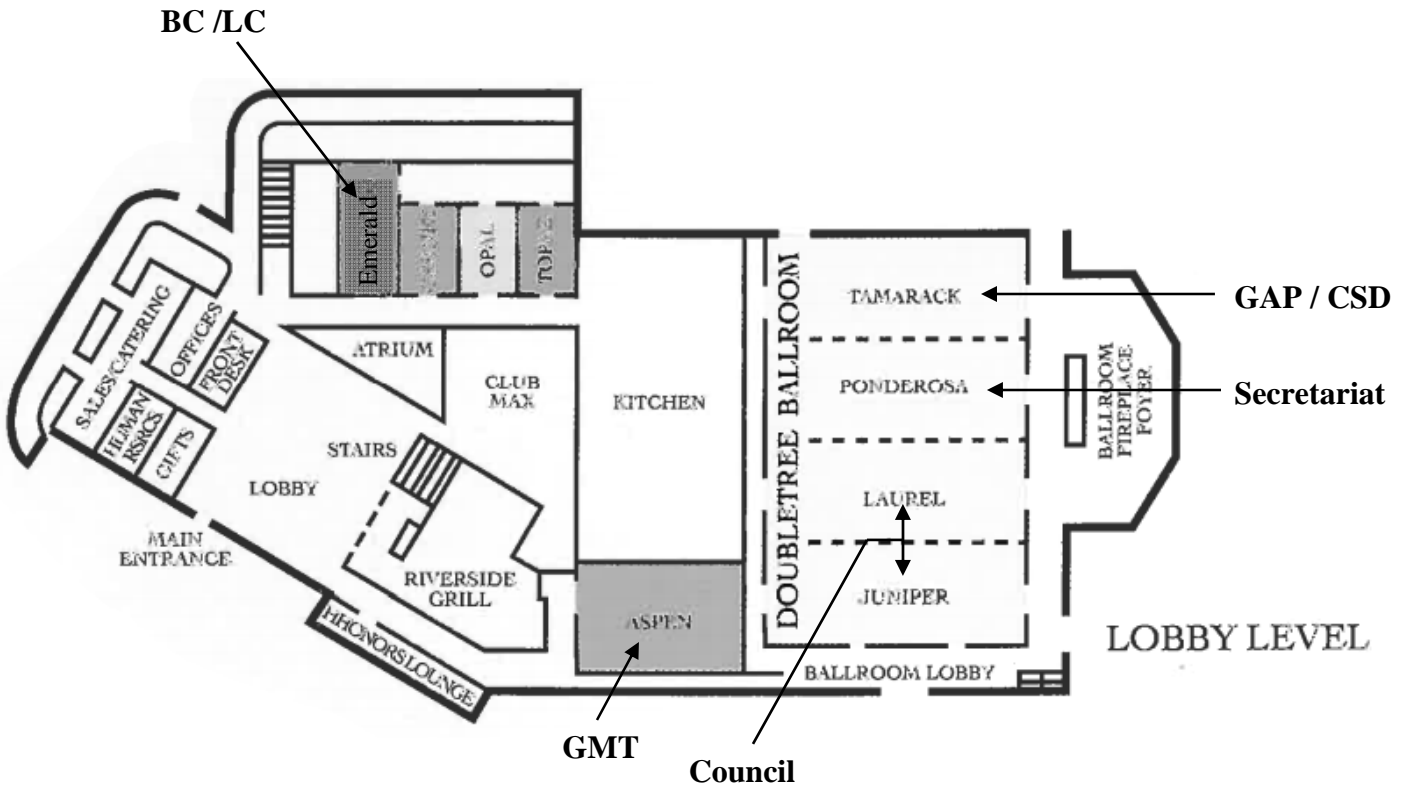
