The Pacific Fishery Management Council (Council) will meet March 7-11, 2013, at the Hotel Murano, Tacoma, Washington. Although neither the Coastal Pelagic Species Management Team (CPSMT) nor the Coastal Pelagic Species Advisory Subpanel (CPSAS) will be meeting in March, there is one CPS-related agenda item, on CPS exempted fishing permits (EFP). The CPSMT and CPSAS discussed the EFP on their joint conference call of January 29, 2013, and are expected to develop supplemental reports to the Council for the March meeting. The Council is tentatively scheduled to take up the CPS EFP matter on Friday, March 8, 2013.

In addition, the revised draft Fishery Ecosystem Plan (FEP) is available for review and comment at <u>http://www.pcouncil.org/ecosystem-based-management/fep-public-review-draft/</u>. As a reminder, the CPSAS and CPSMT both expressed interest in commenting on the FEP, which is scheduled for final adoption by the Council at the April meeting. Any reports on this matter should be completed in time for the April Briefing Book deadline of March 19, 2013.

Enclosed are March agenda materials that might be of interest to you. Thank you for your continued effort in support of the Council and West Coast fishery management.

- SUBJECT: March 2013 Council Meeting

The March Council meeting takes place March 7-11 at the Hotel Murano in Tacoma, Washington. The Highly Migratory Species Management Team (HMSMT) and Highly Migratory Species Advisory Subpanel (HMSAS) will meet Saturday and Sunday, March 9 and 10 beginning at 8:00 a.m. each day. Three HMS topics are on the Council agenda, as described below.

Agenda Item I.1 is the National Marine Fisheries Report. The National Marine Fisheries Service Southwest Regional Office will provide a legislative and regulatory update. The Southwest Fisheries Science Center will describe recent research including an update on ongoing research on alternative gear technologies for targeting swordfish. The Science Center has been using deep-set longline gear during daylight hours to catch swordfish for tagging purposes. Dr. Chugey Sepulveda of the Pfleger Institute of Environmental Research (PIER) will describe ongoing cooperative research on buoy gear. The Council will hear these reports on Sunday, March 10.

Agenda Item I.2 is a follow-up on Council action at the March 2012 meeting with respect to regulatory actions for the west coast swordfish fishery. Based on guidance from the Council, the HMSMT is providing information to help the Council decide about pursuing a change in the southern boundary of the Pacific Leatherback Conservation Area (PLCA) for all or part of the current closure period. The PLCA is closed to large mesh drift gillnet vessels from August 15-November 15 each year. The Council will take up Agenda Item I.2 on Sunday, March 10.

Agenda Item I.3 covers international HMS activities including the U.S.-Canada Albacore Treaty, the recent stock assessment for Pacific bluefin tuna, and the precautionary management framework for North Pacific albacore tuna under development by the Western and Central Pacific Fisheries Commission's Northern Committee. Those interested in more information on this proposal should consult the <u>Report of the Seventh Regular Session of the Northern</u>

<u>Committee</u>¹, particularly Attachment C, which is a summary description of the framework. The Council will take up Agenda Item I.3 on Monday, March 11.

The Council will be taking final action to adopt their Fishery Ecosystem Plan at the April 2013 meeting. A draft of the Plan is being distributed electronically to Council committees so they have time to review the document and provide comments for the April meeting. If the HMSMT or HMSAS chooses to provide comments they should submit them by March 19, the deadline for the April Briefing Book. The document and an accompanying Reader's Guide can be accessed on the Council website at <u>http://www.pcouncil.org/ecosystem-based-management/fep-public-review-draft/</u>.

- SUBJECT: March Council Meeting

In conjunction with the March Council meeting, the Salmon Advisory Subpanel (SAS) and Salmon Technical Team (STT) will meet on Wednesday, March 6, 2013 beginning at 8 a.m. The meetings will be held in Pavilion E and F Rooms, respectively of the Hotel Murano Tacoma, Washington. The Council will begin the salmon agenda on Thursday (March 7), and continue through Monday afternoon (March 11). Habitat issues will be covered Friday morning, March 8, and Pacific halibut issues will be covered on Friday afternoon.

The Council will receive a briefing on National Marine Fisheries Service regulatory and research activities Friday (Agenda Item C.3).

The Council will be briefed Thursday by the STT on the Review of 2012 Ocean Salmon Fisheries and Preseason Report I: Stock Abundance Analysis for 2013 Ocean Salmon Fisheries (Agenda Item C.1). Please note that Preseason Report I is not included with your briefing materials this year. Due to scheduling conflicts, the STT meeting to compile Preseason Report I was held February 19-22, while briefing materials were mailed out. You should be able to access an electronic version from the Council web site by February 28, and there will be printed copies at the Council meeting. I apologize for any inconvenience.

The main salmon issue before the Council will be developing options for modeling 2013 ocean fisheries (Agenda Items C.2, C.4, C.5, and C.6). Thursday afternoon the SAS will present the Council with recommendations for three alternatives. SAS representatives should clearly identify their fishery priorities and engage in negotiations as necessary to resolve conflicts among fishery sectors and areas to arrive at cohesive and coordinated options. The STT will then collate and analyze the alternatives. Working throughout the week the SAS, STT, and Council will refine the alternatives, which are scheduled to be adopted for public review on Wednesday.

The STT and Scientific and Statistical Committee (SSC) will discuss salmon topics on Wednesday afternoon beginning at 1:30 p.m. in the Venice I Room.

Pacific halibut is also on the Council's agenda for Friday. The Council and the SAS will hear reports on the International Pacific Halibut Commission (IPHC) meeting (Agenda Item G.1) and the South of Humbug Policy Committee (Agenda Item G.2). The Council will adopt options for halibut retention in the commercial salmon fisheries (Agenda Item G.3). The SAS should be prepared to offer alternatives for Council consideration.

The Council will be taking up two administrative items of particular interest. Under Agenda Item F.1 the Council will be reviewing a public review draft of the Research and Data Needs document and considering it for final adoption. STT comments from the fall of 2012 have been incorporated into the review draft. Additionally, the Council will consider future Council meeting agendas and workload (Agenda Item F.4) on Monday. The SAS and STT may want to request topics for that agenda item.

The Council will receive an update on current habitat issues on Friday (Agenda Item E.1). The Habitat Committee is meeting Wednesday at 8:30 a.m. in the Venice 2 Room. Jim Hie will attend and brief the SAS on relevant issues. Others are invited to attend relevant topics such as Columbia River matters and offshore energy development off the West Coast.

On Saturday, USCG Fishing Vessel Safety Coordinator, Dan Hardin will brief the SAS on pending commercial fishing vessel regulations and a new web-based application for required safety gear.

In April, the Council will be considering its Fishery Ecosystem Plan (FEP) for final adoption. This will not be on the Council, STT, or SAS agendas for March. However, the review draft of the FEP has been published to our web page under "Ecosystem-Based Management" and I encourage you to begin your review of the FEP well in advance of the April Council meeting.

Also note that you are invited to the Chair's Reception at 6 p.m. Friday evening.

Please take some time and review your briefing materials thoroughly before the meeting. If you have any questions, feel free to contact me. Thank you for your assistance in the Council's salmon management process.

The Council is scheduled to adopt exempted fishing permits for 2013.

Groundfish Management Matters

At this meeting, the Council will consider status determination criteria for data-moderate stocks. The Council will also adopt a range of alternatives for Groundfish Fishery Management Plan Amendment 24 to determine improvements to the groundfish management process.

Additionally the SSC Groundfish and Economic Subcommittees will meet on March 5 and 8, respectively. The Groundfish Subcommittee will review proposed methods for constructing abundance indices contemplated for data-moderate stock assessments. The Economic Subcommittee will review the Groundfish Management Team's commercial nearshore and non-nearshore impact projection models.

Ecosystem-Based Management

The SSC will be briefed on development of the Fishery Ecosystem Plan in preparation for an April Council adoption. A revised version of the Fishery Ecosystem Plan can be found on the Council's web site at http://www.pcouncil.org/ecosystem-based-management/fep/.
