SUBJECT: September Council Meeting

In conjunction with the September 11-17, 2013 Council meeting in Boise, Idaho, the Ecosystem Advisory Subpanel (EAS), will meet on Saturday, September 14 and Sunday, September 15. The meeting will be held in the Liberty Room of the Riverside Hotel in Boise. The ad hoc Ecosystem Workgroup (EW) met via teleconference on August 29 and is not meeting in Boise.

The primary focus of the EAS in September will be final recommendations on updating the Federal list of authorized West Coast fisheries and gear and on Fishery Ecosystem Plan Initiative 1, intended to recognize the importance and provide adequate protection of forage fish to the marine ecosystem off of the U.S. West Coast. We will also discuss future ecosystem matters on the Council's tentative 2014 schedule. A few other items in your mailing are largely informational, but I would be happy to discuss them in Boise.

The Pacific Fishery Management Council (Council) and its advisory bodies will meet September 12-17, 2013 at the Riverside Hotel, 2900 Chinden Boulevard, Boise, Idaho. The Groundfish Advisory Subpanel (GAP) and Groundfish Management Team (GMT) meetings will begin in the Tamarack and Aspen rooms, respectively, at 8 a.m. on Wednesday, September 11, 2013.

The Council is scheduled to consider several important groundfish agenda items and related matters of interest, including:

SUBJECT: September Council Meeting

The Pacific Fishery Management Council will meet September 11-17, 2013 in Boise, Idaho. None of the salmon advisory groups will be meeting in Boise, but will meet via teleconference at 3 p.m. on Tuesday, September 3rd to finalize reports to the Council. An agenda and call-in instructions for the teleconference have been sent out via email.

Mr. Keith Lutz, long-standing tribal representative to the Salmon Technical Team (STT), has resigned his position with the Northwest Indian Fisheries Commission and will be leaving the STT. I have a lot of respect for Keith and the work he did for the Council and wish him the best in his retirement.

Primary items for your consideration in preparation for the September meeting include final topic selection for the 2013 salmon methodology review and final Council action on Fishery Management Plan Amendment 18 regarding essential fish habitat. The Council will also be adopting final recommended updates to the Federal list of authorized fisheries and gears and will continue its work to increase protection of currently unmanaged forage species through Initiative 1 of the Fishery Ecosystem Plan.

Recall in April that we tentatively planned to review an Environmental Impact Statement (EIS) regarding juvenile salmonid predation by double-crested cormorants in the Columbia River in September. As of the briefing book deadline, the draft EIS has not been released by the U.S. Army Corps of Engineers, who now anticipate that the draft EIS will be available for review and comment in the winter of 2013-14.

Additionally, the Council will take up two items relative to Pacific halibut management items; bycatch estimates in the groundfish trawl fishery and the adoption of preliminary alternatives for amending the Catch Sharing Plan. These items are included in your mailing for your information. The Salmon Advisory Subpanel in particular may want to provide recommendations on the Catch Sharing Plan in time for final adoption at the November Council meeting.

Looking ahead, the STT and the Salmon Subcommittee of the Scientific and Statistical Committee will hold their annual salmon methodology review meeting on October 1-3, 2013 in Portland, Oregon. As noted on the draft November Council agenda (Agenda Item H.5.a, Attachment 2), the salmon advisory groups will not be meeting in person at the November Council meeting. Please tentatively plan on a teleconference in late-October to address final salmon methodology review considerations and any other business for the November meeting. Please take some time and review your briefing materials before our teleconference. If you have any questions, feel free to contact me. Thank you.

SUBJECT: September 2013 Council Meeting Materials

The Pacific Fishery Management Council (Council) and its advisory bodies will meet September 11-17, 2013 at The Riverside Hotel, 2900 Chinden Blvd., Boise, Idaho. The Scientific and Statistical Committee (SSC) will meet Wednesday, September 11 through Friday, September 13 in the North Star Room. Your meeting materials are enclosed and include informational items that are not on the SSC agenda.

Council Administrative Matters

There are nominations for some of the twelve seats for the Groundfish Endangered Species Work Group the SSC will review. Additionally, there are three nominations for the vacant at-large SSC seat vacated by Dr. Selina Heppell for the SSC to review. The SSC will be in closed session for this discussion.

The Council will identify priorities for amending the Magnuson-Stevens Act (MSA). The Managing Our Nation's Fishery 3 conference held in May identified a number of findings, some of which represent potential amendments to the MSA. The SSC will review those findings that affect the science informing Council decisions and recommend their priorities for amending the MSA.

Pacific Halibut Management

The Council will review and provide guidance on the Pacific halibut bycatch estimate for use by the International Pacific Halibut Commission in 2014 fisheries.

Salmon Management

The Council will adopt final review priorities and consider recommendations for Sacramento winter Chinook harvest control rules.

The Council will consider final adoption of salmon essential fish habitat updates.

Groundfish Management

The Council will consider adopting new full assessments for aurora rockfish, rougheye rockfish, shortspine thornyhead, longspine thornyhead, cowcod, and Pacific sanddab as recommended by the SSC. The SSC will review these assessments and stock assessment review (STAR) reports before recommending whether they represent the best available science for these stocks and are suitable for management decision-making.

The Council will recommend workshops and other activities to improve the science informing groundfish management. The SSC will discuss candidate science activities and recommend their priorities to the Council.

The Council will initiate decision-making for the 2015-2016 groundfish fishery by adopting final overfishing limits (OFLs) and a range of acceptable biological catches (ABCs) for groundfish stocks and stock complexes. The SSC will review the list of proposed OFLs and a range of ABCs and recommend OFLs, stock categories, biomass variances (i.e., sigmas) for stocks and stock categories, and a proxy F_{MSY} harvest rate for elasmobranch species. The SSC will also discuss rebuilding revision rule alternatives and management strategy evaluation scenarios with the GMT in preparation for analyses supporting the harvest specifications decision-making process.

The Council will adopt a range of alternatives, including preliminary preferred alternatives, for restructuring groundfish stock complexes. The SSC will review the methods and analyses proposed by the Groundfish Management Team (GMT) to inform the suitability of these alternatives.
