The Pacific Fishery Management Council (Council) will meet November 1-6, 2013, at the Hilton Orange County/Costa Mesa Hotel, 3050 Bristol Street, Costa Mesa, California. The Coastal Pelagic Species Management Team (CPSMT) will meet Friday November 1 and Saturday November 2 in Newport Beach 1. The Coastal Pelagic Species Advisory Subpanel (CPSAS) will meet the same days, in Newport Beach 2. The CPSMT and CPSAS will meet jointly for a portion of those days, tentatively scheduled for 9:30 a.m. – 2:30 p.m. on Friday November 1. Please note that on November 1, the CPSAS begins at 9:00 a.m., and the CPSMT begins at 8:00 a.m. On November 2 the start time for both is 8:00 a.m.

The CPSMT is scheduled for a working lunch on Saturday November 2, so please plan accordingly.

At this Council meeting, supplemental reports may be developed on the following topics:

- Exempted fishing permits notice of intent for 2014 (Agenda Item E.2)
 - One Notice of Intent, from the Northwest Sardine Survey, LLC
- Maximum sustainable yield for the northern subpopulation of northern anchovy (E.3)
- Methodology review process and preliminary topic selection (E.4)
 - One proposal for a methodology review, from California Department of Fish and Wildlife
- Federal enforcement priorities (F.1)
 - Presentation from Martina Sagapolu, NOAA Law Enforcement Office

 - Although we anticipate a projection estimate, the Federal government shutdown may cause the estimate to be delayed. As of the writing of this memo, the situation remains unclear

In addition, the CPSMT and the CPSAS should anticipate spending some time discussing Pacific sardine harvest parameters that will be considered by the Council at the March 2014 meeting. I anticipate that you will have a draft analysis report from Felipe Hurtado, which has been updated using the correct temperature data. This topic is not being considered by the Council at the November meeting.

Both the CPSMT and CPSAS will hold elections for Chair and Vice Chair, with new officers starting January 1, 2014 for a period of one year.

The proposed agendas have a new category: "Report Writing/Work Session – Major Points." This reflects the strategy of gaining consensus on the main points of supplemental reports, and then drafting the complete report. This process is designed to avoid wordsmithing, and to be more efficient in developing supplemental reports.

SUBJECT: November Council Meeting Materials

The Pacific Fishery Management Council (Council) and its advisory bodies will meet October 30-November 6, 2013 at the Hilton Orange County/Costa Mesa Hotel, 3050 Bristol Street, Costa Mesa, California. On Wednesday, October 30, 2013 at 8 a.m., the Ecosystem-Based Management Subcommittee of the Scientific and Statistical Committee (SSC) will meet to discuss the analytical framework for the ecosystem section in the groundfish Environmental Impact Statement. Materials for this meeting will be provided electronically only on the Council's website. On Wednesday, October 30, 2013 at 1 p.m., the SSC's Groundfish Subcommittee will meet to review revised data-moderate assessments for brown, China, and copper rockfish, as well as a new rebuilding analysis for cowcod. The Groundfish Management Team (GMT) meeting will begin at 8 a.m. on Thursday, October 31, 2013 in the Laguna Beach 3 room. The Groundfish Advisory Subpanel (GAP) meeting will begin at 11 a.m. on Friday, November 1, 2013 in the Laguna Beach 1-2 room.

The Council is scheduled to consider several important groundfish agenda items and related matters of interest, including:

- Matters raised during the open comment period;
- Current habitat issues;
- Federal enforcement priorities and other enforcement issues;
- Final changes for the 2014 Pacific halibut Catch Sharing Plan and annual fishing regulations;
- Final seabird avoidance regulations for groundfish fisheries;
- Preliminary approval of 2015-2016 groundfish exempted fishing permits for public review;
- Magnuson-Stevens Act reauthorization priorities and other legislative matters;
- Identifying issues and alternatives for consideration of changes in the limited entry fixed gear sablefish permit stacking program;
- Final stock complex aggregations for 2015 and beyond, including guidance on restructuring for future cycles;

• Stock assessments for copper, brown, and China rockfishes and a new rebuilding analysis for cowcod;

- Initial actions for setting 2015-2016 harvest specifications, including annual catch limits and management measures;
- Groundfish Essential Fish Habitat (EFH) review, including proposals to modify EFH;
- Electronic monitoring alternatives for the rationalized groundfish trawl fishery;
- Consideration of inseason adjustments to 2013 and 2014 groundfish fisheries;
- Membership appointments and Council Operating Procedures (COP), including changes to COP 9, which describes the biennial groundfish process; and
- Future Council meeting agenda and workload planning.

- SUBJECT: November Council Meeting

The Pacific Fishery Management Council (Council) will meet November 1-6, 2013 at the Hilton Orange County Hotel in Costa Mesa, California. The Salmon Advisory Subpanel (SAS) will meet October 31 – November 1. The Salmon Technical Team (STT) and the Model Evaluation Workgroup (MEW) will not be attending the November meeting.

Primary items for your consideration in preparation for the September meeting include final review of proposed salmon methodology changes, the tentative 2014 preseason schedule, and Pacific halibut regulations for 2014. This year's methodology review meeting of the Scientific and Statistical Committee (SSC), the STT, and MEW occurred on October 1-2, 2013 at the onset of the Federal government shutdown. Accordingly, no employees of Federal agencies were in attendance which restricted the group's ability to fully review the proposals. Therefore, the modified objective of the meeting was to conduct an initial review of the analyses, discuss alternative ways of completing this year's compromised review, and to prioritize items for the November Council meeting.

There will be insufficient time at the November Council meeting to conduct a thorough review of all of this year's topics. Methodology topics were prioritized for full SSC review in November based on two main criteria; 1) the technical merits of the analysis and the documentation, and 2) the proposed methodology's potential to directly affect the 2014 preseason process. Proposals we will likely focus on include technical revision to the Oregon Coastal Natural (OCN) coho work group harvest matrix, Lower Columbia natural (LCN) coho matrix control rules, Fishery Regulation Assessment Model (FRAM) improvements regarding estimated sublegal encounters and impacts from size limit changes, and alternative forecast methodologies for the Sacramento fall Chinook index.

The Council's Annual Award Banquet will be a 6 p.m. on Friday, November 1st. This year's honorees include Ray Conser, Marion Larkin, Duncan MacLean, Vicki Nomura, Marija Vojkovich, and Steve Williams. SUBJECT: November 2013 Council Meeting Materials

The Pacific Fishery Management Council (Council) and its advisory bodies will meet October 30-November 6, 2013 at the Hilton Orange County/Costa Mesa Hotel, 3050 Bristol St., Costa Mesa, California. The Scientific and Statistical Committee's (SSC's) Ecosystem-Based Management Subcommittee will meet Wednesday, October 30 from 8 a.m. to noon in the Emerald Bay 2 Room and the SSC's Groundfish Subcommittee will meet on the same day in the same room from 1-5 p.m. The full SSC will meet Thursday, October 31 through Friday, November 1 in the Emerald Bay 2 Room. Your meeting materials are enclosed and include informational items that are not on the SSC agenda.

Salmon Management

The Council will adopt final salmon methodology changes at this meeting. The Salmon Subcommittee met in October to review new salmon methodologies but, due to the Federal government shutdown, that review was limited in scope. Therefore, extra time was added to the SSC agenda to complete the Salmon Methodology Review.

Coastal Pelagic Species Management

The Council will consider any exempted fishing permit (EFP) applications for coastal pelagic species (CPS). The SSC will review those EFPs that affect the science informing CPS management.

The Council is scheduled to establish a maximum sustainable yield (MSY) for northern anchovy at this meeting. The SSC will review the science informing an MSY estimate and make their recommendations to the Council.

The Council will decide priorities for the 2014 CPS methodology review process at this meeting. The SSC will recommend their priorities for this methodology review process.

The Council will decide interim harvest specifications and management measures for Pacific sardine for the first half of 2014. Dr. Kevin Hill is scheduled to present harvest specifications for this time period projected from the 2011 full assessment for Pacific sardine. The SSC will review these projections and make their recommendations to the Council.

Groundfish Management

The Council will consider the Phase 2 Report on Groundfish Essential Fish Habitat (EFH) prepared by the Council's EFH Review Committee, which evaluates eight proposals received to change current groundfish EFH. The Council will consider establishing a process to change current EFH based on the Phase 2 report and the SSC's evaluation of that report.

The Council will consider adopting revised data-moderate assessments for brown, China, and copper rockfish, as well as a new rebuilding analysis for cowcod as recommended by the SSC. The SSC will review these assessments and the cowcod rebuilding analysis before recommending whether they represent the best available science for these stocks and are suitable for management decision-making.

The Council will identify issues and alternatives for consideration of changes in the limited entry sablefish permit stacking program. The SSC will review the proposed indicators for evaluating program performance and make their recommendations to the Council whether these or other indicators are the most informative for Council decision-making.

The Council is tasked at this meeting with adopting final preferred 2015 and 2016 overfishing limits (OFLs) for those remaining stocks and complexes in which OFLs were not decided at the September 2013 meeting (i.e., cowcod, brown rockfish, China rockfish, copper rockfish, and those species contemplated for management in the restructured Other Fish complex); final preferred acceptable biological catches (ABCs); and a range of annual catch limits (ACLs), including preliminary preferred ACLs for each groundfish stock and complex. The SSC will review the list of proposed OFLs and the range of ABCs and recommend those OFLs, stock categories, biomass variances (i.e., sigmas) for stocks and stock categories not already decided for 2015-2016 groundfish fisheries.

The Council will adopt a range of alternatives for electronic monitoring regulations. The SSC will review these alternatives and make their recommendations on the range of alternatives and further analysis of these alternatives.
