- *NMFS to close fishing under any EFP for the remainder of the year if the amount of an Endangered Species Act (ESA) -listed species taken in that EFP fishery is the lower of either double the amount of incidental take estimated in an ESA biological opinion prepared for that activity or 10 animals*
- *EFPs testing buoy gear only will be permitted in Federal waters*

*The Council recommended the following applications to NMFS for EFP issuance for the 2015 fishing season:*

1. *Application submitted by Pete Dupuy, John Gibbs, and David Haworth to test pelagic longline gear inside the west coast Exclusive Economic Zone ([Agenda Item H.3.a, Attachment 1](#)) with the following additional conditions:*
  - a. *Only one vessel to be permitted versus three as proposed by the applicants*

- b. Applicants must specify the level of expected fishing effort beyond the first six months of the term of the EFP

  - c. How would we determine the species-specific bycatch rates without 100 percent coverage?
  - d. And, if there is a sound methodology to estimate that with a reasonable degree of certainty, what are the bycatch rates for the species of concern that the Council has identified?
  - e. How would we take the answers to 1.d. to determine what the appropriate level of observer coverage should be for the fishery?
  - f. Given funding constraints, how should we estimate the bycatch and protected species interactions if we cannot achieve the desired coverage level from 1.e.?

- ~~2. And, if there is a sound~~ Request the SSC to review the methodology to estimate bycatch and protected species interactions that have occurred in the past five years (with the 20-

30 percent coverage level), what are the bycatch estimates and species-specific protected species interactions for that time frame?

**Motion:** Adopt the following changes to the Proposed Statement of Purpose and Need, Goals and Objectives for Section 2.1 Proposed Action as follows:

While the DGN fishery currently complies with all applicable laws, including the MSA, ESA, and MMPA, the Council seeks to establish more stringent standards with respect to these laws. Therefore, the proposed action is to implement management measures for the California large mesh DGN fishery to further reduce 1) bycatch including bycatch mortality, and 2) ~~incidental take of interactions with~~ ESA-listed species and other marine mammals. Using MSA authority, bycatch and takes would be reduced below the level currently documented for the DGN, noting that the current level is permitted by applicable law. The proposed action is intended to achieve these reductions while providing an economically viable west coast-based swordfish fishery ~~is maintained or enhanced~~. To promote economic viability, the proposed action will include requirements and incentives to support a swordfish fishery conducted by vessels with west coast home ports and promote increased availability of locally-caught swordfish in the market ~~which substitutes swordfish imported into west coast states, either from elsewhere in the U.S. or overseas with locally-caught swordfish.~~

**Motion:** Adopt the Proposed Statement of Purpose and Need, Goals and Objectives for Section 2.3 Purpose and Need as follows:

The purpose of the proposed action is to conserve non-target species and further reduce bycatch, including incidental take of ESA-listed species and other marine mammals, in the DGN fishery below levels currently permitted by applicable law while maintaining or enhancing an economically viable west-coast-based swordfish fishery.

The proposed action is needed to better integrate fishery management under the HMS FMP with enhanced protection of ESA-listed species and other marine mammals, and to address National Standard 9 and Section 303 of the Magnuson-Stevens Act to minimize bycatch and bycatch mortality and conserve non-target species to the extent practicable.

Bob Turner/Herb Pollard (Motion carried unanimously)

**Staff Summary:** *The Council deferred final action on adopting hard caps for the DGN fishery until the June 2015 meeting, in recognition that Secretarial review for implementing final action on hard caps could not be completed in time for the 2015 fishing season. The Council also expanded the scope of the management and monitoring plan to be the “Swordfish Management and Monitoring Plan (SMMP).” The Council also made revisions to the description of the proposed action and the purpose and need statement for the SMMP. The Council affirmed its commitment to continue progress on finfish performance standards and revisit potential measures at a future date.*

*The Council provided the following direction to the Highly Migratory Species Management Team (HMSMT) in moving forward with developing the SMMP:*

- *Analyze a second preliminary preferred alternative proposed by the California Department of Fish and Wildlife (CDFW). The CDFW alternative does not replace the preliminary preferred alternative (PPA) that the Council adopted in September 2014. This additional alternative would establish hard caps based on observed entanglement in drift gillnet fishing gear of the high priority protected species identified in the Council Preliminary Preferred Alternative.*
- *Analyze an additional alternative for performance objectives for nonESA-listed marine mammals based on the highest level observed during any one year during a five-year period (2010-2014).*
- *Analyze historical fishery performance under the range of alternatives, including the CDFW PPA, for hard caps on high priority species or species of concern.*
- *With assistance from NMFS staff including provision of all existing observer data, the HMSMT was tasked with analyzing observer coverage levels necessary to estimate protected species bycatch with reasonable accuracy.*

*The Council requested the SSC to review the current bycatch estimation methodology used to produce bycatch estimates for the past five years. It was also requested to review the HMSMT analysis of observer coverage levels when completed.*

*The HMSMT and SSC are scheduled to report their results to the Council in June 2015.*


