## STAFF SUMMARY OF FEDERAL LEGISLATION IN THE 114<sup>TH</sup> U.S. CONGRESS

A summary of recent Federal legislation is attached. This summary is intended as a general overview for discussion purposes. Full text of these bills, with background information and current status, can be found at the Library of Congress website (<a href="http://thomas.gov">http://thomas.gov</a>) or at <a href="http://govtrack.us">http://govtrack.us</a>. These summaries are primarily from the GovTrack.us website, further summarized by Council staff. See the attached report for a summary of other bills in the current Congress.

# **Progress of Bills Discussed in June**

Of the bills discussed in June, the **Illegal, Unreported, and Unregulated Fishing Enforcement Act** (HR 774, Bordallo) passed the House on July 27.

A companion bill to HR 1987, the **Coast Guard Reauthorization Act**, was introduced by John Thune. S 1611 was introduced on June 18 and reported by committee on June 25. It is given a 38% chance of passage.

There has been no major movement on the **Vessel Incidental Discharge Act** (S 373, Rubio); **Sacramento Valley Water Storage and Restoration Act** (HR 1060; regarding Sites Reservoir); on the **Endangered Salmon and Fisheries Predation Prevention Act** (HR 564; regarding Columbia predator control); or on the **West Coast Dungeness Crab Management Act** (HR 2168 and S 1143).

The **Federal Water Quality Protection Act** (S. 1140, which changes the definition of "waters of the United States" under the EPA) was reported by committee on June 10.

An amendment to HR 2028 (the **Energy and Water Development and Related Agencies Appropriations Act**) prohibiting the use of funds to deliver water to the Trinity River above the minimum requirements of the Trinity Record of Decision, or to supplement flows in the Klamath River, was dropped.

## **MSA Reauthorization**

The **Florida Fisheries Improvement Act** (S 1403; Marco Rubio) was reported by committee on June 25 and is given a 45% chance of passage by GovTrack.

The Strengthening Fishing Communities and Increasing Flexibility in Fisheries Management Act (HR 1335; Don Young) has not moved. The chance of passage has remained the same at 15%.

None of the other MSA reauthorization bills listed in the June 2015 staff summary of Federal legislation (HR 1825, 1207, 2012) have moved forward.

# **New Bills Addressing Drought Issues**

Several bills addressing drought in the West have been introduced. Lisa Murkowski (R-AK) has said that she plans to hold a hearing on drought legislation in the Senate Energy and Natural Resources Committee in September, and has signaled that she intends to bring drought legislation to the floor later this year. Several of the drought bills that have been submitted are aiming to be included, at least in part, in that legislation. It should be noted that there are many other bills not included here that deal indirectly with drought through water recycling, reservoir operations, grants for water conservation, etc.

### HR 2898: Western Water and American Food Security Act

- **Introduced by** David Valadao (R-CA) on June 25, 2015.
- **Status**: Passed the House on July 16.
- GovTrack chance of passage: 15%

At 174 pages, this House bill is a longer and more detailed version of previous Republican drought bills (such as HR 5781, 113<sup>th</sup> Congress) that the Council has opposed in the past, but its substance is similar. A detailed Congressional Research Service summary of HR 2898 is included in the briefing book materials. Among many other actions, the bill would:

- Repeal the San Joaquin River Restoration Settlement Act. This could result in the San Joaquin River running completely dry, destroying reintroduced salmon runs.
- Establish that the safety of fish required by state laws would be deemed satisfied by the existence of a warm water fishery in the San Joaquin River.
- Reduce legal protections for wild salmon runs in favor of hatchery fish.
- Override protections for salmon and other native fisheries required under the Endangered Species Act.
- Limit or waive environmental review of new dams and other water projects. Exempts some projects from NEPA review; establishes unrealistic review timelines. Gives BOR unprecedented control over environmental review process.
- Preempt the ability of the State of California to enforce its own water management and wildlife preservation laws, forcing the state to weaken its protections.
- Override California's authority to ensure Shasta Dam is operated to protect fish, wildlife, and other users.
- Make it more difficult for state and Federal water managers to restrict water transfers.
- Elevate and prioritize certain water rights holders within the California water rights system, thereby creating different classes of water users, which further limits operational flexibility, and intrudes upon State administration of water rights
- Require BOR to increase water pumping.
- Reduce water deliveries to national wildlife refuges and state wildlife management areas;
   make it more difficult for refuges to receive water during dry years; threaten funding for the refuge water supply system.
- Constrain the Administration's ability to protect the commercial and tribal fishery on the Trinity and Klamath Rivers.
- Perpetuate historical Federal subsidies for water storage projects which are now deemed inappropriate.

The bill passed the House without a public hearing. According to a July 10, 2015 *Los Angeles Times* editorial, Valadao has acknowledged that his ultimate goal is to repeal the Endangered Species Act.

Notably, Reps. Huffman (CA-02), McNerney (CA-09), and DeFazio (OR-04), offered a pair of amendments that would require the legislation to take economic impact into consideration. Those amendments were rejected without a vote. One of the Huffman/DeFazio amendments would have prevented any provision of H.R. 2898 from being implemented if the Pacific Fishery Management Council certified that it would reduce employment or recreational opportunities for commercial or sport fishermen.

"HR 2898 will create another costly ecological disaster—this time with America's fisheries—that American taxpayers will have to foot the bill for, just as they did in 2007, when the federal government spent millions in response to the catastrophic salmon disaster," said Rep. DeFazio.

Many state and Federal agencies, NGOs, and the Administration itself have voiced opposition to the bill. In an OMB Statement of Administration Policy<sup>1</sup>, the Administration writes that it "strongly opposes H.R. 2898... because it will, if enacted, impede an effective and timely response to the continuing drought while providing no additional water to hard hit communities. Like similar legislation in the last Congress, H.R. 2898 was developed with little input from the public, the Administration, or key stakeholders affected by the drought... If the President were presented with H.R. 2898, his senior advisors would recommend that he veto the bill." However, it is unlikely that the current bill would pass the Senate; the expectation is that elements of this bill and the Boxer/Feinstein and Huffman bills could eventually be folded into a compromise bill.

#### S 1894: California Emergency Drought Relief Act

- **Introduced by** Barbara Boxer and Dianne Feinstein (CA) on July 29, 2015.
- **Status**: Introduced.
- GovTrack chance of passage: 2%

This bill (which also is not expected to advance as a stand-alone bill, but to be included in future drought legislation) takes a more ESA-friendly approach to the drought. Parts of this bill are similar to a 2014 Feinstein/Boxer bill that was unanimously approved by the Senate. Additional environmental protections have been added to this version. According to Feinstein's fact sheet on the bill, "Provisions in the bill to help move water efficiently to those areas where it is most needed were carefully drafted to remain consistent with environmental laws including the Endangered Species Act and the Clean Water Act, as well as all biological opinions." A summary of the key provisions follows:

Fisheries provisions:

- Authorizes \$20 million to begin implementation of NMFS' Endangered Species Act recovery plan, a tool to provide habitat and flow restoration throughout the Sacramento and San Joaquin basins.
- Authorizes \$3 million to trap and barge fish to reduce mortality rates on migration through the Delta.
- Addresses key stressors on fish populations including limiting invasive species like striped bass and removing predator habitat, to be paid for by participating water districts.
- Authorizes \$4 million to create additional spawning habitat.
- Authorizes \$11.5 million for federal agencies to manage the water system more precisely using updated science and tools, including smelt distribution studies and refined temperature models
- Authorizes \$2 million annually for five years for improved conveyance of water to refuges to help restore and protect critical wetland habitat for wildlife refuges.

### Water Conservation and Recycling:

- Creates programs to stabilize water supplies for small communities.
- Encourages research into desalination technology and projects.
- Promotes the building of new reservoirs or increasing the capacity of existing reservoirs.
- Encourages and authorizes funds for water recycling, water reclamation, water-saving technology, and water reuse projects.
- Facilitates increased agricultural conservation and groundwater recharge.
- Authorizes a Department of the Interior program to establish an open system with data on water quality, climate and weather effects and erosion.

### Water Transfers:

- Includes a provision to allow limited Delta water transfers in April and May so communities and farms can make up for reduced deliveries. National Marine Fisheries Service and U.S. Fish and Wildlife Service, in providing technical assistance on the bill, have stated that these safeguards ensure the provision is in compliance with environmental laws and biological opinions. (From the Feinstein fact sheet)
- Any time more water is pumped from the Delta, that pumping must remain consistent with the Endangered Species Act and biological opinions.
- When water turbidity is high and smelt are likely to move near pumps, scientists must daily monitor for the presence of the fish. Pumps may only run at high levels when smelt are not present. (This language is similar to language in the Valadao bill.)
- Environmental reviews of water transfers and the installation and removal of temporary barriers will be expedited. These reviews will ensure these actions are consistent with environmental laws. (This language is similar to language in the Valadao bill.)
- Delta Cross-Channel Gates may only be opened for additional time if doing so remains consistent with water quality-related orders issued by the State Water Resources Control Board. (This language is similar to language in the Valadao bill.)

## HR 2983/S 1837: Drought Recovery and Resilience Act of 2015

- **Introduced by** HR 2983 introduced by Jared Huffman (D-CA) on July 8, 2015; S 1837 introduced by Barbara Boxer (D-CA) on July 22.
- Status: Introduced.
- **GovTrack chance of passage**: 1% (both bills)

These two bills are essentially identical, except the Boxer bill includes provisions to establish an open system with data on water quality, climate and weather effects.

Both bills focus on efficient use of current water supplies. They would provide emergency funding to improve water supply and reliability, help out-of-work farmworkers, and combat upstream water theft on federal lands. They also contain provisions to help homeowners reduce their water use by providing a tax credit for the installation of water-capture and harvesting systems; provide emergency funding to stretch existing water supplies; support existing water infrastructure programs; and fund investments to improve desalination technology and expand water recycling. One of the more unusual ideas is to use solar panels to cover canals and reservoirs to reduce evaporation loss. Royalties from the solar-power generation would go to local governments and a new fund for fish and wildlife.

The legislation would draw on a \$9 billion fund accumulated by the Bureau of Reclamation over decades that has not been used for water projects.

### HR 1668: Save Our Water Act

- **Introduced by** Tom McClintock (R-CA) on March 26, 2015.
- Status: Introduced; stalled.
- GovTrack chance of passage: 10%

Amends the Endangered Species Act to allow the Act to be suspended in regard to water releases by Federal and State agencies in river basins that are affected by drought.

Specifically, Amends Section 10 of the Endangered Species Act to add that "The application of this Act with respect to water releases from water storage facilities by Federal and State agencies in a navigable river basin in a State is suspended during each period in which there is in effect a drought in that basin." States may not enforce the ESA when a suspension applies.

# **Other New and Noteworthy Bills**

### HR 2220: Marine and Hydrokinetic Renewable Energy Act

- **Introduced by** Theodore Deutch (D-FL) on May 1.
- Status: Introduced.
- GovTrack chance of passage: 2%

Amends the Energy Independence and Security Act of 2007 to create a program to research, develop, and accelerate commercial production of marine renewable energy.

## HR 3282: Protecting Honest Fishermen Act

- **Introduced by** Blake Farenthold (R-TX) on July 29.
- Status: Introduced.
- GovTrack chance of passage: 2%

Calls for NOAA to coordinate the Administration's seafood inspection activities with the national sea grant college program to provide outreach to the States, local health agencies, consumers, and the seafood industry on seafood safety. Calls for Commerce and the Secretary of Health and Human Services to ensure that inspections and tests for seafood safety also collect information for seafood fraud detection and prevention. Creates a list under HHS and Commerce that identifies countries and exporters selling seafood in the U.S. and tracks any violations related to seafood safety.

Calls for labeling of where fish was caught (UN FAO fishing area), market name, scientific name, whether wild or farmed, method of harvest (including gear type), date of catch, and weight or number of fish, as appropriate; also would identify if seafood has been frozen, treated with any substance affecting its weight, processed in another country, etc. If farm-raised, must include the country of cultivation, location of production, and method of production.

Retailers may make all of this information available upon request rather than being included on a label.

Seafood not labeled may be refused admission; penalties apply. Creates list of offenders. Increases number of inspections. States may bring civil actions against seafood fraud.
