## Status of 2015 Groundfish Mortality in California




Figure 1. Cumulative catch of cowcod in the non-trawl commercial (through May) and recreational (through June) fisheries in 2015 and anticipated catch values from weekly recreational tracking from July 1 through August 23, 2015 and catch in 2012-2014 compared to the non-trawl allocation.




Figure 2. Cumulative catch of black rockfish in the California commercial (through May) and recreational (through June) fishery in 2015 and catch in 2011-2014 compared to the harvest guideline. Note that bag limits were reduced to 5 fish within the 10 fish RCG bag limit

The California Department of Fish and Wildlife (CDFW) provides the following informational report on mortality of select species accrued through June of 2015 for the recreational sector and through May of 2015 for the commercial sector. The following tables and figures provide estimated mortality of select species by month for the recreational sector (Table 1), estimated mortality of select species by month for the commercial sector (Table 2), estimated mortality of select species by month for the combined recreational and commercial sectors (Table 3), estimated harvest compared to federally designated harvest specifications (Table 4), cumulative catch of cowcod in the recreational fishery (Figure 1), cumulative catch of black rockfish in 2015 (Figure 2), and cumulative catch of California scorpionfish in 2015 (Figure 3). Mortality is reported in metric tons and includes landings for the commercial fishery and landings plus discards for the recreational fishery. The 2015 landings are preliminary. CDFW will continue to provide updates on the status of the 2015 fishing season as it progresses.




Figure 3. Cumulative catch of California scorpionfish in the California commercial (through May) and recreational (through June) fisheries in 2015 and catch in 2011-2014 compared to the harvest guideline. Note that the proscribed season end date is August 31 in 2015, while the fishery was open year round in preceding years.
