Dear Madam Chair and Council Members.

The California Sportfishing League. California's leading advocate for recreational anglers, and the small businesses and communities dependent on unifloor recreation, call on the council to adopt policies that transition commercial fishing away from the use of drift gillness.

Over 450 Casillo rea angles who participated in an online petition report this essition.

Drift giffnets are approximately 1-mile long nets used by commercial fishermen to target swordtish and thresher sharks, but instead each nearly 60 different species of marine life, including dolphins, sea turtles and fish important to recreational anglers such as turas and marlins and other fishes.

We also write to express our concern with the Council considering the authorization of a longitue fishery. Longlines are not the solution to the drift gillnet problem- rather than perpetuating a swordfish fishery that uses outdated and wasteful methods, the Council's priority should be transitioning to more selective fishing gent types us soon as possible.

The use of these nets harm recreational fishing, depleting the ocean of an abundance of fish that are essential to sustaining outdoor tourism and recreation, and the jobs that support these activities.

Thank you for considering the view of California's recognitional implers.
