

Dear Members of the Pacific Fisheries Management Council -

I write to encourage the Council to take a stand for all sea animals and the long term health of the fishing industry by banning the use of drift gill nets as soon as possible. It is widely known that the nets capture far more than their intended prey, and those kills are not salvageable from a fishery standpoint.

Conditions in the ocean are changing rapidly and in ways that are harmful to sea life: warming waters, stronger storms, acidification, increased trash and pollution. Let's not add to that burden by continuing to use fishing methods that cause widespread damage.

Please consider the impact of drift gill nets on the overall health of the oceans as you weigh the needs of our fisheries. Drift gill nets simply cause too much damage, and given the other significant challenges to the health of our oceans, we simply can't afford to continue to allow the use of such wasteful and harmful fishing techniques.

I think the PFMC should be recommending a change in gear from drift gillnets to deep-set buoy gear, which uses hooks in deep water instead of nets. ### Dear Pacific Fisheries Management Council:

Drift net fishing is a phenomenally inefficient and expensive way to fish. The target in California is mostly swordfish, although some sharks are also caught and sold. Only one animal in eight is a swordfish and typically 2/3 of the catch is unwanted bycatch and simply thrown overboard, much of it injured or dead.

California is the last place you would expect to host pelagic drift net swordfish fleets. Large-scale driftnet fishing has already been outlawed on the high seas by the United Nations; countries around the world (most recently Russia) have banned their use. California is the last state in the U.S. where it continues unabated. Yet the California drift net fishing industry kills or injures more whales and dolphins than all other fisheries in California, Oregon, Washington and Alaska combined. Why do we continue to allow the wanton destruction of marine life off our coast?

The Council makes rules regulating fishing practices in Pacific waters. Many concerned citizens in coastal communities have already expressed their outrage to the Council. Now you have a golden opportunity to take action to halt drift gill net use and move to adopt more sustainable, targeted fishing gear.
