ELECTRONIC MONITORING EXEMPTED FISHING PERMIT UPDATE AND REVISIONS

At the November 2015 Council meeting, the National Marine Fisheries Service (NMFS) provided an update to the Council regarding exempted fishing permit (EFP) activity for vessels carrying electronic monitoring (EM) in the catch share program. The Council granted NMFS the authority to expand the number of participants under the existing EFPs with the intent of gathering more information to continue the development of an EM program for non-whiting catch share fisheries (fixed gear, mid-water trawl and bottom trawl). The Council also scheduled another update on EFP activity for these fisheries for the March 2016 meeting.

NMFS provides a report that contains a summary of EFP activity for the fixed gear, non-whiting midwater trawl, and bottom trawl vessels (Agenda Item G.7.a, NMFS Report). Under this agenda item, the Council will consider the NMFS report and decide if an extension of EM EFPs beyond the currently approved timeline of 2015-2016 is necessary. Absent an extension, all EFPs will expire on December 31, 2016. Based on the information that is lacking for the non-whiting midwater trawl and bottom trawl fisheries, the Council may want to consider an extension of the EFPs through 2018.

At the November 2015 Council meeting, the Council chose to combine the whiting and fixed gear rulemakings into one regulatory package, scheduled EFP updates for 2016, and scheduled discussion of the non-whiting mid-water trawl and bottom trawl regulatory timeline (Table 1). The Council may want to consider their recommendation for EFP extensions and how it may affect the current timeline for development of the non-whiting midwater trawl and bottom trawl fishery EM programs. Currently, the Council is scheduled to verify their final preferred alternatives for the non-whiting mid-water trawl and bottom trawl fisheries in November of 2016 (Table 1).
