Dear Dr. Compeán:

I am writing on behalf of the U.S. Section to the Inter-American Tropical Tuna Commission (IATTC) to notify you that today the United States formally deposited its instrument of ratification of the Convention for the Strengthening of the Inter-American Tropical Tuna Commission Established by the 1949 Convention Between the United States of America and the Republic of Costa Rica (the Antigua Convention). The United States will be transmitting diplomatic notes to the Parties to the Antigua Convention providing notification of this action.

I was privileged to personally receive the instrument of ratification upon its sealing and to make the deposit with the State Department's Office of the Assistant Legal Adviser for Treaty Affairs, which provides depositary services for the Antigua Convention. That office will also be working in the very near term to update the status of ratifications of and accessions to the Antigua Convention shown on the State Department's website.

The United States wishes to convey to you and the IATTC Members our continued commitment to cooperate in the effective, science-based conservation and management of the very important living marine resources of the eastern Pacific Ocean, which is reinforced by our ratification of the Antigua Convention. I would be grateful if you could circulate this notification to all IATTC Members.
