#### Amendment 20 goals

Create and implement a capacity rationalization plan that:

- increases net economic benefits
- creates individual economic stability,
- provides for full utilization of the trawl sector allocation,
- considers environmental impacts, and
- achieves individual accountability of catch and bycatch.


