WEST COAST RPB: RECENT TIMLINE **.** Recent Timeline: - October 2016: 2016 Annual Meeting Engagement (C&E) Plan dialogs on WA coast, southern CA

- January 2017: Release of Communications &
 - January & February 2017: Initial sub-regional
 - Present: Implement C&E Plan; Support subregional dialogs; Secure 2017-2018 funding







WEST COAST RPB: SUB-REGIONS

Option: RPB members can form Sub-regional Planning Teams (SRPTs) to address subregional needs & ocean planning

 Sub-regional approach (focus, membership, boundaries) flexible and determined by RPB members

Initial dialogs beginning, but no sub-regions yet decided or formed



WEST COAST RPB: SUB-REGIONS . WA Pacific Coast sub-regional dialog:

- Initiated fall 2016, 1st in-person meeting January 2017; monthly conference calls continuing
- Priority: build around existing planning activities (state, tribal) and identify potential gaps that sub-regional team could fill (e.g. data and info sharing; early project notification)
 - Current Efforts:
 - Project: Discussing possible 'mock project' to test out coordinated ocean planning effort
 - Process: Developing sub-regional charter and engagement processes



WEST COAST RPB: SUB-REGIONS **.** Southern California Outreach in San Diego to Port of SD and CA State Lands Commission (RPB member) on new marine planning pilot project Pilot project: MOA between Port and SLC; not driven or formally linked to RPB Early dialog focused on how RPB can

potentially engage and support moving forward, including link to US Navy

WEST COAST RPB: COMMUNICATION & ENGAGEMENT PLAN . C&E Objectives: Build understanding of the WCRPB's role and mission. Increase understanding of how to participate in West Coast efforts. Provide opportunities for input on marine planning and coordination efforts. Identify barriers to effective engagement. Understand and integrate interests of multiple stakeholder groups into the WCRPB's efforts. Promote support for WCRPB efforts, including regional planning products.



WEST COAST RPB: COMMUNICATION & ENGAGEMENT PLAN

- C&E Approach:
 - Build upon initial C&E efforts to date; clarify messaging; leverage existing bodies and forums.
 - Previous examples of RPB in-person outreach:
 - Tribal natural resource meetings, academic conferences, existing state bodies, NGO workshops, etc.

WEST COAST RPB: FUNDING

- Previous funding: NOAA (2013-15) and Gordon and Betty Moore Foundation (2016)
- . March 2017: New NOAA funding to support ~0.5 FTE for RPB staff (contract) for ~12 months
- . Spring 2017: Proposal submitted to Moore Foundation for approx. 12 months of support
 - RPB support staff (~1.0 FTE)
 - Increased communication & outreach
 - Sub-regional support
 - 2017 Annual Meeting
 - Continued West Coast Ocean Data Portal support
