

HISTORICAL CATCH SHARING PLAN ALLOCATIONS AND CATCH

Table 1 below contains the catch of Pacific halibut, in net weight, by sector from 2004-2016. Commercial data through 2015 were provided by the International Pacific Halibut Commission and are considered final. Recreational data were provided by the three west coast states. Data from 2016 are considered preliminary.

a/ Net weight is defined in IPHC regulations as the weight of halibut that is without gills and entrails, head-off, washed, and without ice and slime. If a halibut is weighed with the head on or with ice and slime, the required conversion factors for calculating net weight are a 2 percent deduction for ice and slime and a 10 percent deduction for the head.

b/ 2016 values are considered preliminary until published by the IPHC in the Annual Report in the fall.
