PROPOSED DEEP-SET BUOY GEAR EXEMPTED FISHING PERMITS

In June 2016, the Council announced it would accept for review applications for exempted fishing permits (EFPs) to test deep-set buoy gear (DSBG) at any Council meeting when Highly Migratory Species (HMS) items are on the agenda.

At its September 2017 meeting, the Council made recommendations on the issuance of EFPs for 13 applications. Attachment 1 summarizes those recommendations. The Council recommended 12 applications for EFP issuance by National Marine Fisheries Service (NMFS) but requested four applicants submit missing information (vessel name and/or anticipated amount of fishing effort by area) before NMFS proceeds to consider the application. NMFS will report on the receipt of this information along with other matters related to issuing EFPs for this activity. The thirteenth application, from Mr. Steve Mintz, was submitted after the September deadline as public comment. The Council followed the HMS Management Team recommendation that it be resubmitted for consideration at this Council meeting. It is included as Attachment 3.

Attachment 2 provides summary information on the applications submitted for review at the November 2017 Council meeting. Six new applications were received by the October 19 deadline and are listed below in the reference materials as Attachments 3 through 8.
