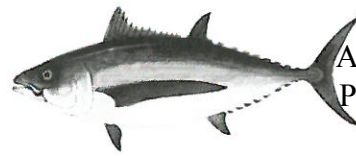

On behalf of The American Albacore Fishing Association and American Tuna, I am pleased to support and endorse the appointment of Carl Nish to the Processor North of Cape Mendocino seat on the Pacific Fishery Management Council's Highly Migratory Species Advisory Subpanel (HMSAS). The American Albacore Fishing Association ("AAFA"), represents commercial albacore pole and line and troll fishermen who collectively harvest almost half of the total U.S. albacore catch. American Tuna is one of the largest purchasers and processors of U.S. harvested Pole & Line/Troll Albacore in the U.S. American Tuna purchases and processes only from pole & line albacore fishermen. American Tuna has promoted and added significant market share to the U.S. market for a raw material sourced from U.S. Pole and Line/Troll Albacore Fishermen.

Mr. Nish is a retired commercial fisherman with over sixty years of HMS fishing experience. In 2005, Mr. Nish was a founding member of both American Albacore Fishing Association and American Tuna. Mr. Nish currently sits on the Board of Directors for both American Tuna and the American Albacore Fishing Association.

The advertisement for the vacancy highlights the duties associated with the Seat as follows: a) the capacity and the extent to which the U.S. commercial and recreational fisheries will harvest the stocks managed under the FMP, b) the effect of such management measures on local economies and social structures, c) potential conflicts

among groups using a specific fishery resource, or d) enforcement problems peculiar to each fishery with emphasis on the expected need for enforcement resources.

We firmly believe that Mr. Nish's experience and knowledge of both processing and harvesting of Highly Migratory Species makes him ideally suited to provide advice and counsel on the aforementioned subjects.

Lastly, appointing Mr. Nish to the vacancy on the HMSAS will benefit us; our members; commercial/charter boat/recreational fishermen along the west coast; and the supporting businesses and communities reliant upon sustainable and active fisheries.

Dear Chairman Anderson:

Pacific Seafood hired Jonathan Gonzalez as a Fishery Policy Analyst almost a year ago. I was directly involved with his interviews and evaluation. There were several key reasons I recommended he be hired for the position. First was his passion for the fishing community and the people who make their living from the sea. Second was the close relationships he had forged amongst many fishermen I knew personally in the CPS and HMS fisheries. Third was that he is intimately familiar with HMS issues and policy. Although Pacific Seafood purchases a large amount of albacore in the NW and some warm water species in California we do not have someone that is involved in the world of HMS. This is an important component of our business that we would like to expand. Pacific believes that any successful business plan must take into account the needs of our fishermen as well as the needs of our customers. This includes coverage of the fishery management programs and processes that govern our access to resources and the long term health of those resources.

Jonathan brought to Pacific Seafood a “plug & play” package for HMS. In addition his energy and enthusiasm for the industry and the work appear to know few limitations. He has established personal history working on a number of important HMS fishery issues over the last four years. He did all of this on his own time and was sometimes paid through donations from fishermen he worked with. Not only did he attend almost every Council meeting in the last several years but he has hit the legislative halls in the states of California, Oregon, and Washington and more recently in our nation’s capital. He has a penchant for learning and analyzing the issues and has also taken on a host of other fishery issues. His real forte however remains HMS.

Jonathan has served on the HMSAS multiple times over the years as a substitute for fishermen who were at sea or others that could not attend. He has always balanced his advocacy for industry with the conservation of our stocks and the preservation of our habitat and environment. He understands that the sustainability of our marine resources is the security of our future. For these reasons Pacific Seafood believes he is the best possible candidate for the open HPSAS positon.
