CALIFORNIA DEPARTMENT OF FISH AND WILDLIFE REPORT ON INSEASON ADJUSTMENTS – FINAL ACTION

The California Department of Fish and Wildlife (CDFW) offers this update on the status of yelloweye rockfish catch in the California recreational groundfish fishery for 2018.

As discussed in CDFW Supplemental Report 1¹ encounters with yelloweye rockfish tracked higher than expected during May and July in 2018, and resulted in state action by CDFW to reduce allowed fishing depths north of Point Conception, effective August 25, 2018. The trend toward higher than projected catches continued in the month of August, based on the most recent counts of sampler-examined and angler-reported fish.

Current catch information now available through September 2, 2018 suggests that 3.79 mt of yelloweye rockfish have been taken (Table 3), against the 3.9 mt California recreational Harvest Guideline. Updated catch projections, including the expected reduction in take due to the August 25 inseason depth change, predict 4.71 mt of yelloweye rockfish mortality through the end of 2018, if no additional regulatory action is taken (status quo).

Regional analysis of yelloweye encounters by management area show that almost half (47 percent) of encounters in 2018 have been in the Northern Management Area (Table 1).

CDFW notes that in 2017, the highest catches also occurred in the Northern Management Area (Table 2), likely in response to new depth regulations that allowed fishing to 30 fathoms through mid-October. Subsequently, inseason action took effect October 19, 2017, to reduce the allowable fishing depths for all management areas north of Point Conception by 10 fathoms.

Additional regulatory action is needed to keep yelloweye rockfish impacts from further exceeding the 2018 California recreational Harvest Guideline. In an effort to allow the Council and its advisors to consider available data and trends in formulating inseason recommendations, CDFW analyzed a number of alternative season structures listed below. The options range from status quo to complete closure of the boat-based recreational groundfish fishery for the remainder of 2018. CDFW will work with agencies and industry representatives during the Council week on other alternatives as requested, utilizing the most up to date inseason information.
