## OMNIBUS PLANNING—EXISTING COMMITMENTS AND NMFS WORKLOAD

The Groundfish Management Team report under this agenda item (Agenda Item G.4.a, GMT Report 1) provides a table of new management measure that might potentially be taken up in the coming year. When the Council sets its omnibus groundfish priorities, it usually does so in the context of its existing Council commitments and NMFS workload. While the Council is not scheduled to set its omnibus priorities at this meeting, in September the Council discussed possibly identifying one or two items on which some progress might be made over the winter. To provide context for the Council's November deliberations, the following table lists existing Council commitments (as reflected on the Year at a Glance planner) and NMFS workload (as reflected in Agenda Item G.1. NMFS Report 2). Note that workload related to some other NMFS/NOAA GC tasks is not reflected in this table (e.g. response to law suits).
