NATIONAL MARINE FISHERIES SERVICE REPORT ON FUTURE COUNCIL MEETING AGENDA AND WORKLOAD PLANNING FOR GROUNDFISH

The National Marine Fisheries Service (NMFS) reviewed the draft April Pacific Fishery Management Council (Council) meeting agenda (<u>Agenda Item C.5, Attachment 2</u>) and the draft Year at a Glance (<u>Agenda Item C.5, Attachment 1</u>) in the advanced briefing book. We also considered Council discussion at the March meeting and the Groundfish Management Team (GMT) Report on Future Council Meeting Agenda and Workload Planning (<u>Agenda Item C.5, a,</u> <u>Supplemental GMT Report 1</u>).

We propose the following adjustments for the Year at a Glance, based on NMFS staffing capacity (Table 1):

- We suggest adding a Groundfish workload planning agenda item at 4 of the 5 annual Council meetings, consistent with the Council's discussions on adjustments to Council Operating Procedure 9.
- We support the revised timeline for the Salmon Mitigation Measures Action described in Agenda Item C.5.a., Supplemental GMT Report 1.
- We echo the GMT's discussion in <u>Agenda Item C.5.a</u>, <u>Supplemental GMT Report</u> <u>1</u>regarding the "Flexibility in ACL Management" agenda item. To this end, we suggest removing the "Flexibility in ACL Management" agenda items from the June and November 2019 meetings. We support instead using staff capacity and time on the June 2019 agenda to develop responses to the new sigma values the Council adopted at the March 2019 meeting.
- We recommend maintaining an electronic monitoring agenda item at the April meeting to update the Council on the new Electronic Monitoring rulemaking and implementation timeline. We also propose a placeholder to update the Council on the Electronic Monitoring 3rd Party Transition Plan at the June Council meeting, and can confirm whether we will be ready for this agenda item during workload planning at the April meeting.
- We recommend removing the Western Cowcod Conservation Area adjustments item from the June and September 2019 agendas. Instead, we recommend adding an agenda item for a Non-trawl Area Management action that analyzes: 1) Western Cowcod Conservation Area adjustments; 2) Non-trawl rockfish conservation area modifications (Item 6 in <u>Agenda Item G.4.a, GMT Report 1</u>); and 3) non-trawl logbooks. This package of alternatives builds on the Council's recommendations under the Omnibus Agenda item at the March meeting, appropriately expands the scope of the Cowcod Conservation Area action to benefit more non-trawl vessels, and begins work on a much needed reporting requirement that supports both our fisheries management needs and Endangered Species Act obligations for seabirds and other species that interact with fixed gear. We have proposed waiting to add this agenda item until the June 2020 meeting due to concerns with overlapping this large action with two other large actions (harvest specifications/management measures and sablefish gear switching/area management), but

welcome input on GMT and Council staff capacity to begin analysis on this item at an earlier meeting (e.g., November 2019).

- We recommend delaying selection of the range of alternatives for sablefish gear switching and area management from June to September to give the Sablefish Management and Trawl Allocation Attainment Committee (SaMTAAC) time to prepare and submit a report on its May meeting for the advanced briefing book.
- We echo the GMT's recommendation in <u>Agenda Item C.4.a., Supplemental GMT Report</u> <u>1</u> for moving the 2020 Midwater Trawl Gear EFP FPA from June to September. That timing will still allow NMFS to undertake the necessary permitting for the 2020 season.
