

SALMON TECHNICAL REPORT 2
COLLATION OF PRELIMINARY SALMON MANAGEMENT ALTERNATIVES
FOR 2019 OCEAN FISHERIES

The Salmon Technical Team received the following guidance from the Council in further shaping the 2019 Salmon management measures:

Washington Department of Fish and Wildlife:

Guidance for STT for analysis of options for Non-Indian fisheries North of Falcon:

Alternative I

Reduce coho TAC to 220,000 and adjust all corresponding subquotas accordingly
Change starting date for recreational fishery in Neah Bay and La Push subareas to June 15

Alternative II

Reduce coho TAC to 205,000 and adjust all corresponding subquotas accordingly
Change starting date for recreational fishery in Westport subarea to June 29

Alternative III

Reduce coho TAC to 150,000 and adjust all corresponding subquotas accordingly

California Department of Fish and Wildlife:

Implement the following changes:

Commercial Troll Management Alternatives

OR/CA Border to Humboldt South Jetty (California KMZ)

For all Alternatives:

Replace “Open seven days per week” with “Open five days per week, Friday through Tuesday.”

For the July quotas, replace July 31 with July 30.

For the August quotas, replace August 1 with August 2 and replace August 29 with August 31.

Alternative 1:

Add the language, “Landing and possession limit of 20 Chinook per vessel per day.”

Adjust the Chinook size limit to 27 inches.

Alternative 2:

Replace all quota values with 3,500 Chinook.

Add the language, “Landing and possession limit of 25 Chinook per vessel per day.”

Adjust the Chinook size limit to 27 inches.

Alternative 3:

Replace all quota values with 6,000 Chinook.

Add the language, “Landing and possession limit of 30 Chinook per vessel per day.”

Horse Mt. to Pt. Arena (Fort Bragg)

Alternative 1:

Remove August 1-29 and September 1-30.

Add May 1-15, June 1-30, and July 11-31.

Adjust the Chinook size limit to 27 inches.

Replace the sentence that states, “All salmon caught in the area prior to September 1 must be landed and offloaded no later than 11:59 p.m., August 30” *with* “All salmon caught in the area must be landed and offloaded no later than 11:59 p.m., August 5.”

In the sentence that states, “During September, all fish must be landed north of Point Arena,” *remove* “During September.”

Alternative 2:

Replace May 1-31 with May 10-31.

Replace June 1-30 with June 1-20.

Replace July 1-31 with July 11-31.

Adjust the Chinook size limit to 27 inches.

In the sentence that states, “All salmon caught in the area prior to September 1 must be landed and offloaded no later than 11:59 p.m., August 30,” *remove* “prior to September 1.”

In the sentence that states, “During September, all fish must be landed north of Point Arena,” *remove* “During September.”

Alternative 3:

Remove September 1-30.

Add June 11-30.

Replace July 1-31 with July 11-31.

In the sentence that states, “All salmon caught in the area prior to September 1 must be landed and offloaded no later than 11:59 p.m., August 30,” *remove* “prior to September 1.”

Remove the sentence that states, “During September, all fish must be landed north of Point Arena.”

Pt. Arena to Pigeon Pt. (San Francisco)

Alternative 1:

Replace May 1-31 with May 1-20.

Replace July 1-31 with July 11-31.

In the sentence that states, “During September, all fish must be landed south of Point Arena,” *replace* “September” with “May, June, and July.”

Alternative 2:

Add May 10-31, June 1-30, and July 11-31.

In the sentence that states, “During September, all fish must be landed south of Point Arena,” *replace* “September” with “May, June, July, and August.”

Alternative 3:

Remove September 1-30, October 1-4, and October 7-11.
Replace June 15-30 with June 11-30.
Replace July 16-31 with July 11-31.
Replace August 1-15 with August 1-29.

Remove the sentence that states, “During September, all fish must be landed south of Point Arena.”

In the sentence that states, “All salmon caught in the area prior to September 1 must be landed and offloaded no later than 11:59 p.m., August 30,” *remove* “prior to September 1.”

Pigeon Pt. to U.S./Mexico Border (Monterey)

For all Alternatives:

In the sentence that states, “All salmon caught in the area must be landed and offloaded no later than 11:59 p.m.,” *replace* the dates with August 5.

Alternative 1:

Add July 11-31.

Alternative 2:

Add July 11-31.

Alternative 3:

Replace May 1-17 with May 1-31.
Replace June 17-30 with June 11-30.
Add July 11-31.

Recreational Management Alternatives

Pigeon Pt. to U.S./Mexico Border (Monterey)

Alternative 2:

Replace April 6 - August 11 with April 6 - August 18.

Alternative 3:

Replace April 6 - July 6 with April 6 - August 11.
