

**NATIONAL MARINE FISHERIES REPORT ON THE
 SOUTHERN RESIDENT KILLER WHALE (SRKW) AD HOC WORK GROUP**

The National Marine Fisheries Service (NMFS) appreciates the opportunity to work with the Pacific Fishery Management Council (Council) to reassess the effects of Council ocean salmon fisheries on SRKWs. When the Council formally established the SRKW Ad Hoc Work Group (Workgroup), it instructed NMFS to gather names of participants from the management entities identified in the draft Terms of Reference (TOR) (Supplemental NMFS Report 1, Agenda Item F.3.a). The current initial roster is described in Table 1.
