GROUNDFISH MANAGEMENT TEAM REPORT ON NATIONAL MARINE FISHERIES SERVICE REPORT

In March 2019, the Pacific Fishery Management Council (Council) adopted the Groundfish Management Team's (GMT) proposed groundfish workload prioritization process. While there is no prioritization item scheduled for this meeting, the GMT presents a draft of our workload matrix (Attachment 1) to help the Council better understand our progress on ongoing and scheduled projects, in context with what the National Marine Fisheries Service (NMFS) is working on (G.1.a, Supplemental NMFS Report 2, April 2019). The shaded blocks represent the GMT's anticipated timeline for direct involvement with the issue (e.g., through the Council's final action), noting that some GMT members may have additional workload to assist NMFS and Council staff in developing the final regulatory documents. Any feedback on this report would be helpful in improving this new process prior to the June Council meeting.

Additionally, based on Council action in March, the GMT is providing an updated groundfish workload prioritization list, with items renumbered as appropriate (Attachment 2). Changes from March include the removal of the item, entitled "Retain Halibut in the Sablefish Fishery (South of Pt. Chehalis)" (previously item #9), and the addition of item #17, "Commercial Use of Recreational Discards," to the list. Additionally, the GMT noted the progress of the analysis by the staff or if research or an Exempted Fishing Permit to inform future analysis is ongoing.

Item #17: Permitting Commercial Sale of Recreational Fish Waste Background

At the March 2019 Council meeting, the Enforcement Consultants (EC) brought forward a proposal to change Federal regulations to allow for ports to collect waste at recreational fish cleaning stations and use that fish waste (carcasses) to produce commercially sold products (e.g., fish meal). Currently, recreational caught fish, and any parts of, are prohibited from entering any commercial market.

Relevant Factors for Analysis

The GMT does not believe any analysis would be required by the team.

Potential Benefits

Low

There would be additional economic benefit to the ports in which companies establish contracts to collect and process these discards.

Workload

Unsure/Likely Low

We believe it would likely be low and the majority of the workload would fall on NMFS and enforcement staff. However, as this is a significant policy change, the GMT is unsure of what our workload would be and where our input would be needed.

GMT Proposed Process

The GMT looks to NMFS for suggestions on the best pathway for implementation.
