- Propose conservation and management measures to minimize bycatch of listed species

2016-2017

- Continued development of the shoreside midwater rockfish trawl fleet
- Increase in the number of fleet-wide pots used.


Changes notable but do not warrant a new look at the BiOps

Eulachon




- Five year geometric mean bycatch estimates: 2016 – 1,326 eulachon 2017 – 676 eulachon
- Bycatch under precautionary and reinitiation thresholds for 2016 and 2017
- No Workgroup recommendations

Eulachon bycatch thresholds (0.01% and 0.02%) compared with the five-year geometric mean for West Coast Groundfish Fishery eulachon bycatch (number of individuals)



Green Sturgeon





- Southern DPS
 - 1-16 encounters per year (2013-2017)
 - Incidental take statement amount not exceeded

 No Workgroup recommendations


DPS bycatch in federal fisheries 2002–2017 horizontal dashed line = annual ITS threshold (28 Southern DPS individuals)



Humpback Whales

Two documented takes:

- Limited Entry Sablefish (2014)
- Open Access Fixed Gear (2016)
- Incidental take amount was exceeded
 - Above 5 year average of 1/year
- NMFS reinitiated consultation based on DPS changes. ITS exceedance will also be considered.



Dotted lines = 5-year incidental take limit per the 2012 BiOp Points = observed takes

Humpback Whales



The Workgroup recommends the Council:

- 1. Encourage NMFS to collaborate with the Council during the consultation process
- 2. Pursue a coastwide Federal fixed gear logbook requirement for all fixed gear sectors
- 3. Encourage NMFS, industry, and other partners to:
 - a. Explore gear modifications to reduce entanglements/mortalities
 - b. Consider changes to fixed gear marking requirements
 - c. Have discussions on the extent of lost gear and storage of gear at sea
 - d. Identify methods or improved procedures for identification of humpback whales at the DPS level

Short-tailed albatross



Mean expected total STAL bycatch

- No STAL takes documented in 2016-2017
- Fleet-wide estimates of mean bycatch ranged from 0.11 to 1.32 STAL/year
- Incidental take statement amount not exceeded

Effort = hooks Three effort measures show similar patterns

Short-tailed albatross

• The Workgroup recommends the Council support efforts that explore ways to improve streamer lines or gear configuration for the purpose of mitigating seabird interactions.
