### Additional information you think would be helpful in reviewing the application concerning where you plan to fish and the amount of fishing:

I plan to fish albacore from July to September North of point conception to Oregon swordfish often follow and eat tuna. Using DSBG around upwellings would complement jigging for albacore as both are daytime fisheries.October to January I plan to fish DSBG during daylight and DGN at night.

Gear tending- trolling in sight of DSBG when trolling use less sets maybe 2 or 3 when albacore biting, Determine whether swordfish in same area then use all ten sets of gear. Concurrent gear use -trollng in early morning and before sunset is best. DSBG should probably work better for slow jigging during middle of days
