Hello,

My name is J.J. Gerritsen, I own and operate a 73-foot, commercial pole and line albacore boat. Annually I participate in the seasonal albacore fishery which in recent years, has taken place off the coast of Northern California, Oregon, and Washington. I am a member of the American Albacore Fishing Association (AAFA), and the albacore fishery is my sole income for supporting my family.

I live and keep my boat (Piky) in San Diego. Every spring I leave San Diego and head up the California and Oregon coast in search of the most fertile areas to catch albacore. I fish mostly offshore outside the 200-fathom curve generally from 20 to 100 miles off the beach. A trip can range from 1 to 4 weeks in duration. I often see swordfish while fishing albacore in these regions. I'm interested in finding out on a scientific level if there is truly a viable fishery in these waters. I believe DSBG is a fishery that can be fished concurrently with the albacore fishery. My season usually goes into late summer or early fall; then I begin to slide back down the coast in hopes of a late catch off Central California. When making this slide in recent years, I have seen good swordfish sign from Oregon to Point Conception. I want to test the DSBG to determine based on the amount of swordfish I see off the coast of California and Oregon if there is a viable DSBG fishery in this region. I believe I can help fill data gaps in areas where extensive research has not yet been conducted. My goal is to use the EFP to help collect data on this underutilized resource.

X Bycatch & protected species interactions

How?

All bycatch if marketable will be kept and processed. All nonmarketable and protected species will be promptly and carefully released. Both marketable and nonmarketable bycatch will be logged and recorded for NMFS, CA DFW, and OR DFW. If an ESA-listed species is entangled or hooked, I will report the species and its release condition to the NMFS point of contact via email or phone within 24 hours after every EFP trip. In addition, the vessel operators will take the required safe handling and release workshop held by the NMFS WCR Protected Resources before fishing the EFP.

(b) X Active gear tending

How?

I anticipate simple active gear tending keeping all pieces of gear insight at all times for timely strike response to minimize bycatch mortality and prevent gear loss.

(c) X Gear conflicts/number of vessels

How?

I believe fisherman generally respect each other's areas. I would consider one mile to be adequate separation from another fisherman's gear. I plan to fish above point conception and as far north as the Oregon Washington border. At this point, I do not anticipate gear conflict in these areas.

d) X DSBG time and area use

How?

I expect to fish this gear in central and northern CA as well as Oregon water from August through December.

e) X dear configuration

How?

I plan to fish both DSBG and LBG. The method used will be determined based on which gear type is performing better under specific conditions.

How?

I am hoping that the pole and line/troll albacore fishery will be a viable concurrent fishing activity with the EFP.
