GROUNDFISH NON-SALMON ENDANGERED SPECIES WORKGROUP REPORT

On December 7, 2012, National Marine Fisheries Service (NMFS) published a Biological Opinion (Opinion) prepared pursuant to section 7(a)(2) of the Endangered Species Act (ESA) on the continuing operation of the Pacific coast groundfish fishery. The Opinion analyzed the effects of the fishery on green sturgeon (*Acipenser medirostris*), eulachon (*Thaleichthys pacificus*), humpback whales (*Megaptera novaeangliae*), Steller sea lions (*Eumetopiasjubatus*), and leatherback sea turtles (*Dermochelys coriacea*). The Opinion concluded that the action is not likely to jeopardize the continued existence and is not likely to destroy or adversely modify designated critical habitat of green sturgeon, eulachon, and leatherback sea turtles, and is not likely to jeopardize humpback whales. (Note that the eastern distinct population segment [DPS] of Steller sea lions was subsequently de-listed.)

The Council's Groundfish Endangered Species Workgroup (Workgroup) was established in conformance with the Opinion and last reported to the Council in June 2015. The Workgroup meets biennially, reviews updated estimates of the incidental take of the above ESA-listed species, and makes recommendations to the Council on mitigation measures should take in groundfish fisheries be a concern. The Workgroup met February 15-16, 2017 to take up these tasks. Meetings of the Workgroup are timed so that recommendations that involve adoption or adjustment of management measures can be considered as part of the biennial harvest specifications process, slated to begin at the June Council meeting for the 2019-2020 period. The Workgroup Report is attached (Agenda Item F.3.a, Groundfish Endangered Species Workgroup Report).
