CALIFORNIA DEPARTMENT OF FISH AND WILDLIFE REPORT ON CORRECTIONS TO THE 125 FATHOM RCA LINE BETWEEN 40°10' AND 34°27' N LATITUDE

At the March Council meeting, the Groundfish Advisory Subpanel (GAP) identified errors in the 125 fm line that is now used to define the shoreward boundary of the Rockfish Conservation Area (RCA) for the non-trawl fishery between 40°10' and 34°27' N Latitude (Agenda Item C.5.a, Supplemental GAP Report, March 2017). The waypoints used to define the 125 fm line creates crossovers with the 150 fm line and now closes areas that were previously open when the depth restriction was 150 fm.

As part of the 2017-2018 biennial specifications process, California Department of Fish and Wildlife (CDFW) recommended a change to the RCA line from 150 fm to 125 fm, after analyzing expected impacts to both target catch and expected bycatch, and concluding the change could be accommodated within allowable limits and harvest guidelines. Although the 125 fm line was previously defined in regulations and available for use in management, it had never been implemented and never been field tested until now (Agenda Item C.5.a, Supplemental CDFW Report, March 2017). Although CDFW recommended modifications to waypoints defining other depth contours as part of the 2017-2018 biennial specification process, we were unaware of the errors in the 125 fm line and therefore did not recommend any changes at that time.




Figure 1. Proposed modification to 125 fm RCA line at Delgada Canyon. The proposed change would increase the allowable fishing area by 5.22 km².

Given the concerns raised by the GAP, CDFW staff reviewed the 125 fm line between 40°10' and 34°27' N Latitude and found several errors resulting in crossovers. The areas affected include Delgada Canyon, Usal Canyon, Noyo Canyon, Cordell Bank, and Point Ano Nuevo. CDFW proposes corrections to these areas (Table 1; Figures 1-5) to eliminate crossovers with the 150 fm line and allow access to fishing grounds consistent with decisions made in the 2017-2018 specifications process and approved by National Marine Fisheries Service.




Figure 2. Proposed modification to 125 fm RCA line at Usal Canyon. The proposed change would increase the allowable fishing area by 4.52 km^2 .




Figure 3. Proposed modification to 125 fm RCA line at Noyo Canyon. The proposed change would increase the allowable fishing area by 0.28 km².




Figure 4. Proposed modification to 125 fm RCA line at Cordell Bank. The proposed change would decrease the allowable fishing area by 1.76 km^2 .




Figure 5. Proposed modification to 125 fm RCA line near Point Ano Nuevo. The proposed change would increase the allowable fishing area by 1.13 km².

CDFW used GIS software to evaluate the proposed waypoint corrections. At Delgada Canyon, the corrections would increase the allowable fishing area by 5.22 km² (Figure 1); at Usal Canyon 4.52km² (Figure 2); Noyo Canyon 0.28 km² (Figure 3); and Point Ano Nuevo 1.13km² (Figure 5). Allowable fishing area would decrease at Cordell Bank by 1.76 km² (Figure 4).
