## UPDATE ON EXEMPTED FISHING PERMITS (EFPS) FOR 2021-2022

At its November 2019 meeting, the Council approved a number of groundfish EFPs for public review and final action in June 2020 as part of the cycle for the 2021-2022 groundfish specifications. At the same time, it scheduled this agenda item as a check-in on the EFPs and an opportunity to incorporate a trawl electronic monitoring (EM) EFP into the package. The Council's November actions on the EFPs that were moved forward are described in Agenda Item H.3, Attachment 1. As reflected in the following table, one EFP approved by the Council has since been withdrawn and another, an EM EFP, has not been submitted.

Also, at its November 2019 meeting, the Council directed a letter be written to NMFS requesting that the effectiveness date for EM regulations for the West Coast be delayed to 2022 and stating that at its March 2020 meeting the Council expected to consider an EM EFP to cover the 2021 fishery (Agenda Item H.3, Attachment 8). In response, the Council received a February 4, 2020 letter from National Marine Fisheries Service (NMFS/NOAA Fisheries, Agenda Item Attachment 9) indicating that NMFS needed to continue on schedule with the EM regulations for 2021 and raising question as to whether the reasons for an EFP raised in the Council letter meet EFP criteria:

In order for NOAA Fisheries to approve an EFP, it must be an activity regarding the targeting or incidental harvest of species managed under a Fishery Management Plan or fishery

regulations that would otherwise be prohibited. It is not clear from your letter that any of the proposed reasons meet these requirements.

## **Council Action:**

- 1. Review updated EFPs and determine if any additional guidance is necessary.
- 2. Review correspondence pertaining to EM and the development of an EFP and provide guidance.
