# STAFF SUMMARY OF FEDERAL LEGISLATION IN THE 116<sup>TH</sup> U.S. CONGRESS

A summary of recent Federal legislation is provided below (see table below for full summary). Full text of these bills, with background information and current status, can be found at the Library of Congress website (<u>http://thomas.gov</u>) or at <u>http://govtrack.us</u>. Percentages in parentheses refer to "chance of passage" as determined by Govtrack.us.

Bill status is up to date as of February 10, 2020. Two bills been signed into law since the November Council meeting. The Council has not received any new requests for comment.

Bills that have not moved forward since November are listed in the table at the end of this report.

#### Signed into Law

## <u>Columbia River In-Lieu and Treaty Fishing Access Sites Improvement Act</u> (S. 50/HR 91)

- Introduced by Jeff Merkley/Earl Blumenauer (D-OR).
- S. 50 was signed by the President on December 20, 2019.

The development of the Columbia River Power System resulted in the destruction of many native fishing sites and villages. For thousands of years, numerous tribes based their entire livelihood and culture around the Columbia River, living on its shores and eating and trading the salmon from its waters. The dams, constructed beginning in the 1930s, deeply and severely impacted this heritage, flooding tribal homes and traditional fishing sites, and inhibiting tribal members' ability to exercise treaty rights to fish in their usual and accustomed places. The tribes and their citizens have never been fully compensated for these losses.

In a series of agreements and laws starting in 1939, the Federal government acquired and developed small parcels of land to serve as "in-lieu" and Treaty Fishing Access Sites, providing members of the four Columbia River Treaty tribes – the Nez Perce, Umatilla, Warm Springs, and the Yakama Nation – access to exercise their rights to fish in the Columbia and reside at their traditional fishing places and stations. Finally completed in 2011, a total of 31 sites have been developed along the banks of the river, to be used primarily for in-season fishing and some temporary camping. However, many tribal members now use these areas as permanent residences. These sites were not designed for and cannot sustainably accommodate this intense use.

This Act aims to improve conditions at these sites in the short term, calling for the Bureau of Indian Affairs to conduct a much-needed assessment of current safety and sanitation conditions at the sites, identifying areas of high use and opportunities for improvement in coordination with the affected tribes. Next, the bill directs the Bureau to work on improving sanitation and safety conditions in several key areas such as structural improvements, safety improvements, electrical infrastructure, and basic sewer and septic infrastructure.

In the longer term, Senator Merkley and Representative Blumenauer are working with the Tribes, the U.S. Army Corps of Engineers, the Bureau of Indian Affairs, and colleagues in the Senate and House on legislation and funding to build permanent housing to replace what was flooded by the

construction of the dams, honoring the Tribes' treaty rights and providing compensation that has long been denied. (*Summarized from Congressional statements*).

## Maritime Security and Fisheries Enforcement Act (S. 1269)

- Introduced by Roger Wicker (R-MS).
- Incorporated into the National Defense Authorization Act, which was signed by the President on December 20, 2019.

This bipartisan Act promotes a whole-of-government strategy to combat illegal, unreported, and unregulated (IUU) fishing. The Act gives Federal agencies greater tools to protect maritime security, lawful fishing, and the global seafood supply chain. It establishes an interagency working group to provide Federal agencies with a coordinated framework to effectively combat IUU fishing and authorizes a range of agency activities, including building capacity for law enforcement and port security, improving transparency and traceability in the seafood supply chain, promoting the use of technology to combat IUU fishing, and encouraging better information sharing among agencies and other organizations. (*Summarized from Congressional statements*).

## **New Bills**

## Fishery Failures: Urgently Needed Disaster Declarations Act (HR 5548/S. 2346)

- HR 5548 introduced by Jared Huffman (D-CA) on January 7, 2020. Committee hearing held January 14, 2020. (3%)
- S. 2346 introduced by Roger Wicker (R-MS) on July 30, 2019. (16%)

HR 5548 is a companion bill to S. 2346, which the Council commented on in September 2019. In general, the gist and timelines of the bills are the same, but the Huffman version adds two unrelated provisions:

- Requires a report, within one year, by the Comptroller General examining efforts by the regional fishery management councils, Atlantic States Marine Fisheries Commission (ASFMC), and National Marine Fisheries Service (NMFS) to prepare and adapt to climate change. The report would include current and previous such efforts; an examination of any guidance issued by the Councils and NMFS, and whether and how it was used; identification and recommendations for how best to address relevant knowledge gaps to increase the Councils', ASFMC's, and NMFS' ability to adapt fishery management for the impacts of climate change; recommendations on how these agencies can better adapt management and prepare fishing industries and communities for the impacts of climate change to fisheries and marine ecosystems, improve forecasts, communicate scientific advice, and better manage fisheries, etc.
- Adds new requirements to the Biennial Report on International Compliance in section 607 of the High Seas Driftnet Fishing Moratorium Protection Act. Requires the report to describe actions taken to carry out the provisions of section 206 of the Magnuson-Stevens Act (MSA), including a list and description of any new fisheries that conduct large-scale driftnet fishing beyond the exclusive economic zones (and more).

In addition, the bill...

- removes Wicker references to aquaculture operations as a recipient of disaster relief
- removes the Wicker text, "A fishery subject to overfishing in any of the 3 years preceding the date of a determination under this section is not eligible for a determination of whether a fishery resource disaster has occurred unless the Secretary determines that overfishing was not a contributing factor to the fishery resource disaster."
- clarifies that reductions in fishing opportunities as a result of conservation actions taken under the MSA to not qualify as fishery disasters
- adds tsunamis, harmful algal blooms, hypoxic zones, and marine heatwaves as causes of resource disasters
- adds lost resource tax revenues and revenue loss by processors as information that must be included in requests for disaster relief, if applicable
- allows the Secretary to provide assistance to requesters, as well as regional contacts to facilitate disbursement of funds, etc.
- adds examples of fishery and fishery infrastructure businesses
- requires the Secretary to consider loss of revenue to charter fishing businesses and loss of tribal ceremonial fishing opportunity in making decisions about disaster declarations
- allows disaster relief funds to be used for capacity reduction, to offset budgetary costs to refinance Federal fishing capacity reduction loans, to repay the principle of a Federal fishing capacity reduction loan, for incentives to encourage commercial fishermen to return to the fishery once it has recovered from a disaster, and for hatcheries and stock enhancement to rebuild affected stocks or offset pressure on affected stocks
- clarifies the definition of "anthropogenic causes" for fishery disaster scenarios
- removes the Wicker definition of fishing community.

## Blue Carbon for Our Planet Act (HR 5589)

• Introduced by Suzanne Bonamici (D-OR) on January 13, 2020. (3%)

This legislation is designed to capture the power of oceans and estuaries to protect "coastal blue carbon" ecosystems such as mangroves, tidal marshes, seagrasses and kelp forests. Such ecosystems can remove carbon dioxide from the atmosphere and store it for centuries in stems, branches, leaves, roots and soils. According to the High-Level Panel for a Sustainable Ocean Economy, the protection and restoration of blue carbon ecosystems could prevent approximately one gigaton of carbon dioxide from entering the atmosphere by 2050. They are also key to healthy fisheries.

The Blue Carbon for Our Planet Act would create a national map of coastal blue carbon ecosystems and their sequestration potential, study the effects of environmental stressors on rates of carbon sequestration, improve protections for existing coastal blue carbon ecosystems and restore degraded ecosystems. It would also establish an Interagency Working Group on Coastal Blue Carbon.

## **Property Rights Protection Act (HR 5601)**

• Introduced by Ralph Norman Jr. (R-SC) on January 14, 2020. (3%)

This bill would prohibit a critical habitat designation by the government unless either the landowner consents, or the Secretary of the Interior certifies that a species is in danger of extinction without such a designation. In this case, the government would purchase that land at 150% of its fair market value.

## Passed Senate

## America's Conservation Enhancement (ACE) Act (HR 925)

• Introduced by Mike Thompson (D-CA) on January 30, 2019. Passed the House on November 20, 2019; passed the Senate with changes on January 9, 2020. (Awaiting House vote). (65%)

This bipartisan legislation would reauthorize or establish several important government wildlife conservation programs. Among other wildlife-related provisions, the bill reauthorizes the North American Wetlands Conservation Act, reauthorizes the National Fish and Wildlife Foundation Act, authorizes funds to combat the threat of invasive species, and encourages partnerships among public agencies and other interested parties for promoting fish conservation. The bill establishes a National Fish Habitat Board to establish national goals for fish habitat conservation, recommend partnership entities, and make recommendations regarding fish habitat projects. (One member would a be a representative of the regional fishery management councils). The bill authorizes \$7.2 million for each year from 2021 through 2025 for habitat conservation projects, as well as funds for U.S. Fish and Wildlife Service, National Oceanic and Atmospheric Administration, and other Federal agencies to provide technical assistance for these projects.

#### **Passed House**

## Coastal and Great Lakes Communities Enhancement Act (HR 729)

• Introduced by Derek Kilmer (D-WA) on January 23, 2019 and reported by committee on September 25. Passed the House on December 10, 2019. (21%)

Formerly the Tribal Coastal Resiliency Act. Amends the Coastal Zone Management Act to authorize grants to tribes for use in achieving tribal coastal zone objectives.

## Shark Fin Sales Elimination Act (HR 737/S. 877)

- HR 737, introduced by Gregorio Sablan (D-CNMI), passed the House on November 20, 2019. This bill has 287 bipartisan cosponsors. (74%)
- S. 877 introduced by Corey Booker (D-NJ) and reported by committee on December 20, 2019. (50%)

It has been illegal to de-fin a shark in U.S. waters since 2012, and 12 states have banned the sale of shark fins within their borders, but the sale of shark fins isn't illegal on a Federal level. This bill bans the selling or buying of shark fins nationwide, with a fine of up to \$100,000 (the maximum fine allowed under the MSA.) The bill would permit sharks to be caught for either subsistence purposes or for scientific research. The bill has attracted 215 bipartisan House cosponsors: 159 Democrats and 56 Republicans. It awaits a potential vote in the House Natural Resources Committee. While that's one of the highest cosponsors of any bill in this Congress, the previous version introduced last Congress attained 262 bipartisan House cosponsors but failed to receive a vote. ## San Francisco Bay Restoration Act (HR 1132)

• Introduced by Jackie Speier (D-CA) in February 2019. Reported by committee Sept. 2019. Passed the House on February 5, 2020. (n/a)

This bill Amends the Federal Water Pollution Control Act to establish a grant program to help revive the Bay Area's wetlands, improve water quality, and protect coastal communities from the damaging effects of sea level rise.

## Promoting United Government Efforts to Save Our Sound (PUGETS) Act (HR 2247)

• Introduced by Denny Heck (D-WA) in April 2019. Reported by committee Sept. 2019. Passed House February 5, 2020. (n/a)

Amends the Federal Water Pollution Control Act to support programs and activities to protect the water quality of Puget Sound.

## Fish "SAFE" Act (HR 4719/S. 1410)

• Introduced by Jared Golden (D-ME) and Ed Markey (D-MA) on May 5/October 17. HR 4719 passed the House on December 17, 2019. (48%)

This bill reauthorizes and expands the Department of Health and Human Services fishing safety training and research grant programs and increases the Federal share of costs for activities under these programs.

## Save Our Seas 2.0 Act (S. 2372 and S. 1982)

- S. 2372 was introduced by Robert Menendez (D-NJ) (with Dan Sullivan and Sheldon Whitehouse) on July 31 and was reported by committee on September 25, 2019. (3%)
- S. 1982 was introduced by Dan Sullivan (R-AK) on June 26, 2019 and passed the Senate unanimously on January 9, 2020. (79%)

A bill to enhance global engagement to combat marine debris, particularly plastics. The bill creates a Federal marine debris foundation, establish a "genius prize" to encourage the development of solutions to address plastics pollution, and launches a number of Federal studies into marine debris.

## **Reported by Committee**

#### Driftnet Modernization and Bycatch Reduction Act (HR 1979/S. 906)

- HR 1979 was introduced by Ted Lieu (D-CA) on March 28, 2019. (3%)
- S. 906 was introduced by Dianne Feinstein (D-CA) on March 27, 2019 and was reported by committee on December 5, 2019. (18%).

Extends California state regulations regarding driftnets to all Federal waters within five years. Authorizes NOAA to help fishermen transition.

## Digital Coast Act (HR 2189/S. 1069)

- S. 1069 introduced by Tammy Baldwin (D-WI) on April 9; reported by committee November 13, 2019. (38%)
- HR 2189 introduced by A. Dutch Ruppersberger (D-MD) on April 9 and reported by committee on November 26, 2019. (3%)

Requires Commerce (NOAA) to establish a constituent-driven program to provide a digital information platform capable of efficiently integrating coastal data with decision-support tools, training, and best practices and to support collection of priority coastal geospatial data to inform and improve local, State, regional, and Federal capacities to manage the coastal region.

#### Northwest California Wilderness, Recreation, and Working Forests Act (HR 2250)

• Introduced by Jared Huffman (D-CA) in April 2019. Reported by committee Nov. 20, 2019 and Feb. 4, 2020.

Provides for restoration, economic development, recreation, and conservation on Federal lands in Northern California. (16%)

#### **Recovering America's Wildlife Act (HR 3742)**

• Introduced by Debbie Dingell (D-MI) on July 12, 2019. Reported by committee on December 5, 2019. (15%)

Amends the Pittman-Robertson Wildlife Restoration Act to make supplemental funds available for management of fish and wildlife species of greatest conservation need as determined by State fish and wildlife agencies.

## **Coordinated Ocean Observations and Research Act (S. 914)**

• Introduced by Roger Wicker (R-MS) in March 2019. Reported by committee on April 3, 2019. (38%)

Reauthorizes the Integrated Coastal and Ocean Observation System Act to clarify NOAA's authority with respect to post-storm assessments, and to require the establishment of a National Water Center.
