STAFF SUMMARY OF FEDERAL LEGISLATION IN THE 116TH U.S. CONGRESS

A summary of recent Federal legislation is provided below. Bill status is up to date as of August 13, 2020. Bills that have not moved forward since June are listed in the table at the end of this report.

Requests for Comment

On August 13, the Council received a request for the Legislative Committee to discuss the RESTAURANTS Act, below.

Introduced

RESTAURANTS Act (S. 4012, H.R. 7197)

• Introduced by Roger Wicker (R-MS) on June 18, 2020 and by Earl Blumenauer (D-OR) on June 15, 2020 (4%)

These bills (which are essentially the same) establish a \$120 billion revitalization fund to help independent restaurants deal with the long-term structural challenges facing the industry because of COVID-19, and to support the reemployment of 11 million workers.

There are no clauses specifically relating to seafood or fishermen.

The bill proponents note that in April alone, 5.5 million restaurant workers lost their jobs, accounting for 27 percent of total job losses in the month. Without further action from Congress, over 11 million independent restaurant workers are at risk of permanently losing their jobs. Restaurants are facing months of massive revenue losses because of government-mandated social distancing, rising costs of supplies, new expenses for personal protective equipment, and a decrease in the public's willingness to dine out.

A recent study found that 85 percent of independent restaurants are likely to close by the end of the year if direct aid like the revitalization fund is not provided to the industry.

Neither bill applies to franchises with over 20 locations. The House bill does not apply to publicly traded companies.

The program would only run through December 31, 2020, and then any leftover money would be deposited back in the treasury.

Breaking Free from Plastic Pollution Act (H.R. 5845)

• Introduced by Alan Lowenthal (D-CA) on Feb. 11, 2020 (4%)

A bill to amend the Solid Waste Disposal Act to reduce the production and use of certain singleuse plastic products and packaging, to improve the responsibility of producers in the design, collection, reuse, recycling, and disposal of their consumer products and packaging, to prevent pollution from consumer products and packaging from entering into animal and human food chains and waterways.

Pandemic Fishery Disaster Relief Act (H.R. 7167)

• Introduced by Jared Golden (D-ME) on Feb. 11, 2020 (4%)

A bill to amend the Magnuson-Stevens Fishery Conservation and Management Act to add a pandemic as a potential cause of a fishery resource disaster.

Untitled (H.R. 7657)

• Introduced by Kim Schrier (D-WA) on July 16, 2020 (4%)

This bill amends the Water Resources Development Act (WRDA) to include anadromous fish habitat and passage under Section 206 ("Aquatic Ecosystem Restoration"). Specifically, "a project under this section may include measures to improve habitat or passage for anadromous fish, including installing fish bypass structures on small water diversions; modifying tide gates; and restoring or reconnecting floodplains and wetlands that are important for anadromous fish habitat or passage... A project that includes measures under this paragraph shall be formulated to maximize benefits for the anadromous fish species benefitted by the project."

Reported by committee

Regulations from the Executive in Need of Scrutiny (REINS) Act (S. 92)

- Introduced by Rand Paul (R-KY) on January 10, 2019
- Reported by committee June 22, 2020. (4%)

The REINS Act aims at reconfiguring the administrative state by requiring that any regulation passed by an administrative agency would only take effect if agreed upon by both houses of Congress and by the President. This removes Congress' ability to delegate and gives it the Executive branch. This would have a fundamental, long-lasting impact on governance in the United States. It is extremely unlikely to pass the House.

BLUE GLOBE Act (S. 933)

- Introduced by Sheldon Whitehouse (D-RI) on March 28, 2019
- Reported by committee July 22, 2020. (4%)

A bill to improve data collection and monitoring of the Great Lakes, oceans, bays, estuaries, and coasts.

Sport Fish Restoration and Recreational Boating Safety Act (S. 4144)

- Introduced by Roger Wicker (R-MS) on July 1, 2020
- Reported by committee on July 22, 2020 (4%)

A bill to reauthorize the Sport Fish Restoration and Boating Trust Fund, which provides funding for fisheries conservation and management, water and boating infrastructure, and recreational boating safety, among other things.

NOAA Sexual Harassment and Assault Prevention Improvements Act of 2020 (H.R. 6636)

- Introduced by Suzanne Bonamici (D-OR) on April 28, 2020
- Reported by committee on June 29, 2020 (22%)

A bill to amend the National Defense Authorization Act for Fiscal Year 2017 to address sexual harassment involving National Oceanic and Atmospheric Administration personnel.

The bill expands coverage of NOAA's sexual harassment prevention and response policy to include personnel who were not otherwise covered, including commercial fisheries and protected species staff and voting members and executive and administrative staff of regional fishery management councils.

The bill directs NOAA to provide a clear mechanism for anonymous reports of sexual harassment, strengthens advocacy resources for survivors, provides for a secure reporting structure for survivors, expands reports to Congress on sexual harassment, sexual assault, and equal opportunity employment, and improves the ability of NOAA's Office of Law Enforcement to enforce a prohibition on assault, intimidation, and interference with fisheries observers. The bill would remove the stipulation in the Magnuson-Stevens Fishery Conservation and Management Act that these acts must be "forcible" in nature and occur "on a vessel" for NOAA to investigate.

Energy and Water Development and Related Agencies Appropriations Act (H.R. 7613)

- Introduced by Marcy Kaptur (D-OH) on July 15, 2020
- Reported by committee on July 15, 2020 (4%)

This bill makes appropriations for energy and water development and related agencies for the fiscal year ending September 30, 2021. The bill would fund the U.S. Army Corps of Engineers, Dept. of the Interior programs, Dept. of Energy, and other agencies.

The bill focuses on spurring energy innovation to create jobs and reinvigorate the economy while working to mitigate and adapt to climate change, improve the nation's water infrastructure, and strengthen national security. It responds to the coronavirus pandemic by providing an additional \$43.5 billion in emergency spending.

The bill also prohibits funds to restart underground nuclear testing, which has been proposed by the Trump administration.

Passed House or Senate

Driftnet Modernization and Bycatch Reduction Act (S. 906)

- Introduced by Diane Feinstein (D-CA) on March 27, 2019
- Passed Senate June 22, 2020 (4%)

This bill would extend current California state regulations regarding driftnets to all Federal waters within five years. <u>The Council commented on this bill in September 2019</u>.

Coordinated Ocean Observations and Research Act (S. 914)

- Introduced by Roger Wicker (R-MS) on March 27, 2019
- Passed Senate June 30, 2020 (4%)

This bill reauthorizes the Integrated Coastal and Ocean Observation System Act to clarify NOAA's authority with respect to post-storm assessments, and to require the establishment of a National Water Center.

Water Resources Development Act (WRDA) of 2020 (H.R. 7575)

- Introduced by Peter deFazio (D-OR) on July 13, 2020
- Passed House on June 29, 2020 (4%)

This bill authorizes \$8.6 billion for 38 new Army Corps of Engineers construction projects, including flood and storm protection, river and port navigation, and environmental restoration improvements.

The Senate version would authorize \$5.1 billion in Federal funds for 26 Corps of Engineers projects.

The House bill frees the surplus in the Harbor Maintenance Trust Fund, which, according to Transportation and Infrastructure Committee Chairman Peter DeFazio, would allow \$10 billion in Harbor Maintenance Taxes to be used for port dredging projects.

Signed into law

Great American Outdoors Act (H.R. 1957)

- Introduced by John Lewis (D-GA) on March 28, 2019
- Signed into law on August 4, 2020

This bill addresses the maintenance backlog of the National Park Service, the United States Fish and Wildlife Service, the Bureau of Land Management, the Forest Service, and the Bureau of Indian Education, and provides permanent, dedicated funding for the Land and Water Conservation Fund.
