SUBJECT: November 2020 Council Meeting

The Pacific Fishery Management Council (Council) will meet in online format November 9-10, 12-13 & 16-20. The Coastal Pelagic Species Management Team (CPSMT) and the Coastal Pelagic Species Advisory Subpanel (CPSAS) will convene November 16 – 17. Major topics for discussion at this meeting are below. For more detailed information, please refer to the situation summaries in the Briefing Book materials.

Exempted Fishing Permits – Preliminary Review (H.1)

The Council will consider adopting for public review any proposals for exempted fishing permits (EFP), with final approval scheduled for the April 2021 meeting. Advanced Briefing Book materials include two letters of intent from the California Wetfish Producers Association (CWPA) and one from the West Coast Pelagic Conservation Group.

Methodology Review Topic Selection (H.2)

Proposals for new survey or other science-based methodologies must undergo independent review prior to being used in Council stock assessments or other products. For CPS, proponents of new methodologies bring their proposal to the November Council meeting for consideration. While there are no proposals for methodology reviews, there are two items in the advance November Briefing Book materials that should be considered by the CPSAS and CPSMT.

Comments on Court Ordered Rulemaking on Harvest Specifications for the Central Subpopulation of Northern Anchovy (H.3)

The United States District Court for Northern California issued an order for the National Marine Fisheries Service (NMFS) to promulgate a rule for management reference points for the central subpopulation of northern anchovy (CSNA). If the proposed rule is published in time, the CPSMT and CPSAS should review and be prepared to comment.

Standardized Bycatch Reporting Methodology (C.3)

NMFS issued a final rule to implement a provision of the Magnuson-Stevens Fishery Conservation and Management Act (Agenda Item C.3, Attachment 1). This provision requires that all fishery

management plans (FMPs) establish a standardized reporting methodology to assess the amount and type of bycatch occurring in a fishery. The Council and its Advisory Bodies are to determine whether FMP provisions are consistent with the final rule.

Elections

The CPSAS and CPSMT will hold elections for calendar year 2021.

SUBJECT: November 2020 Council Meeting Materials

The Pacific Fishery Management Council (Council) and its advisory bodies will meet via webinar November 9-10, 12-13 & 16-20, 2020. The Groundfish Management Team (GMT) and the Groundfish Advisory Subpanel (GAP) will convene their sessions starting Thursday, November 12 at 8:00 A.M. and adjourn on Wednesday, November 18. All meetings are open to the public. For advisory bodies, there will be a once-daily opportunity for public comment scheduled on their agendas.

Instructions for how to connect to advisory body webinars will be posted on the Council's November 2020 Meeting webpage prior to the first day of the meeting. It is recommended that you use a computer headset to listen to the meeting, but you may use your telephone for the audio-only portion of the meeting. The audio portion may be attended using a telephone by following the connect to audio instructions on your screen, shown after joining the webinar. Please remember to enter your full name (including your Agency acronym if appropriate) when prompted on the webinar entry screen. This additional information helps Council identify speakers in the webinar.

The Council is scheduled to consider several important groundfish agenda items and related matters of interest. The briefing book materials attached to this memorandum provide detailed information for these items on the Council's November agenda; however, the following agenda items, summarized below, may be of particular interest.

E.2 Transition of Area 2A Fishery Management – Final Action

At its March 2020 meeting, the Council discussed the <u>report</u> provided by the Project Team, and adopted the range of alternatives provided with suggested edits. In September 2020, the Project Team's report to the Council included an updated range of alternatives. Based on that report the Council adopted preliminary preferred alternatives for public review. Attachment 1 under this agenda item provides the updated range of alternatives. The Council is scheduled to take final action and select its final preferred alternatives.

E.3 Non-Indian Commercial-Directed Fishery Regulations for 2021

Groundfish fishery management does not encompass managing Pacific halibut; however, many participants involved in groundfish fishery management have expressed interest in this agenda item. At their September meeting, the Council adopted options for the 2021 Area 2A non-Indian commercial-directed halibut fishery season. Stakeholders have the opportunity to provide input on these options under this agenda item. Additionally, the National Marine Fisheries Service (NMFS) and the Council have been notified of higher-than-expected yelloweye rockfish bycatch in this fishery this year. A report from NMFS is provided regarding available information on the incidental catch of yelloweye rockfish in this directed fishery.

G.1 Gear Switching for Sablefish in the Trawl Catch Share Fishery

The Council adopted a statement of <u>purpose and need</u> at the September meeting for sablefish gear switching. At this meeting, the Council will consider adopting a range of alternatives for further analysis. In September, the Council reviewed three potential alternatives, which are described in detail in <u>Agenda Item D.1</u>, <u>Attachment 1</u>, <u>September 2020</u>. The Council may adopt the alternatives as described, but may modify the alternatives or incorporate new options as appropriate.

G.2 National Marine Fisheries Service Report

Under this agenda item, NMFS will provide an overview of current rulemaking, a timeline for action items, and present information on cost recovery. While no Council action is scheduled under this agenda item, stakeholders will have the opportunity to provide feedback to the Council and NMFS. Additionally, the Northwest Fishery Science Center has provided their annual reports on salmon and seabird bycatch.

G.3 Inseason Adjustments for 2020 and 2021 Including Pacific Whiting Set - Asides for 2021 – Final Action

This agenda item will consider progress to date of the groundfish fisheries as well as routine inseason adjustments to the 2020 fisheries, as necessary, to achieve conservation objectives. In addition, it's expected that the recent high catch of yelloweye rockfish in the non-Indian commercial-directed halibut fishery will be accounted for and the Council will look for opportunities to balance the catch for 2020 and the expected catch in 2021 to ensure that the annual catch limit for yelloweye rockfish is not exceeded. The Council is also scheduled to adopt yield set-asides to accommodate the incidental mortality of Pacific whiting in 2021 research activities and in the pink shrimp fishery.

G.4 Sablefish Management Strategy Evaluation Update

The Council will be given an update on the sablefish management strategy evaluation (MSE) process framework and the development of an operational model. As part of the MSE, the Council may consider modifying the scope of the MSE to include additional inputs that evaluate socioeconomic ramifications to the fishery due to changing ecosystem conditions and/or other management strategies. The MSE development team is requesting feedback on the MSE operational model and how the West Coast would like to provide feedback to the team on identification of management objectives, alternative management strategies, and performance metrics for the MSE.

C.3 Standardized Bycatch Reporting Methodology

The Council is scheduled to review each fishery management plan (FMP) per requirements of the Magnuson-Stevens Act. NOAA fisheries filed a final rule that requires all FMPs to establish a standardized bycatch reporting methodology (SBRM) to assess the amount and extent of bycatch

in the fishery. Advisory bodies are invited to review the groundfish FMP to determine if it meets the criteria of the SBRM. Recommendations from the GAP and the GMT will assist the Council in this endeavor and help to determine if an FMP amendment is needed to meet the SBRM requirements.

SUBJECT: November 2020 Council Meeting

The Pacific Fishery Management Council (Council) will meet November 9-10, 12-13 & 16-20 by webinar. The Highly Migratory Species Advisory Subpanel (HMSAS) and the Highly Migratory Species Management Team (HMSMT) will meet Thursday, Friday, and Monday, November 12, 13, and 16. Instructions for how to connect to advisory body webinars will be posted on the Council's November 2020 Meeting webpage prior to the first day of the meeting. Summaries of the four HMS topics and one Administrative item on the Council agenda follow.

I.1 National Marine Fisheries Service Report

National Marine Fisheries Service (NMFS) will brief the Council on recent regulatory activities and international meetings.

I.2 Recommend International Management Activities

The situation summary reports on recent meetings of the Inter-American Tropical Tuna Commission (IATTC)/Western and Central Pacific Fisheries Commission (WCPFC) Joint Working Group on Pacific Bluefin Tuna Management, WCPFC Northern Committee, and the Permanent Advisory Committee to Advise the U.S. Commissioners to the Western and Central Pacific Fisheries Commission (WCPFC PAC). The Seventeenth Regular Session of the WCPFC (WCPFC17), is scheduled to occur online December 8-15, 2020. WCPFC PAC recommendations are included as Attachment 3. These can be used as a resource for the development of any Council recommendations to the U.S. delegation.

The IATTC Chair has proposed November 30-December 4 as the dates for the annual Commission meeting. The Council may wish to advise on the adoption of a new IATTC resolution to succeed Resolution C-18-01 (Measures for the Conservation and Management of Pacific Bluefin Tuna in the Eastern Pacific Ocean, 2019 and 2020). A draft U.S. proposal is available in Attachment 1, Annex E. Discussion of the measure could also address domestic implementation as suggested by

the HMSAS in September. Another high priority issue for West Coast fisheries is the adoption of bigeye tuna commercial catch limit as part of a new tropical tuna measure.

I.3 Biennial Harvest Specifications and Management Measures

In even-numbered years the Council may review and comment on status determination criteria established by NMFS for the species managed under the HMS Fishery Management Plan (FMP). Attachment 1 is an updated draft of the stock status section of the HMS Stock Assessment and Fishery Evaluation document including estimates of management reference points and, if available, status determinations made by NMFS. Determinations are pending for three stocks: Pacific bluefin tuna, Eastern Pacific bigeye tuna, and Eastern Pacific yellowfin tuna. For the latter two stocks, NMFS has been waiting for the IATTC Scientific Advisory Committee to meet to review new benchmark assessments.

I.4 Drift Gillnet Fishery Hard Caps

As reported at the March 2020 Council meeting, a final rule implementing a 2015 Council decision to implement protected species hard caps for the California/Oregon thresher shark/swordfish large mesh drift gillnet (DGN) fishery came into force early this year. Per a Council request, at this meeting NMFS will report on comments received on the final rule implementing hard caps, the details of the economic analysis that was the basis for withdrawing the proposed rule, and a range of viable measures the Council could consider in a future rulemaking process.

C.3 Standardized Bycatch Reporting Methodology

In 2017 NMFS issued regulations specifying the requirement of the Magnuson-Stevens Fishery Conservation and Management Act (MSA) that all fishery management plans (FMPs), with respect to any fishery, establish a standardized reporting methodology to assess the amount and type of bycatch occurring in a fishery. (These guidelines may be found in the Code of Federal Regulations at Title 50, Part 600, Subpart R.) FMPs must be consistent with these regulations by February 21, 2022 (50 CFR 600.1610(b)). At this meeting, the Council will review its four FMPs for consistency with the final rule and discuss next steps. Mr. Brett Wiedoff, Council Staff, will brief the HMSAS and HMSMT on this review process.

With Council meetings being conducted online, the number of agenda items at each meeting has been limited. Keeping this in mind, you may wish to provide comments on scheduling HMS topics at future Council meetings under Agenda Item C.8, Future Council Meeting Agenda and Workload Planning.

In addition to the enclosed briefing materials, you may obtain electronic copies of all the meeting materials on our website. We also post supplemental briefing materials on our website as they become available after distribution of the advance briefing book. Public comment is available only in electronic form through the Council's <u>e-portal</u>. Visit the <u>November 2020 Meeting webpage</u> to access these materials.

SUBJECT: November 2020 Council Meeting

The Pacific Fishery Management Council (Council) and its advisory bodies will meet via webinar November 9-10, 12-13 & 16-20 2020. The Council and its Advisory Bodies will not be holding meetings Wednesday, November 11 or the weekend of Saturday, November 14 and Sunday, November 15.

Instructions for how to connect to the Council meeting and Advisory Body webinars will be posted on the Council's <u>November 2020 Meeting webpage</u> prior to the first day of the meeting.

The Salmon Advisory Subpanel (SAS) and the Salmon Technical Team (STT) will meet in conjunction with the November 2020 Council meeting. The Model Evaluation Workgroup (MEW), the Ad Hoc Southern Resident Killer Whale Workgroup (SRKW Workgroup), and the Ad Hoc Southern Oregon/Northern California Coast Coho Workgroup (SONCC Coho Workgroup) will not meet during the Council meeting. However, all advisory members are welcome to attend the online SAS meeting (Monday and Tuesday, November 9-10), or the STT meeting (Monday, November 9) to discuss topics of interest on the Council agenda. In addition, a representative from the SRKW Workgroup and a representative from the SONCC Coho Workgroup will participate in the November Council meeting to provide a statement on their respective topic.

The Council will cover the salmon agenda items on Monday, November 16. Three salmon topics will be discussed by the Council. The first topic (Agenda Item F.1) will be the 2021 Preseason Management schedule. The second topic (Agenda Item F.2) covers the SRKW Endangered Species Act consultation process. The Council is scheduled to adopt final preferred alternatives from the range of alternatives adopted for public review at the September 2020 Council meeting. The last salmon topic (Agenda Item F.3) will focus on the SONCC Endangered Species Act consultation process. The SONCC Coho Workgroup will update the Council on its progress on the risk assessment and development of a range of alternatives.

There are also three topics addressing Pacific halibut fishery management on the November Council agenda. Two topics will be covered on Friday November 13. Under Agenda Item E.1, the Council will adopt the final changes to the 2021 Halibut Catch Sharing Plan and annual regulations. Proposed

changes were adopted for public review at the September 2020 Council meeting. Agenda Item E.2 will cover the transition of Area 2A fishery management. The Council adopted preliminary preferred alternatives for public review at the September 2020 Council meeting and is scheduled to adopt final preferred alternatives at this November meeting. On Monday November 16, under Agenda Item E.3, the Council will adopt final changes for the 2021 non-Indian commercial directed fishery regulations for recommendation to the International Pacific Halibut Commission. Proposed changes for this fishery were adopted for public review at the September 2020 Council meeting.

Current Habitat Issues (Agenda Item D.1) is scheduled for Friday November 13. In addition, there are multiple Administrative Matters of interest on the Council's agenda scheduled. On Friday, November 13, the Council Coordination Committee will provide a report under Agenda Item C.1, and under Agenda Item C.2, National Marine Fisheries Service (NMFS) will provide a report on West Coast Region priorities, and other topics. On Thursday, November 19, under Agenda Item C.3, the Council will discuss Standardized Bycatch Reporting Methodology (SBRM) and review all the Fishery Management Plans for consistency with the final rule from NMFS. SBRM will be of particular interest to the STT. The Council will also discuss Legislative Matters (Agenda Item C.4.) and Fiscal Matters (C.5). On Friday November 20, Future Council meeting agendas and workload planning will be discussed under Agenda Item C.8.

Also, under Informational Reports, the STT will submit an inseason harvest report for the ocean salmon fisheries. Look for this report once the Council meeting is underway.

The Pacific Fishery Management Council (Council) and its advisory bodies will meet November 9-10, 12-13, 16-20, 2020 via webinar. The Scientific and Statistical Committee (SSC) will meet on Thursday, November 12 and Friday, November 13, starting at 8 a.m. each day. Your meeting materials are enclosed.

Instructions for how to connect to Advisory Body webinars will be posted on the Council's November 2020 Meeting webpage prior to the first day of the meeting. It is recommended that you use a computer headset to listen to the meeting, but you may use your telephone for the audio-only portion of the meeting.

Council Administrative Matters

The SSC will review the nominations of Ms. Gretchen Hanshew and Mr. Daniel Studt, National Marine Fisheries Service West Coast Region (NMFS WCR), to fill the NMFS WCR seats on the Groundfish Management Team (GMT) vacated by Ms. Abigail Harley and Ms. Karen Palmigiano. The SSC will also review the nomination of Dr. Chantel Wetzel, NMFS Northwest Fisheries Science Center (NMFS NWFSC), to fill the vacant NMFS NWFSC seat on the GMT.

The SSC will discuss future workload planning and will report to the Council on their plans under Agenda Item C.8.

The SSC will begin discussion with Dr. Jim Hastie and Dr. Sarah Shoffler, NMFS Southwest and Northwest Fisheries Science Centers, respectively on developing a regional policy/plan for deciding best scientific information available (BSIA). This policy is anticipated to be considered by the Council next year in advance of a 2022 deadline to develop a policy.

The SSC will continue planning and development of a new Research and Data Needs database.

Groundfish Management

Agenda Item G.1 – Gear Switching for Sablefish in the Trawl Catch Share Fishery: Under Future Meeting Planning, the SSC will discuss a proposed analysis of gear switching behavior (see Section 3 in Agenda Item G.1, Attachment 3). Council staff may recommend the Council task the SSC Economics Subcommittee to review the methodology for this analysis before the March 2021 Council meeting.

The SSC will be briefed on a management strategy evaluation (MSE) framework for Northeast Pacific sablefish by Dr. Melissa Haltuch, NMFS NWFSC. The SSC will also be briefed on the spatial operating model under development for use in the MSE by Ms. Maia Kapur, University of Washington, and will offer critical comment on the model. The SSC will provide their recommendations on the operating model as well as the scope of the MSE.

The SSC will be briefed on the October 23 SSC Groundfish Subcommittee meeting second review of proposed length-based assessment methods and their recommendations on future use of these methods for stock assessment. The SSC will recommend any of these new methodologies they endorse for informing future groundfish stock assessments and will also recommend language for the Terms of Reference (TOR) for the Groundfish and Coastal Pelagic Species Stock Assessment Process for 2021 and 2022 pending an endorsement of new length-based assessment methods.

Coastal Pelagic Species Management

The SSC will review any new exempted fishing permits proposed for 2021.

The SSC will review any new coastal pelagic species methodology proposals to inform future coastal pelagic species assessment proposed for a formal review next year.

The SSC will be briefed on the court-ordered rulemaking on harvest specifications for the Central Subpopulation of Northern Anchovy and may offer comments to the Council on how to achieve compliance.

Highly Migratory Species Management

The SSC will be briefed on considerations for a NMFS BSIA determination for deciding bigeye and yellowfin tuna harvest specifications. New assessments for these species are structured in a probabilistic framework and NMFS is seeking guidance on how to use the framework for determining BSIA.
