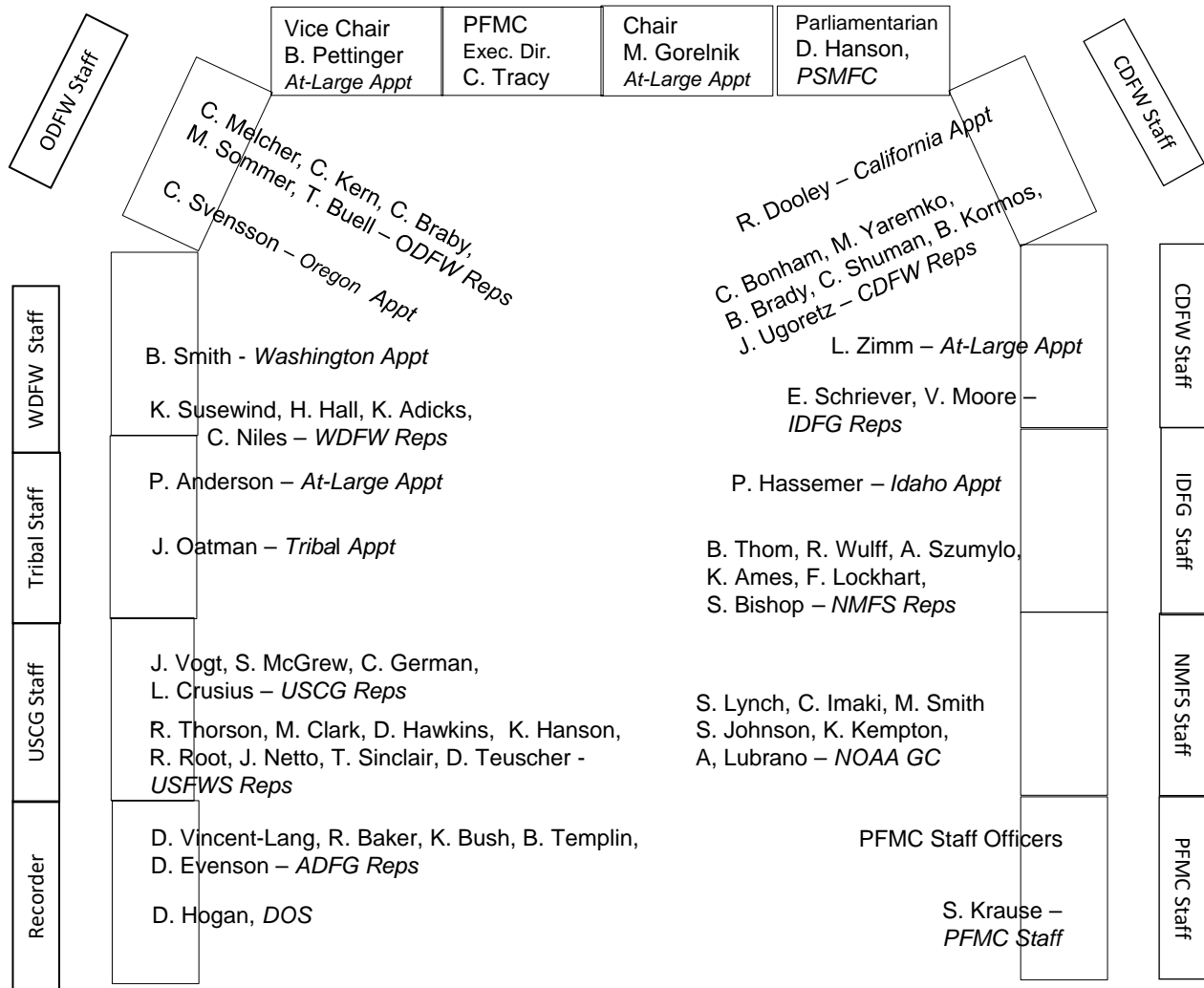


PACIFIC COUNCIL SEATING DIAGRAM
