# Non-Trawl Rockfish Conservation Area

## Origins

- a) Non-trawl area closures began in 2002
- b) Goal to minimize overfished groundfish catch/aid in rebuilding

## Area and Management

- a) Contiguous area closure & bounded by depth
- b) Fishing for groundfish with non-trawl gear is prohibited

## Current Groundfish Status

- a) All overfished groundfish are rebuilt except yelloweye rockfish
- b) Multiple non-trawl shelf species allocations under-attained


# Recent Council Decision Points

## 2021-2022 Biennial Groundfish Management Measures

- a) Multiple boundary adjustments in CA/OR
- b) Specific gear restrictions in one re-opened area depth-bin
- c) Recommended multiple EFPs to test gear
- d) Changes to salmon troll yellowtail rockfish retention



# Process to Date



# Area Management Proposal Categories

## 1. Boundary Adjustments

- a) Modification of non-trawl rockfish conservation area (NT-RCA) shoreward/seaward boundaries

## 2. Gear Allowances

- a) Authorizing use of specific hook & line gear in NT-RCA (e.g., Emley-Platt EFP)

## 3. Incidental Groundfish Catch Retention

- a) Retention of 'midwater' rockfish by salmon troll fishery while fishing in NT-RCA

## Area Management Proposals

- a) Has the Non-trawl RCA achieved its intended goals and objectives?
- b) What are the benefits/concerns of the proposals?
- c) Do proposals need to be revised?

## Fishery Concerns

- a) Are existing mitigation/monitoring methods sufficient?
- b) Do proposals promote fairness and/or equity amongst participants?
