NATIONAL MARINE FISHERIES SERVICE (NMFS) REPORT ON EXEMPTED FISHING PERMIT PRELIMINARY RECOMMENDATIONS

Deep-Set Buoy Gear (DSBG) Exempted Fishing Permit (EFP) Update

National Marine Fisheries Service (NMFS) has authorized 28 standard deep-set buoy gear (DSBG) and 12 linked DSBG vessels to fish in 2021. The current DSBG exempted fishing permits (EFPs), listed below, and their current Endangered Species Act (ESA) coverage, are set to expire December 31, 2021. The Council could recommend that NMFS extend them into 2022/2023 prior to final DSBG authorization and implementation.



DSBG EFP effort in 2020 was higher than in any season to date, with an average swordfish catch of 1.4 fish per day. Over 98 percent of the effort is attributed to standard buoy gear, with only 14 days of effort attributed to linked buoy gear. Catch composition was similar to previous years, with

two new species reported caught (new species included two oilfish and one yellowfin tuna). The majority of non-target species consisted of bigeye thresher sharks, similar to previous years. A relatively higher amount of "unidentified" shark catch than in past years may be due to decreased observer coverage and an increased reliance on logbooks for catch reporting (i.e., if bigeye thresher sharks are recorded as "thresher shark" in fisherman's logbooks, they appear as "Unidentified Thresher Shark" in the integrated database). No protected species interactions were observed or reported in logbooks in 2020.

Night-Set Buoy Gear (NSBG) EFP Update

A single vessel is currently authorized to fish in 2021 with NSBG. This NSBG EFP and its ESA coverage are also expiring on December 31, 2021, and the Council could recommend that NMFS extend it into 2022/2023. One vessel fished under the NSBG EFP in 2020, and the EFP holder's 2020 activity report can be found in the Council's Briefing Book.

Deep-Set Short Line (DSSL) EFP

No activity has occurred under the DSSL EFP to date since it was issued in January 2020. The DSSL EFP and its ESA coverage are expiring on December 31, 2021, and the Council could recommend that NMFS extend it for another 2-year period.

Shallow-set and Deep-set Longline (SSLL/DSLL) EFP

NMFS continues to draft an analysis, pursuant to the National Environmental Policy Act (NEPA), to evaluate potential impacts of the proposed action to issue an EFP to fish with SSLL and DSLL gear inside the U.S. West Coast EEZ south of the Oregon-Washington border. Once the draft NEPA analysis is completed, NMFS will initiate consultation on the proposed action under the ESA. NMFS will complete consultation prior to finalizing the NEPA analysis and issuing the EFP.
