## ENDANGERED SPECIES WORKGROUP REPORT

The Groundfish Endangered Species Workgroup (Workgroup) was established in June 2013 to serve as an advisory body to the Pacific Fishery Management Council (Council) with the objective to support Endangered Species Act (ESA) Section 7(a)(2) compliance in the <u>Biological Opinions</u> (BiOps) for the continued operation of the Pacific Coast groundfish fishery. Workgroup meetings are generally timed so that their recommendations that would need to be addressed by adoption or adjustment of management measures can be considered as part of the groundfish biennial harvest specifications and management measures process.

The Workgroup met from April 26 - 28, 2021 and reviewed reports detailing the most recent incidental take estimates for eulachon, green sturgeon, humpback whales, leatherback sea turtles, and short-tailed albatross in the groundfish fishery. The Workgroup, in part, considered whether incidental take was exceeded and if new information reveals effects not previously considered in the BiOp. Under its <u>Terms of Reference</u>, the Workgroup may recommend the Council consider new conservation and management measures to minimize bycatch of the aforementioned ESA listed species. The Workgroup chair is expected to present the findings from the Workgroup's report (Agenda Item G.4.a, NMFS Report 1) at this meeting.

The Council has the opportunity under this agenda item to address conservation concerns raised in the reports and consider measures to minimize bycatch of the aforementioned species The Council may also recommend new analyses, reports, or changes to sampling protocols to improve bycatch estimates of these ESA listed species as well. New management measures that the Council identifies at this meeting could be evaluated as part of the 2023-2024 harvest specifications and management measures process, if appropriate.

The specific reports for the ESA listed species noted above (Agenda Item G.4.a, NMFS Reports 2-6) and a groundfish fishery effort report with an accompanying data file (Agenda Item G.4.a, NMFS Reports 7 & 8) are provided as Council reference material for this agenda item. Additionally, the Northwest Fishery Science Center has developed an informational report that summarizes the findings of these reports (Agenda Item G.4.a., NMFS Report 1, June 2021).
