Catch Only Projection for Canary Rockfish (Sebastes pinniger) in 2021

This document provides the third catch-only projection of the 2015 assessment of canary rockfish (Sebastes pinniger), with updated catch data through 2020. Updated total catches for each fleet for years 2015 – 2019 were derived from Groundfish Expanded Multi-year Mortality (GEMM) report. During updating and issue was identified in the 2019 catch-only update where the input removals between 2016 – 2018 did not match the actual removals from the population in the model. This issue was corrected in this year's catch-only update while also updating the removals between 2015 - 2019. Estimated 2020 removals and the projected removals for 2021 and 2022 were provided by the Groundfish Management Team (GMT). For years 2023 and beyond, ABC catches were assumed. In the projections, the split of catches among fleets was based upon the split in 2022, which differed from that used in the previous projection. Scientific time-varying uncertainty buffers are based upon the number of years since the last assessment, conducted in 2015, using a Category-1 sigma = 1.0 and a of $P^* = 0.45$. The time-varying buffers, along with updated removals (2015-2022), Overfishing Limits (OFLs), Acceptable Biological Catches (ABCs), summary biomass 5+, spawning output (SSB), and the fraction unfished are given in Table 1. A comparison between the removals, OFLs, ABCs, and fraction unfished from the 2019 and 2021 catch-only updates are provided in Table 2.
