- SUBJECT: November 2021 Council Meeting

The Pacific Fishery Management Council (Council) will meet in an online format November 16 – 22, 2021, with no meetings scheduled on Saturday, November 20. The Coastal Pelagic Species Management Team (CPSMT) and the Coastal Pelagic Species Advisory Subpanel (CPSAS) will convene November 16 - 18 and the Council will consider CPS agenda items on November 19. Major topics for discussion at this meeting are below. For more detailed information, please refer to the situation summaries in the Briefing Book materials.

Instructions for how to connect to Advisory Body webinars will be posted on the Council's <u>November 2021 Meeting</u> webpage prior to the first day of the meeting. Upon entering the meeting, please modify your entry on the participant list to reflect your full identification (full name and affiliation). This additional information helps participants identify speakers in the webinar.

Preliminary Review of New Exempted Fishing Permits for 2022 (I.1)

The Council will consider adopting for public review any proposals for exempted fishing permits (EFP), with final approval scheduled for the April 2022 meeting. The California Wetfish Producers Association in collaboration with the California Department of Fish and Wildlife submitted two letters of intent and copies of the prior year proposals. The West Coast Pelagic Conservation Group in collaboration with the Washington Department of Fish and Wildlife submitted a letter of intent and a copy of the prior year's proposal. All three are included in Advanced Briefing Book materials.

Fishery Management Plan Management Categories (I.2)

Beginning in late 2018, the Council has considered a process to remove the management category designations in the CPS Fishery Management Plan (FMP), and instead describe the management of each stock individually rather than through use of categorical assignments. Specifically, the intent was to remove references to the named management categories, but not to revise the manner

in which the CPS stocks are managed. Proposed FMP text revisions are included in advanced Briefing Book materials (Agenda Item I.2.a, CPSMT Report 1). The CPSMT and CPSAS should review the proposed FMP text and provide advice to the Council as appropriate.

Marine Planning (C.2)

The Council's Ad Hoc Marine Planning Committee (MPC) is scheduled to meet November 10, 2021 and will provide a supplemental report for Council and advisory body (AB) consideration. There will be updates on National Oceanic and Atmospheric Administration (NOAA) Aquaculture Opportunity Areas, the United States Coast Guard Port Access Route Study, offshore wind planning activities, and other marine planning-related items.

Legislative Matters (C.6)

This is a regular agenda item at all Council meetings. The CPS ABs should assign a member to read the agenda materials and be prepared to discuss with the AB members. There is no current request for Council comments on legislation, so this is likely to remain a mostly informational agenda item.

Standardized Bycatch Reporting Methodology (SBRM) – Final Action (C.8)

At the September 2021 meeting, the Council and its ABs considered proposed language for incorporation into FMPs, documenting approaches to monitoring and reporting bycatch. At this meeting the Council and ABs will consider final language for incorporation into the CPS and other FMPs.

Membership Appointments and Council Operating Procedures (C.9)

At its June 2021 meeting, the Council considered the central subpopulation of northern anchovy (CSNA) management framework and flowchart and directed the CPSMT to develop draft language that would be incorporated into Council Operating Procedure 9 Schedule 3. The CSNA framework would apply certain triggers and mechanisms to inform determinations on when the CSNA stock should be assessed and whether harvest management measures should be revised. These revisions could be based on a new stock assessment, on fishery attainment, or on changes in the biomass estimate. The proposed text is included in Agenda Item C.9.a, CPSMT Report 1.

- SUBJECT: November 2021 Council Meeting Materials

The Pacific Fishery Management Council (Council) and its advisory bodies will meet via webinar November 15-19 & 21-22, 2021. The Groundfish Management Team (GMT) and the Groundfish Advisory Subpanel (GAP) will convene their sessions starting Monday, November 15, 2021 at 8:00 a.m. and adjourn on Sunday, November 21, 2021. All meetings are open to the public. Advisory bodies will have once-daily opportunity for public comment scheduled on their agendas. Instructions for how to connect to advisory body webinars will be posted on the Council's November 2021 meeting webpage prior to the first day of the meeting.

The Council is scheduled to consider several important groundfish agenda items and related matters of interest. The following summarizes agenda items that may be of particular interest. The briefing book materials attached to this memorandum provide detailed information for these items on the Council's November 2021 agenda. Briefing materials for this meeting can also be accessed from the <u>November 2021 meeting page</u>.

C.2 Marine Planning

The Council is scheduled to hear from the Ad Hoc Marine Planning Committee and consider topics relevant to aquaculture or offshore wind energy planning and development as appropriate, which may include NOAA Aquaculture Opportunity Areas and the United States Coast Guard's Port Access Route Study.

C.4 Preliminary West Coast Regional Framework for Determining the Best Scientific Information Available

The Council is required to base decisions on the best scientific information available (BSIA). National Marine Fisheries Service West Coast Region and science centers have been working with the Pacific Council's Scientific and Statistical Committee (SSC) to develop a draft West Coast BSIA regional framework per National Marine Fisheries Service policy directive <u>01-101-10</u>. This agenda item provides opportunity for stakeholders to provide advice towards the development of this framework.

C.8 Standardized Bycatch Reporting Methodology – Final Action

The Council is scheduled to finish its consistency review for <u>Standardized Bycatch Reporting</u> <u>Methodology</u> (SBRM) for each of its fishery management plans (FMPs) at this meeting and to identify any potential FMP amendments to bring FMPs into compliance with the final rule.

E.2 Adopt Stock Assessments

The Scientific and Statistical Committee (SSC) will review results from the September 29 & 30 "mop-up" meeting regarding the copper rockfish, quillback rockfish, and spiny dogfish assessments. The SSC is expected to make recommendations to the Council regarding these assessments for the 2023-2024 biennial management cycle. The Council is scheduled to adopt assessments and rebuilding analyses, as appropriate.

E.3 Harvest Specifications for 2023-2024 Including Final Overfishing Limits and Acceptable Biological Catches

The Council is scheduled to adopt final harvest specifications for overfishing limits, sigma values, stock categories, acceptable biological catches, and a preliminary range of annual catch limits to be analyzed if the Council wishes to depart from the default harvest control rules for the 2023-2024 biennium. Additionally, the Council will consider adopting its preferred preliminary alternatives for annual catch limits of groundfish stocks.

E.4 Preliminary Exempted Fishing Permit Approval for 2023-2024

At this meeting, the Council is scheduled to identify exempted fishing permit proposals for additional consideration and public review. Under this agenda item, applicants are expected to present their preliminary proposals to the Council for consideration in the 2023-2024 biennium.

E.5 Biennial Management Measures for 2023-2024

The Council will consider adopting a range of alternatives for management measures necessary to implement the harvest specifications for the next biennium, as well as adopt preliminary two-year allocations for applicable species.

E.6 Non-Trawl Sector Area Management Measures

The Council has the opportunity to adopt at Range of Alternatives, as well as select preliminary preferred alternatives, for changes regarding management of the Non-Trawl Rockfish Conservation Area (NT_RCA). Potential modifications to NT_RCA management measures include allowing groundfish limited entry and open access non-trawl commercial fixed gear fisheries to operate within the NT_RCA and revising NT_RCA boundaries.

E.7 Inseason Adjustments Including Pacific Whiting Set-Asides for 2022 – Final Action

The Council will consider progress to date of the groundfish fisheries as well as routine inseason adjustments to the 2021 fisheries, as necessary, to achieve conservation objectives under this agenda items. Stakeholders may request changes to current inseason management under this agenda item.

G.1 Commercial-Directed Fishery Regulations for 2022 – Final Action

As part of the International Pacific Halibut Commission/PFMC Area 2A management process, the Council seeks stakeholder input regarding regulation changes for the Area 2A Non-Indian Directed Pacific Halibut Fishery at this meeting. The Council will finalize their recommendations at this meeting and forward them to the International Pacific Halibut Commission.

G.2 2022 Catch Sharing Plan and Annual Regulations – Final Action

At this meeting, the Council is scheduled to develop recommendations for changes to the Catch Sharing Plan and annual regulations for Area 2A. This agenda item is the opportunity for stakeholders to provide input regarding potential options under consideration by the Council.

Other Items

SUBJECT: November 2021 Council Meeting

The Pacific Fishery Management Council (Council) will meet November 15-19 and 21-22 by webinar. The Highly Migratory Species Advisory Subpanel (HMSAS) and the Highly Migratory Species Management Team (HMSMT) will meet Monday through Thursday, November 15-18. HMS topics are on the Council agenda on Thursday, November 18. Instructions for how to connect to advisory body webinars will be posted on the Council's <u>November 2021 Meeting webpage</u> prior to the first day of the meeting. Upon entering the meeting, please modify your entry on the participant list to reflect your full identification (full name and affiliation). This additional information helps participants identify speakers in the webinar. Summaries of three HMS topics and other items of interest on the Council agenda are listed below.

H.1 National Marine Fisheries Service Report

National Marine Fisheries Service will brief the Council on recent regulatory activities.

H.2 International Management Activities

Three meetings related to international HMS management that occurred between the September and November Council meetings are summarized in the situation summary. This agenda item will be an opportunity for the Council to get briefed on salient issues and consider recommendations to the U.S. delegation to the 18th Regular Session of the Western and Central Pacific Fisheries Commission, occurring in December.

H.3 Drift Gillnet Hard Caps – Range of Alternatives

The Council adopted a preliminary range of alternatives for this action at its June 2021 meeting and directed the HMSMT to flesh out the alternatives, particularly with options for closure periods of varying lengths. The HMSMT submitted a report for the advanced briefing book with these options and a preliminary analysis to help the Council in adopting a refined range of alternatives and, if appropriate, identify a preliminary preferred alternative.

C.8 Standardized Bycatch Reporting Methodology – Final Action

The Council is scheduled to take final action to adopt amendment language for its fishery management plans (FMPs) to address the requirement that FMPs establish a standardized bycatch reporting methodology (SBRM) and identify the required procedure or procedures that constitute the SBRM (<u>50 CFR 600 subpart R</u>). Agenda Item C.8, Attachment 1, contains proposed amended text for Council FMPs including the HMS FMP. The HMSMT and HMSAS may wish to comment on, and propose revisions to, the draft text.

In addition to the previous topics, the Council will consider marine planning issues under Agenda Item C.2. The Ad Hoc Marine Planning Committee (MPC) is scheduled to meet on November 10 to develop recommendations for the Council on marine planning topics including designation of Aquaculture Opportunity Areas and the United States Coast Guard's Port Access Route Study. Mike Conroy, HMSAS representative on the MPC, will brief the HMSAS, and interested members of the HMSMT, on MPC deliberations and recommendations.

In addition to the previous topics, you may wish to provide comments on scheduling HMS topics at future Council meetings under Agenda Item C.10, Future Council Meeting Agenda and Workload Planning.

In addition to the enclosed briefing materials, you may obtain electronic copies of all the meeting materials on our website. We also post supplemental briefing materials on our website as they become available after distribution of the advance briefing book. Public comment is available only in electronic form through the Council's <u>e-portal</u>. Visit the <u>November 2021 Meeting webpage</u> to access these materials.

SUBJECT: November 2021 Council Meeting

In conjunction with the November Pacific Fishery Management Council (Council) meeting, the Salmon Technical Team (STT) and the Salmon Advisory Subpanel (SAS) will meet online on Monday and Tuesday, November 15-16; meetings will start at 8:00 a.m. The Model Evaluation Workgroup (MEW) is not scheduled to meet; however, the Chair of the MEW will attend to update the Scientific and Statistical Committee (November 15). The Ad-Hoc Southern Oregon/Northern California Coast Coho (SONCC) Workgroup is not scheduled to meet; however, the Chair of the SONCC Workgroup will attend to brief the SAS (November 15) and to present a report to the Council (November 17).

The November 2021 Council meeting will be held via webinar and will be in session Tuesday through Friday (November 16-19), and Sunday through Monday (November 21-22). No meetings are scheduled for Saturday (November 20). The Council Agenda for the November meeting has three salmon topics and a variety of other topics of interest scheduled.

Instructions for how to connect to Advisory Body webinars will be posted on the Council's <u>November 2021 Meeting webpage</u> prior to the first day of the meeting. Upon entering the meeting, please modify your entry on the participant list to reflect your full identification (full name and affiliation). This additional information helps participants identify speakers in the webinar.

On Tuesday, November 16 the Council will discuss pertinent Habitat Issues under Agenda Item D.1. Look for briefing materials in the packet and familiarize yourself with the topics at hand.

On Wednesday, November 17 the Council will cover three topics: Salmon, Pacific Halibut, and Marine Planning. Under salmon Agenda Item F.1, Salmon Methodology Review the Council will hear reports from the SSC and STT on the four topics identified for review at the <u>September 2021</u> Council meeting. Next, the Council will consider the preseason salmon management schedule for the 2022 season (Agenda Item F.2). Under Agenda Item F.3, the SONCC Workgroup will provide an updated Risk Assessment and a Range of Alternatives (ROA) for harvest control rules based on

<u>guidance</u> provided by the Council in September 2021, and the Council may adopt a final preferred alternative for a SONCC harvest control rule.

Pacific Halibut has two agenda items for Council consideration. Consistent with Council Operating Procedure (COP) 9, the Council considers changes to the Pacific Halibut Catch Sharing Plan (CSP) and annual regulations in September and November of every year. The Council also considers changes to the annual regulations for the commercial directed halibut fishery under the same schedule. Recommendations for change are adopted at the September meeting for public review, and final recommendations are adopted at the November Council meeting. For 2022, Agenda Item G.1 will cover changes to the commercial directed fishery regulations and Agenda Item G.2 will cover changes to the CSP. Recommendations adopted in September for public review are found in the <u>September 2021 Decision Document</u>. The Council will wrap -up the day with Marine Planning (Agenda Item C.2). Please be sure to read the Marine Planning Committee Report and be prepared to draft any statements as needed.

On Friday November 19, the Council will hear a report on the progress of the Regional Operating Agreement renewal (Agenda Item C.3) and be briefed on the preliminary regional Best Scientific Information Available (BSIA) Framework (Agenda Item C.4).

On Sunday November 21, the Council will discuss Legislative Matters (Agenda Item C.6) and Standardized Bycatch Reporting Methodology (SBRM; Agenda Item C.8). Please review the staff summary of federal legislation in your briefing packet. Under SBRM, multiple Fishery Management Plans, including salmon, may need to be updated to better describe how bycatch in fisheries is reported. The STT will be providing a report describing how SBRM requirements are met.

On Monday November 22 (Day Last) Membership appointments and Council Operating Procedures (Agenda Item C.9), and future Council meeting agendas and workload planning (Agenda Item C.10) will be covered. As a reminder, the Council has solicited for nominations for the next three-year term (2022-24) between the September and November Council meetings, with final appointments expected in November 2021.

Please take the time necessary to review and familiarize yourself with briefing materials thoroughly before the meeting. If you have any questions, please feel free to contact me.

The SSC will review any nominations for SSC at-large seats and any vacant management or technical team seats that may come in before the November Council meeting. Their recommendations will be offered to the Council under the Council Closed Session on Tuesday, November 16.

The SSC will review a draft West Coast framework for determining best scientific information available and report their recommendations under Agenda Item C.4.

The SSC will discuss future workload planning matters and will report to the Council on their plans under Agenda Item C.10.

Groundfish Management

The SSC will review and consider endorsing stock assessments for copper rockfish in California (two assessments north and south of Pt. Conception), quillback rockfish in California, and spiny dogfish, as well as new rebuilding analyses for copper rockfish in California south of Pt. Conception and quillback rockfish in California, which were reviewed on September 29-30 by the SSC's Groundfish Subcommittee at the mop-up review panel. The SSC will report their recommendations on these assessments as best scientific information available for management decision-making for fisheries in 2023 and beyond under Agenda Item E.2.

The SSC will review 2023 and 2024 groundfish harvest specifications under default harvest control rules (please review the <u>GMT008</u> report on the PacFIN website for the most recent updates). Additionally, the SSC will review the projected harvest specifications for select species under alternative harvest control rules requested by the Council. The SSC will recommend the 2023 and 2024 overfishing limits and sigma values to inform Council decisions under Agenda Item E.3.

Salmon Management

The SSC will report their recommendations on salmon methodologies reviewed by the SSC's Salmon Subcommittee in October under Agenda Item F.1.
