## Dear all IATTC-WCPFC NC Pacific Bluefin Tuna Joint Working Group participants,

As many of you know, the IATTC concluded the second half of their 2021 annual meeting on October 22, 2021. Among the actions taken during the first session of the annual meeting held on 23-27 August was the adoption of a **Resolution C-21-01** (*Amendment to Resolution C-18-02 on a Long-term Management Framework for the Conservation and Management of Pacific Bluefin Tuna in the EPO*). The revisions to the long-term management included control rules for the second rebuilding period. This new Resolution fully incorporated the recommendations of the JWG this year.

In addition, at the second session of their annual (18-22 October), the IATTC approved by consensus short term (2021-2024) measures **Resolution C-21-05** (*Measures for the Conservation and Management of Pacific Bluefin Tuna in the EPO*). These measures are also fully consistent with the JWG recommendations.

Both of these adopted resolutions are now posted on the IATTC website and attached to this email for your convenience.
