Dr. Benjamin Cross Biography

Project Leader - Western Washington Fish and Wildlife Conservation Office

Dr. Benjamin Cross began his current position at the U.S. Fish and Wildlife Service (Service) in November 2021 as the Project Leader and Deputy Complex Manager for the Western Washington Fish and Wildlife Conservation Office (WWFWCO) and Puget Sound/Olympic Peninsula Complex (Complex), respectively. The Complex includes Quilcene, Quinault, and Makah National Fish Hatcheries, which annually release over 6 million salmon and steelhead in support of tribal, recreational, and commercial fisheries. The Complex also includes the WWFWCO with a staff of fish and wildlife biologists, hatchery operation specialists, biostatisticians, and support personnel that work on a variety of projects affecting wild and hatchery fish and other aquatic resources in addition to carrying out the marking and tagging of fish released from the three hatcheries.

Dr. Cross initially joined the Service in December 2018, serving as a Supervisory Fish Biologist for the WWFWCO where he led the hatchery monitoring and evaluation program. Prior to working for the Service, he worked for the Colville Confederated Tribes as a Principal Fisheries Biologist, leading their resident fisheries habitat program and hatchery monitoring and evaluation program. Dr. Cross also represents the Service on the Regional Committee on Marking and Tagging with the Pacific States Marine Fish Commission where he coordinates marking and tagging activities related to Pacific salmonid evaluations with other federal, state, and tribal agencies in the U.S. and Canada. Dr. Cross has a BS in Zoology (North Dakota State University), a MS in Natural Resources (University of Wisconsin – Stevens Point), and a PhD in Environmental and Natural Resource Sciences (Washington State University).
