PROGRAM HISTORY AND KEY MANAGEMENT MEASURES

- Catch share program established with Amendment 14 (2001)
 - Lengthened season date from a derby fishery to the current season of April I-October 31
- Vessels must have a sablefish endorsed LEFG permit
 - Permits are assigned to Tier I, Tier 2, or Tier 3 (3.85 : 1.75 : I)
- Vessels can stack up to three permits at one time
- No entity may own or hold more than 3 permits
- Owner-on-board requirement and exemptions




NWFSC WEST COAST FISHERIES PARTICIPATION SURVEY

- Majority of participants live in coastal counties for OR and CA, Puget Sound in WA
- 60+% of respondents indicate that they captain their own vessels
 - Compared to around 40 percent of the permits require the owner to be present
- "Do you have adequate access to processors or first receivers in order to sell your catch?"
 - 2/3rds say yes
 - No respondents- N CA, S OR and PS for WA
- Average age= 59



PERMIT PRICE ANALYSIS

- 2014 Council recommendation to collect permit price information- not prioritized
- Limited information available from Dock Street Brokers
- Similar trends in the price per pound and permit per pound of quota.





NET REVENUE

Change since 2010 (2014-2017 data compared to 2010 – Table 11)

- All LEFG Groundfish Vessels
 - Average Revenue Per Vessel Down
 - Average Cost Per Vessel Down more
 - Net Revenue Per Vessel <u>Up 9%</u> (TCNR)
 - Exceptions 30'-50' vessels and California vessels

Note: Table 11, footnote a/ should be deleted (applies to Table 12).

Sablefish Endorsed LEFG Vessels – Net Revenue Per Vessel – <u>Down 13%</u> (TCNR)


LEFG vessels that also gear switch > profits than other LEFG vessels (Table 12)

• \$93 thousand compared to \$19 thousand per vessel (vessel size difference explains some of difference)


HIGHGRADING ANALYSIS: OBSERVER EFFECT


- SSC Request from June 2021
- Previous analyses indicated that the LEFG fleet highgrades
- Unlike IFQ, discards do not count against tier limit- therefore, no cost in highgrading
- Fishing behavior doesn't appear to change with presence of observer



ENFORCEMENT COMPLIANCE REPORT

- Between 2018-2020, average of
 - 83% compliance rate for the longline fleet
 - 80% compliance rate for the trap/pot fleet



Permit Price Reporting	On GFWorkload List (Agenda Item E.6.)
Require that all pot gear be returned to shore at the end of each fishing trip.	Removed in 2016 b/c conflicted with VMM Rule
Convert daily trip limits to a tier endorsement.	Removed from GF Workload List in Nov 2018 based on GMT and GAP recommendations
Combine longline and pot gear limited entry gear endorsements into a single fixed gear endorsement.	
Move the seaward line of the Rockfish Conservation Area (RCA) closer to shore for pot vessels.	Part of the NT RCA action (next scheduled for April 2022)
