Who to notify:

Please notify Pacific Council Executive Director, [Merrick Burden](#) and Administrative Officer, [Patricia Crouse](#)
Federal and State members – please follow individual Federal and State guidelines.

Notification of committee and close contacts exposure notice:

An infected person can spread COVID starting 48 hours (or two days) before the person has any symptoms or tests positive. Notification will be made by Executive staff.

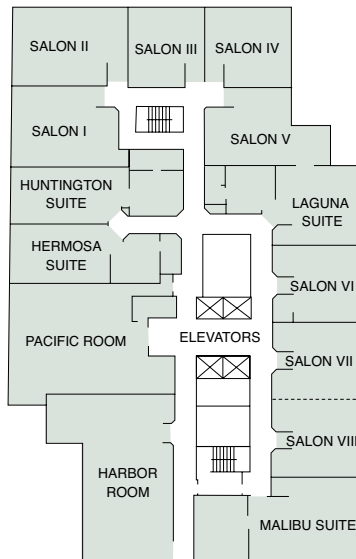

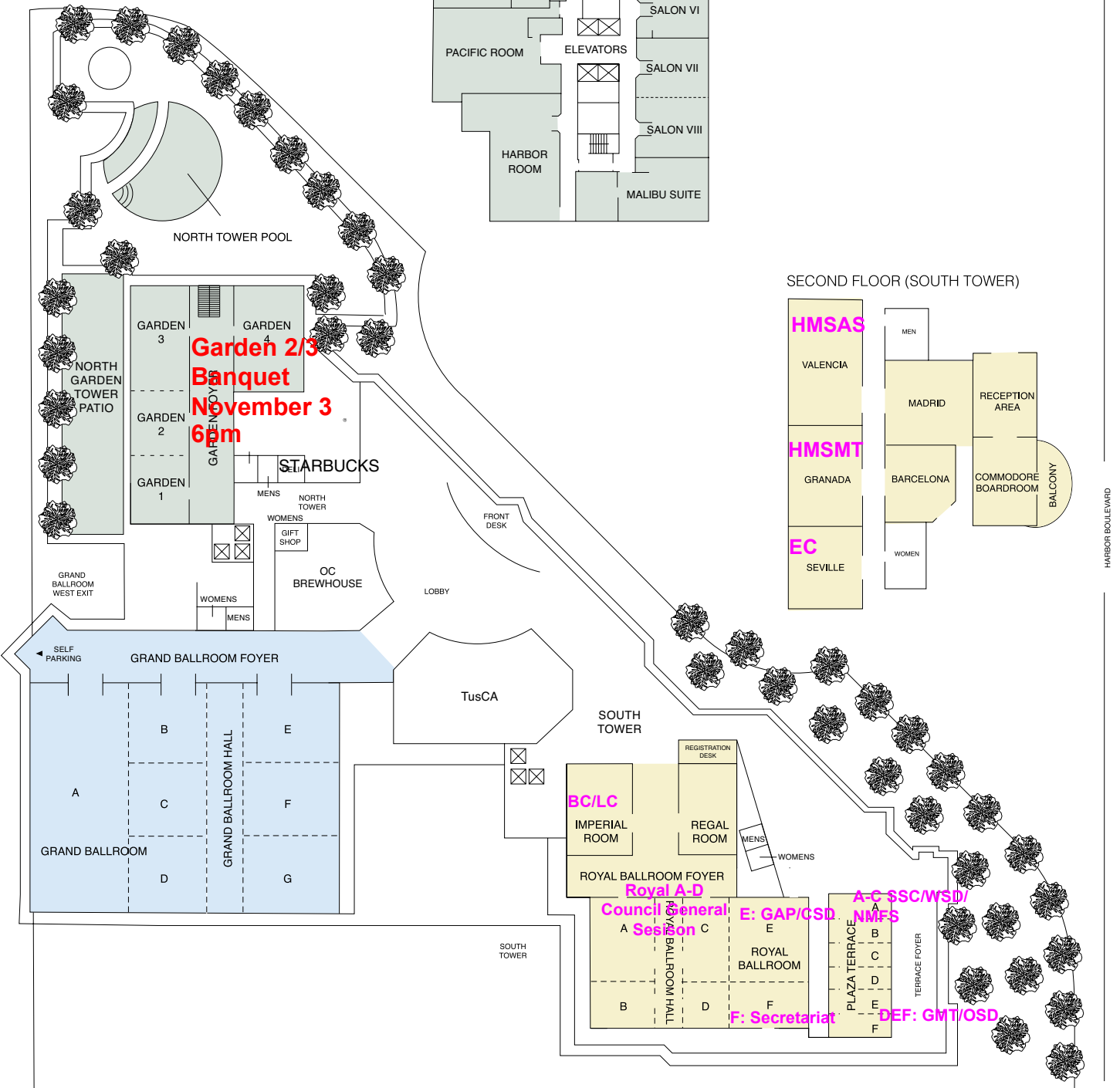
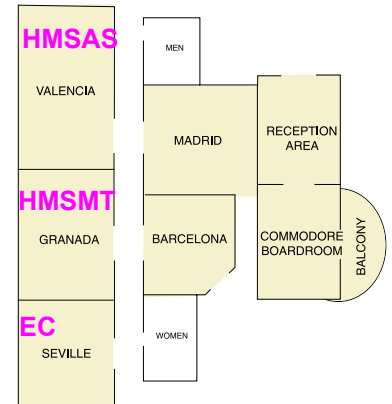

ROOM DIMENSIONS & CAPACITIES (CONTINUED)

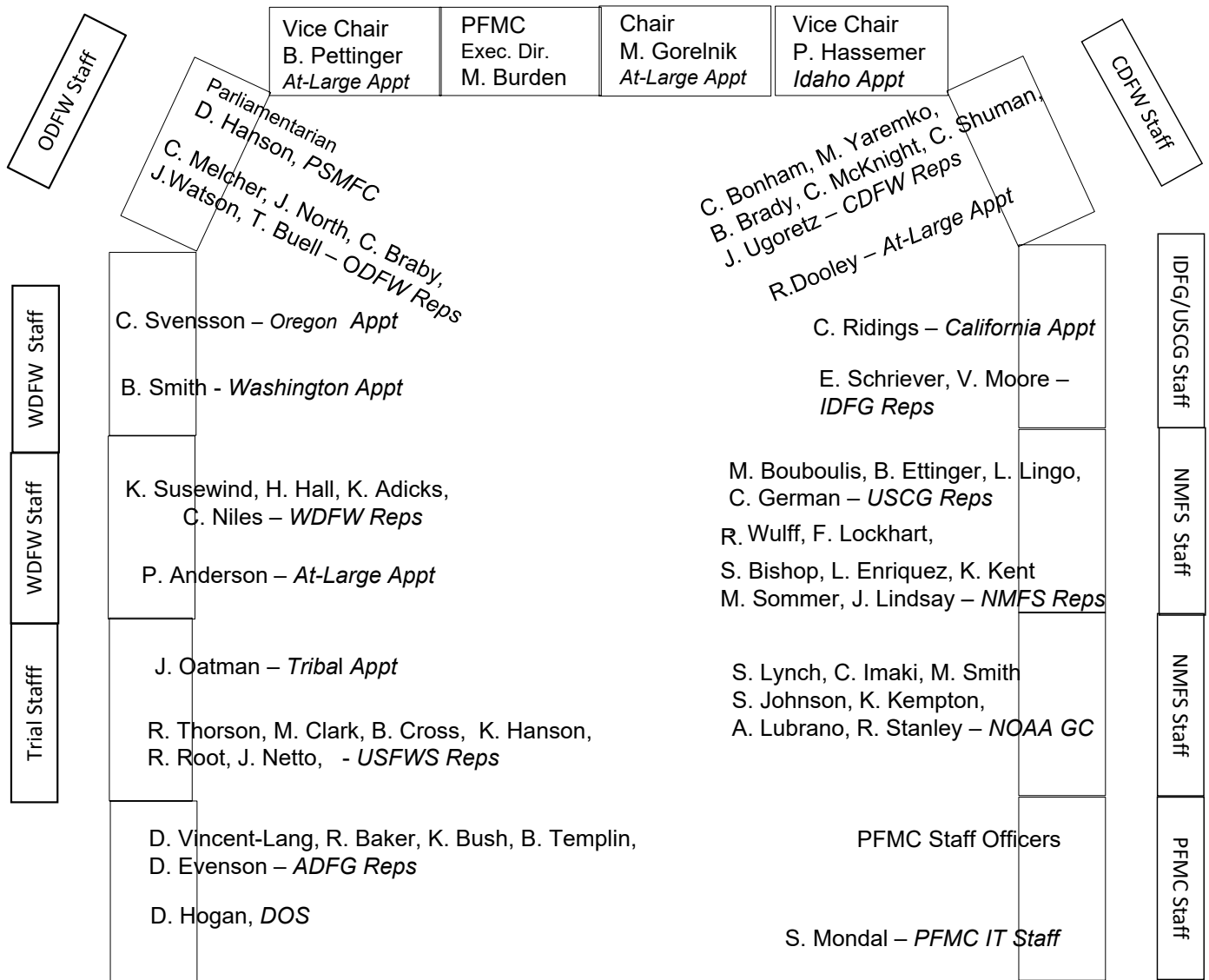
SECOND FLOOR (NORTH TOWER)

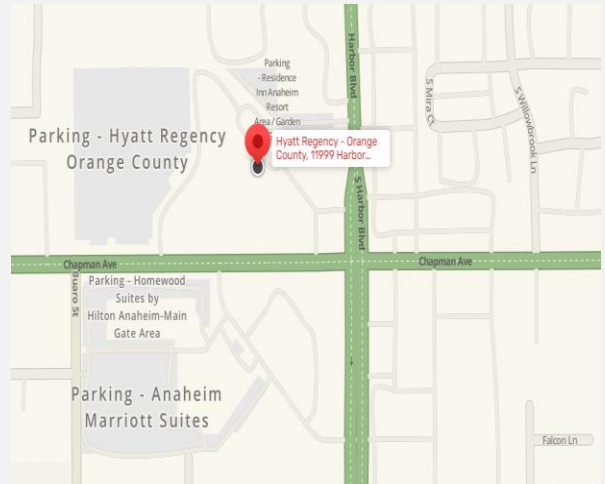
