Who to notify:

Please notify Pacific Council Executive Director, <u>Merrick Burden</u> and Administrative Officer, <u>Patricia Crouse</u> Federal and State members – please follow individual Federal and State guidelines.

Notification of committee and close contacts exposure notice:

An infected person can spread COVID starting 48 hours (or two days) before the person has any symptoms or tests positive. Notification will be made by Executive staff.



How do I get home?


Please follow the CDC guidance for travel - Per the CDC, do not travel if...
