# Ad Hoc Committees

The ad hoc Marine Planning Committee (MPC) was established in June 2021 to engage in the marine planning processes for offshore wind and aquaculture opportunity areas. The Council anticipated the MPC would be in place for at least two years. Under this agenda item, the Council should consider whether to renew the MPC, and whether any changes to committee structure, function, or membership are warranted.

Membership of the Council's newly formed Ad-Hoc Equity and Environmental Justice Committee has been named and includes Mr. Joseph Oatman (Tribal), Ms. Heather Hall (WDFW), Ms. Christa Svensson (OR Obligatory), Mr. Virgil Moore (IDFG), Ms. Corey Ridings (CA Obligatory) and Ms. Maggie Sommers (NMFS).

# Council Operating Procedures and Statement of Organization, Practices, and Procedures

The Council should consider updates to COP 1, 2, 3, 4, and 6 to reflect current hybrid meeting practices for public comment registration, motions, and voting procedures.

The Council should also consider additional steps to promote a respectful and harassment-free work environment.
