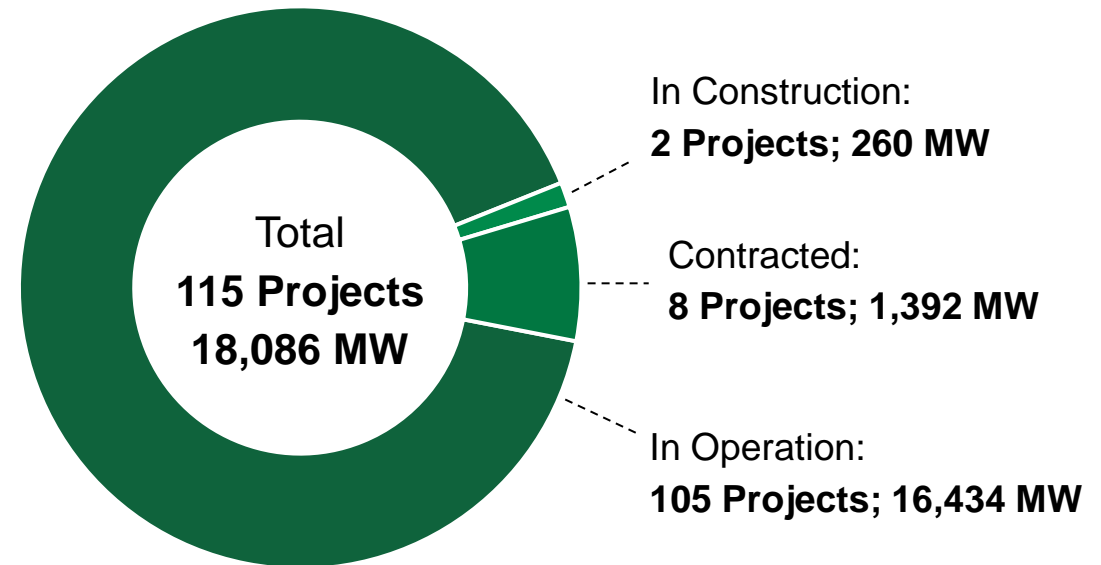

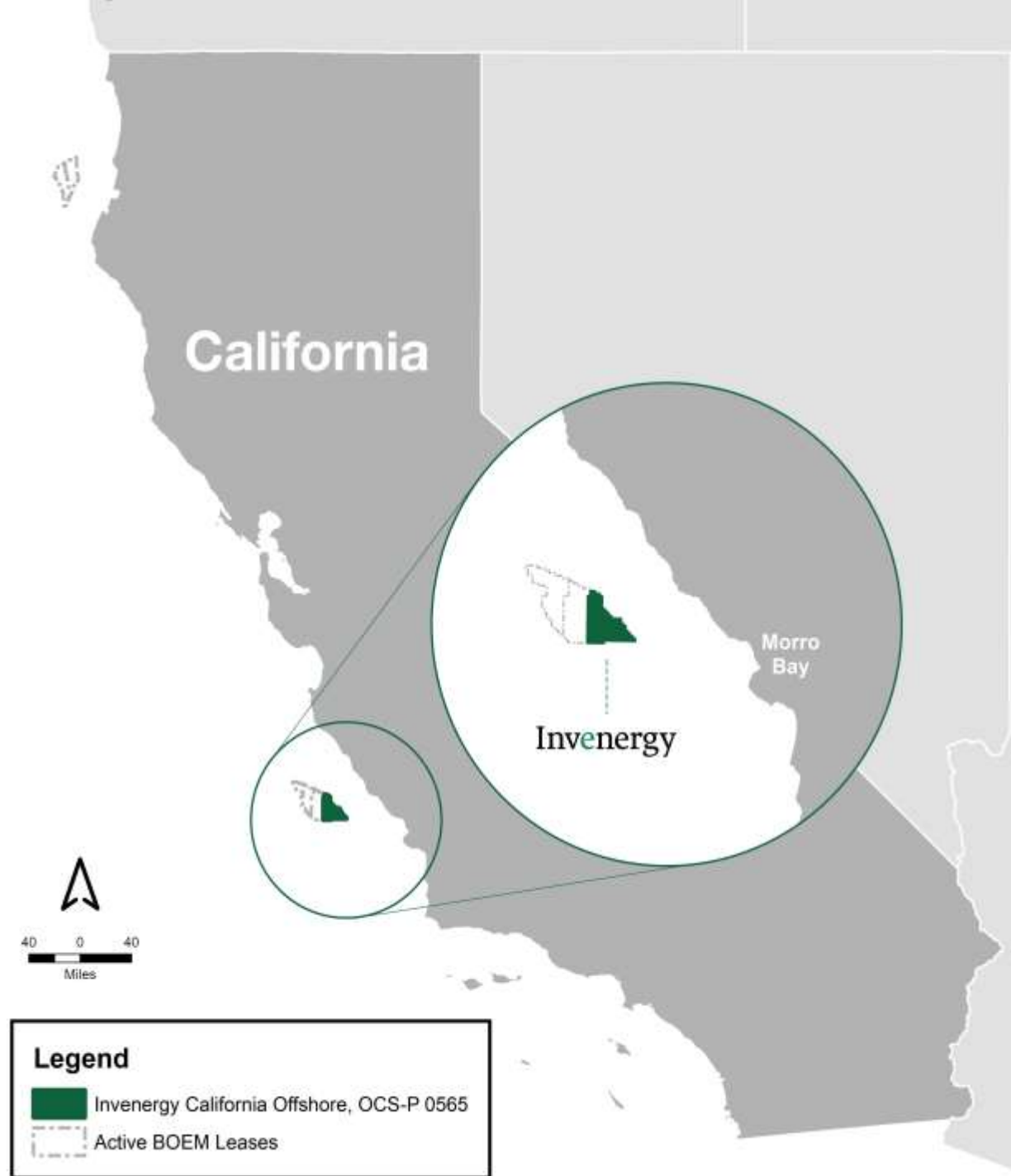


Invenergy Wind Portfolio



Project Profile

- **Named only American-led provisional leaseholder by Bureau of Ocean Energy Management (BOEM) in December 2023**
- **Final lease agreement was executed on June 1, 2023**
 - **Capacity: ~2,000 MW**
 - **Acres: 80,418**
 - **Avg. water depth: 994-1,197 m**
 - **Distance from shore: ~20 mi**



Fisheries Communications Plan – Core Principles

Our Fisheries Communication Plan will:

Apply Transparency and Accountability. Facilitate open, efficient, timely, and transparent communications to promote awareness and safety.

Incorporate Diverse Experiences. Seek out and apply the diverse expertise and knowledge of the commercial and recreational fishing communities in the shared project area.

Conduct Respectful Communication. Acknowledge and respect the concerns and interests of the fishing industry and their supporting businesses.

Fisheries Communication Plan - Objectives

- ❑ Promote the safety of fishers, offshore survey crews, and construction crews transiting, working, and fishing in/near the project area.
- ❑ Proactively solicit fishing stakeholder concerns and strive for open, transparent communication to avoid conflicts before they develop.
- ❑ Identify potential adverse impacts to fishers and related industries; understand, as fully as possible, historic, current, and potential fisheries in the affected area; and make informed decisions on how to avoid, minimize, and/or mitigate effects including the use of community benefit agreements.
- ❑ Identify potential opportunities to enhance the safe and productive shared use of resources.
- ❑ Provide a pathway to quickly and fairly resolve fisheries related conflicts that may develop during the life of the project.
- ❑ Create an authentic and professional relationship between fishing and wind energy in which both will prosper on a long-term basis.
- ❑ Establish a single point of contact to serve as a facilitator between project sponsors and fisheries stakeholders (i.e., the Fisheries Liaison Officer).
