Non-Tribal Sport Allocation

proposals to keep as is, or shift some portion of WA & OR sport to CA sport



Options adopted for public review in September.



Status Quo – CA sport = 4%

Option 1 – moves 2% from OR and 1%

from WA for CA total of 7%



Option 2 – move 1% of OR and 0.5% from WA for CA total of 5.5% Option 3 – Move 0.6% from OR and 0.4% from WA for CA total of 5%

Inseason Flexibility

the goal is to try to provide better access to the total Area 2A FCEY by identifying unused quota and transfer to other states inseason



States can report actual and projected catch, plus projected unused quota inseason



NMFS re-apportions the amount available based on the state and subarea quotas prescribed in the CSP



Need expedited transfer of quota for the concept to be meaningful.

May need more time to get the language right


