- As of January 26, 2024, NMFS has approved 33 EM vessel authorizations and an additional 13 vessels have begun applications. 14 vessels that previously participated in the EM EFP have not yet begun applications, and NMFS is conducting outreach to these vessel owners.
- The deadline for EM vessel authorization applications for the primary whiting season is February 1, 2024.

- PSMFC is administering the reimbursement program for EM video review services
 - Initially, 90% partial reimbursement will be provided for the review rates in the EM Program Manual
 - Full reimbursement may occur later in the year, as funds allow
 - The 2024 video review reimbursement rate is \$100 per haul fished
- NMFS is issuing EFPs to allow vessels to discard sablefish and rex sole while on declared optimized retention bottom trawl or non-whiting midwater trawl trips. These species were allowable discards under the EM EFPs, but must be retained under current regulations.
