SABLEFISH GEAR SWITCHING – FINAL ACTION AND FISHERY MANAGEMENT PLAN (FMP) AMENDMENT

Pacific Fishery Management Council (Council) discussions on limiting the use of non-trawl gear to target sablefish in the trawl individual fishing quota (IFQ) fishery (gear switching) began as part of its review of the Trawl Catch Share Program, finalized in 2017. As a result of the review, the Council adopted a gear switching control date (September 15, 2017). Subsequently it began a process that started with work by the Sablefish Allocation Management and Trawl Allocation Attainment Committee and led to further work on a range of alternatives across several Council meetings starting in September 2021. Most recently, at the November 2023 meeting, the Council selected its preliminary preferred alternative (PPA). The PPA would implement gear-specific quota pounds except in years in which a trigger is met, in which case generic quota pounds would be issued. Over the winter, the National Marine Fisheries Service (NMFS) determined that it would require a Fishery Management Plan (FMP) amendment for this action. At this meeting, the Council is scheduled to select its final preferred alternative and adopt FMP amendment language.

Additionally, NMFS will provide a report discussing implementation and ongoing tasks related to the PPA (Agenda Item F.4.a, NMFS Report 1).

Assuming the Council recommends an action alternative, the approval process requires that the Council deem that proposed regulations developed by NMFS are consistent with Council action. Generally, deeming is done by the Executive Director. On some occasions, deeming is conducted as part of a Council agenda item. This can be particularly useful for major or complex actions, for which policy issues are sometime discovered as regulations are developed.

Council Action:

- 1. Select final preferred alternative, including final preferred options and resolution of any outstanding issues (see list in Attachment 1 and discussion sections of Attachment 2).
- 2. Adopt FMP language.
- 3. Provide other guidance on the alternatives and process, as needed.
