Congressional Activities Report 118th Congress April 2024 Submitted to the Caribbean Fishery Management Council

Appropriations Update – Fiscal Year 2024

The Federal government is now fully funded through the end of the fiscal year (September 30, 2024). Two public laws were passed by Congress and signed by the President to fund various agencies – P.L. 118-42 (signed on March 9, 2024) included funding for six of the twelve normal appropriations bill (including funding for the Department of Commerce) and P.L. 118-47 (signed on March 23, 2024) included funding for the remaining six appropriations bills.

<u>Appropriations Update – Fiscal Year 2025</u>

At this point, no hearings have been scheduled for the NOAA or Department of Commerce budget request in either the House or Senate Appropriations Committees.

NEW LEGISLATION

- **H.R. 8169**, (Rep. Dean, D-Pennsylvania) [Prognosis: 1%], a bill to require the Secretary of Agriculture to prohibit the use of lead ammunition on all lands and waters under the jurisdiction and control of the Forest Service, and for other purposes. Introduced on April 30, 2024, and referred to the House Agriculture Committee, and in addition to the House Natural Resources Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **H.R. 8156**, (Rep. Newhouse, R-Washington) [Prognosis: 2%], a bill to direct the Comptroller General of the United States to submit to Congress an updated report on the roles, responsibilities, and practices of the Council on Environmental Quality. Introduced on April 29, 2024, and referred to the House Natural Resources Committee.
- **H.R. 8155**, (Rep. Newhouse, R-Washington) [Prognosis: 2%], a bill to direct the Secretary of Energy to develop fish and wildlife program funding alternatives to mitigate the cost to Bonneville Power Administration ratepayers, and for other purposes. Introduced on April 29, 2024, and referred to the House Natural Resources Committee.
- **H. Res. 1176**, (Rep. Newhouse, R-Washington) [Prognosis: 26%], a resolution expressing disapproval of the Columbia Basin Restoration Initiative entered into by the Biden

administration. Sponsor: Newhouse, Dan [Rep.-R-WA-4] Introduced on April 29, 2024, and referred to the House Natural Resources Committee.

- **H.R. 7973**, (Rep. Gimenez, R-Florida) [Prognosis: 2%], a bill to direct the Secretary of Commerce to establish a grant program to support the restoration of coral reefs in South Florida. Introduced on April 12, 2024, and referred to the House Natural Resources Committee.
- H.R. 7938, the "Klamath Basin Water Agreement Support Act of 2024", (Rep. Bentz, R-Oregon) [Prognosis: 4%], a bill to amend the Klamath Basin Water Supply Enhancement Act of 2000 to provide the Secretary of the Interior with certain authorities with respect to projects affecting the Klamath Basin watershed, and for other purposes. Introduced on April 11, 2024, and referred to the House Natural Resources Committee.
- **S. 4117, the "Climate Change Education Act"**, (Sen. Markey, D-Massachusetts) [Prognosis: 0%], a bill to require the Administrator of the National Oceanic and Atmospheric Administration to establish a Climate Change Education Program, and for other purposes. Introduced on April 11, 2024, and referred to the Senate Commerce, Science, and Transportation Committee.
- **S. 4113, the "State Boating Act"**, (Sen. Shaheen, D-New Hampshire) [Prognosis: 2%], a bill to allow States to require payment of State fees related to boating as a condition for issuance of a vessel number and to collect such fees in conjunction with other fees related to vessel numbering. Introduced on April 11, 2024, and referred to the Senate Commerce, Science, and Transportation Committee.
- **H.R. 7932**, (Rep. Nehls, R-Texas) [Prognosis: 4%], a bill to prohibit Federal funds from being made available to international financial institutions for the purposes of financing foreign shrimp farms, and for other purposes. Introduced on April 10, 2024, and referred to the House Financial Services Committee.
- H.R. 7925, the "Modernizing Access to Our Public Oceans Act", (Rep. D'Esposito, R-New York) [Prognosis: 9%], a bill to provide for the standardization, publication, and accessibility of data relating to public outdoor recreational use of Federal waterways, and for other purposes. Introduced on April 10, 2024, and referred to the House Natural Resources Committee.
- **H.R. 7897**, (Rep. Crane, R-Arizona) [Prognosis: 2%], a bill to require the Secretary of the Interior to finalize a proposed rule to remove the Apache trout from the Federal List of Endangered and Threatened Wildlife. Introduced on April 09, 2024, and referred to the House Natural Resources Committee.
- H.R. 7872, the "Colorado River Salinity Control Fix Act", (Rep. Curtis, R-Utah) [Prognosis: 12%], a bill to amend the Colorado River Basin Salinity Control Act to modify certain requirements applicable to salinity control units, and for other purposes. Introduced on April 05, 2024, and referred to the House Natural Resources Committee.

- H.R. 7859, the "Tribal Environmental Resiliency Resources Act" or the "TERRA Act", (Rep. Kilmer, D-Washington) [Prognosis: 8%], a bill to authorize the integration and administrative streamlining of Federal funding for Indian Tribes that have reservations, other Tribal lands, or ways of life at risk due to environmental impacts and natural disasters, and for other purposes. Introduced on April 02, 2024, and referred to the House Natural Resources Committee.
- **S. 3795, the "Remote Seafood Employee Meals Tax Parity Act"**, (Sen. Murkowski, R-Alaska) [Prognosis: 0%], a bill to amend the Internal Revenue Code of 1986 to provide that the 50 percent limitation on the deduction for meal expenses does not apply to meals provided on certain fishing boats or at certain fish processing facilities. Introduced on February 9, 2024 and referred to the Senate Finance Committee.
- S. 3791, the "America's Conservation Enhancement Reauthorization Act of 2024", (Sen. Carper, D-Delaware) [Prognosis: 60%], a bill to reauthorize the America's Conservation Enhancement Act, and for other purposes. Introduced on February 8, 2024, and referred to the Senate Environment and Public Works Committee. (Note: this legislation would amend the National Fish Habitat Board to add a second representative of the regional fishery management councils to the Board.)
- H.R. 6295, the "Remote Seafood Employee Meals Tax Parity Act", a bill to (Rep. DelBene, D-Washington) [Prognosis: 1%], a bill to amend the Internal Revenue Code of 1986 to provide that the 50 percent limitation on the deduction for meal expenses does not apply to meals provided on certain fishing boats or at certain fish processing facilities. Introduced on November 8, 2023, and referred to the House Ways and Means Committee.
- H.R. 5087, the "Supporting Equity for Aquaculture and Seafood Act" or the "SEAS Act", (Rep. Pallone, D-New Jersey) [Prognosis: 2%], a bill to require the Secretary of Agriculture to submit a report to Congress on Department of Agriculture spending related to seafood purchases and grants, and for other purposes. Introduced on July 28, 2023, and referred to the House Agriculture Committee.
- S. 2211, the "Sustaining Healthy Ecosystems, Livelihoods, and Local Seafood Act", (Sen. Whitehouse, D-Rhode Island) [Prognosis: 2%], a bill to amend the Department of Agriculture Reorganization Act of 1994 to establish the Office of Aquaculture, and for other purposes. Introduced on June 22, 2023, and referred to the Senate Agriculture, Nutrition, and Forestry Committee.
- **S. 2208, the "National Seafood Supply Act of 2023"**, (Sen. Sullivan, R-Alaska) [Prognosis: 0%], a bill to require the Secretary of Agriculture to provide support for domestically harvested seafood, and for other purposes. Introduced on June 22, 2023, and referred to the Senate Agriculture, Nutrition, and Forestry Committee.
- H.R. 3951, the "Sustaining Healthy Ecosystems, Livelihoods, and Local Seafood Act", (Rep. Bonamici, D-Oregon) [Prognosis: 2%], a bill to establish in the Department of

Agriculture an Office of Aquaculture, and for other purposes. Introduced June 9, 2023, and referred to the House Agriculture Committee.

- H.R. 2734, the "Ocean Acidification Research Partnerships Act", (Rep. Carbajal, D-California) [Prognosis: 3%], a bill to provide for ocean acidification collaborative research grant opportunities. Introduced on April 20, 2023, and referred to the House Science, Space, and Technology Committee.
- S. 618, the "United States Foundation for International Conservation Act of 2023", (Sen. Coons, D-Delaware) [Prognosis: 26%], a bill to establish the United States Foundation for International Conservation to promote long-term management of protected and conserved areas, and for other purposes. Introduced on March 1, 2023, and referred to the Senate Foreign Relations Committee.
- H.R. 614, the "Commercial Fishing and Seafood Business Act of 2023", (Rep. Wittman, R-Virginia) [Prognosis: 6%], a bill to amend the Department of Defense Appropriations Act, 2005 to provide for the inclusion of certain workers in the exemption from numerical limitations on H–2B workers, and for other purposes. Introduced on January 27, 2023, and referred to the House Judiciary Committee.

LEGISLATIVE ACTIVITY

Changes in bill status since the last report:

On April 30, 2024, the full House of Representatives passed **H.R. 615**, the "Protecting Access for Hunters and Anglers Act of 2023", (Rep. Wittman, R-Virginia) [Prognosis: 52%], a bill to prohibit the Secretary of the Interior and the Secretary of Agriculture from prohibiting the use of lead ammunition or tackle on certain Federal land or water under the jurisdiction of the Secretary of the Interior and the Secretary of Agriculture, and for other purposes.

On April 16, 2024, the House Natural Resources Committee ordered to be reported (amended): **H.R. 7408, the "America's Wildlife Habitat Conservation Act"**, (Rep. Westerman, R-Arkansas) [Prognosis: 21%], a bill to amend the Pittman-Robertson Wildlife Restoration Act to make supplemental funds available for management of fish and wildlife species of greatest conservation need as determined by State fish and wildlife agencies, and for other purposes.

On April 16, 2024, the Senate Foreign Relations Committee ordered to be reported (amended): **S. 618, the "United States Foundation for International Conservation Act of 2023"**, (Sen. Coons, D-Delaware) [Prognosis: 26%] a bill to establish the United States Foundation for International Conservation to promote long-term management of protected and conserved areas, and for other purposes.

On April 11, 2024, the full House of Representatives passed **H.R. 2560**, the "Sea Turtle Rescue Assistance and Rehabilitation Act of 2023", (Rep. Keating, D-Massachusetts) [Prognosis: 30%], a bill to require the Secretary of Commerce to establish the Sea Turtle Rescue Assistance Grant Program, and for other purposes.

On April 9, 2024, the full House of Representatives passed **H.R. 1792, the "South Pacific Tuna Treaty Act of 2023"**, (as amended by the House Natural Resources Committee), (Rep. Radewagen, R-American Samoa) [Prognosis: 41%], a bill to amend the South Pacific Tuna Act of 1988, and for other purposes.

On April 9, 2024, the Senate Energy and Natural Resources Committee filed the report to accompany **S. 2247, the "Upper Colorado and San Juan River Basins Endangered Fish Recovery Programs Reauthorization Act of 2023"**, (Sen. Hickenlooper, D-) [Prognosis: 45%], a bill to reauthorize the Bureau of Reclamation to provide cost-shared funding to implement the endangered and threatened fish recovery programs for the Upper Colorado and San Juan River Basins, and placed the bill on the Senate Legislative Calendar.

On April 2, 2024, the House Natural Resources Committee filed the report to accompany **H.R. 4770, the "Chesapeake Bay Science, Education, and Ecosystem Enhancement Act of 2023"**, (Rep. Sarbanes, D-Maryland) [Prognosis: 23%], a bill to reauthorize the Chesapeake Bay Office of the National Oceanic and Atmospheric Administration, and for other purposes, and the bill was placed on the Union Calendar.

October 24, 2023, the Congressional-Executive Commission on China held a hearing titled "From Bait to Plate—How Forced Labor in China Taints America's Seafood Supply Chain".

According to the Commission's website,

"Forced labor in China taints the world's seafood supply chain. PRC-based companies that use the forced labor of Uyghurs and North Koreans process a large amount of seafood for the U.S. market. From fish sticks to calamari—these products end up in the supply chains of major restaurants and wholesalers and in the lunches served at American schools and military bases. Recently published reports by The Outlaw Ocean Project detail how forced labor is rampant in China's seafood industry, including modern slavery on China's illegal, unreported, and unregulated (IUU) fishing fleet, and in processing plants located in Shandong province of China—where Uyghurs are employed in labor transfer projects. There is also emerging evidence that North Koreans are also working in the fish processing industry in Liaoning province. Squid, pollack, baby clams, and crab are just some of the imports that make it onto the plates of American consumers.

"U.S. imports of seafood caught or processed with forced labor may be prohibited under the Uyghur Forced Labor Prevention Act (Public Law 117-78), the Countering America's Adversaries Through Sanctions Act (Public Law 115-44), and other laws. Nevertheless, the U.S. Government, major grocery chains, and restaurants continue to purchase seafood caught and processed using forced labor in China.

"This hearing will continue the CECC's efforts to ensure that PRC goods and products made with forced labor do not enter U.S. markets. Witnesses will provide testimony about the human rights abuses on board China's IUU fishing fleet, the seafood supply chains tainted by forced labor in China, and the exposure of the U.S. Government and American consumers to these supply chains. Witnesses will also provide recommendations for U.S. action."

Wittman, R-Virginia), a bill to direct the Secretary of Commerce to establish a task force regarding shark depredation, and for other purposes. Introduced June 12, 2023, and referred to the House Natural Resources Committee. On July 27, 2023, the House Natural Resources Committee's Subcommittee on Water, Wildlife, and Fisheries held a hearing on the legislation. On Wednesday, September 20, 2023, the bill (amended) was ordered to be favorably reported to the House of Representatives by unanimous consent by the House Natural Resources Committee. On February 5, 2024, the full House of Representatives passed the bill by voice vote.
- **S. 1508**, (Sen. Reed, D-Rhode Island), a bill to amend the Magnuson-Stevens Fishery Conservation and Management Act to add Rhode Island to the Mid-Atlantic Fishery Management Council, and for other purposes. Introduced on May 10, 2023, and referred to the Senate Commerce, Science, and Transportation Committee.
- **H.R. 3187**, (Rep. Magaziner, D-Rhode Island), a bill to amend the Magnuson-Stevens Fishery Conservation and Management Act to add Rhode Island to the Mid-Atlantic Fishery Management Council. Introduced on May 10, 2023, and referred to the House Natural Resources Committee.
- H.R. 2990, the "National Oceanic and Atmospheric Administration Sexual Harassment and Assault Prevention Improvements Act of 2023", (Rep. Bonamici, D-Oregon), a bill to amend the National Defense Authorization Act for Fiscal Year 2017 to address sexual harassment involving National Oceanic and Atmospheric Administration personnel, and

for other purposes. Introduced April 28, 2023, and referred to the House Natural Resources Committee, and in addition to the House Transportation and Infrastructure Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned. On October 25, 2023, the House Natural Resources Committee's Subcommittee on Water, Wildlife, and Fisheries held a hearing on the bill.

- **S. 3879, the "Illegal Red Snapper Enforcement Act"**, (Sen. Blumenthal, D-Connecticut), a bill to support healthy fisheries in dynamic ocean conditions, and for other purposes. Introduced on January 25, 2024, and referred to the Senate Commerce, Science, and Transportation Committee.
- S. 3389, the "Fishing Industry Safety, Health, and Wellness Improvement Act of 2023" or the "FISH Wellness Act of 2023", (Sen. Markey, D-Massachusetts), a bill to authorize safety and prevention training programs for fishing vessel operators and crewmembers, and for other purposes. Introduced on December 4, 2023, and referred to the Senate Commerce, Science, and Transportation Committee.
- **S. 2182, the "Wild USA Seafood Act of 2023"**, (Sen. Murkowski, R-Alaska), a bill to amend the Agricultural Marketing Act of 1946 to establish a label designating fish harvested in the United States exclusive economic zone or navigable waters as wild USA seafood, and for other purposes. Introduced on June 22, 2023, and referred to the Senate Agriculture, Nutrition, and Forestry Committee.
- H.R. 6447, the "Saving Natural Ecosystems and Marine Organisms Act" or the "Saving NEMO Act", (Rep. Case, D-Hawaii), a bill to prohibit certain actions with respect to certain marine reef species, and for other purposes. Introduced on November 17, 2023, and referred to the House Natural Resources Committee, and in addition to the House Ways and Means Committee, and the House Foreign Affairs Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- H.R. 4596, the "Upper Colorado and San Juan River Basins Endangered Fish Recovery Programs Reauthorization Act of 2023", (Rep. Boebert, R-Colorado), a bill to reauthorize the Bureau of Reclamation to provide cost-shared funding to implement the endangered and threatened fish recovery programs for the Upper Colorado and San Juan River

Basins, On Wednesday, September 20, 2023, the bill was ordered to be favorably reported to the House of Representatives by unanimous consent by the House Natural Resources Committee.

- H.R. 4587, the "Red Snapper Act", (Rep. Rutherford, R-Florida), a bill to provide that the Administrator of the National Oceanic and Atmospheric Administration shall not issue an interim or final rule that includes an area closure in the South Atlantic for species managed under the Snapper-Grouper Fishery Management Plan until the South Atlantic Great Red Snapper Count study is complete and the data related to that study is integrated into the stock assessment. Introduced on July 12, 2023, and referred to the House Natural Resources Committee. On July 27, 2023, the House Natural Resources Committee's Subcommittee on Water, Wildlife, and Fisheries held a hearing on the legislation. On Tuesday, October 24, 2023, the House Natural Resources Committee marked up the legislation.
- H.R. 4051, the "Supporting the Health of Aquatic systems through Research Knowledge and Enhanced Dialogue Act" or the "SHARKED Act", (Rep. Wittman, R-Virginia), a bill to direct the Secretary of Commerce to establish a task force regarding shark depredation, and for other purposes. Introduced June 12, 2023, and referred to the House Natural Resources Committee. On July 27, 2023, the House Natural Resources Committee's Subcommittee on Water, Wildlife, and Fisheries held a hearing on the legislation. On Wednesday, September 20, 2023, the bill (amended) was ordered to be favorably reported to the House of Representatives by unanimous consent by the House Natural Resources Committee. On February 5, 2024, the full House of Representatives passed the bill by voice vote.
- S. 1227, the "Fighting Foreign Illegal Seafood Harvests Act of 2023" or the "FISH Act of 2023", (Sen. Sullivan, R-Alaska), a bill to combat illegal, unreported, and unregulated fishing at its sources globally. Introduced on April 20, 2023, and referred to the Senate Commerce, Science, and Transportation Committee.
- H. J. Res. 46, (Rep. Bentz, R-Oregon), a resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the National Marine Fisheries Service relating to "Endangered and Threatened Wildlife and Plants; Regulations for Listing Endangered and Threatened Species and Designating Critical Habitat". Introduced on March 30, 2023, and referred to the House Natural Resources Committee. On April 18, 2023, the House Natural Resources Committee's Subcommittee on Water, Wildlife, and Fisheries held a hearing on the legislation. On April 27, 2023, the bill was ordered reported by the House Natural Resources Committee favorably by a roll call vote of 17 to 12.
- **H.R. 2315**, (Rep. Biggs, R-Arizona), a bill to provide for a limitation on availability of funds for Department of State, International Commissions, International Fisheries Commissions for fiscal year 2024. Introduced on March 29, 2023, and referred to the House Natural Resources Committee.
- H.R. 1792, the "South Pacific Tuna Treaty Act of 2023", (Rep. Radewagen, R-American Samoa), a bill to amend the South Pacific Tuna Act of 1988, and for other purposes. Introduced on March 24, 2023, and referred to the House Natural Resources Committee. On July 27, 2023, the House Natural Resources Committee's Subcommittee on Water, Wildlife, and

Fisheries held a hearing on the legislation. On Tuesday, October 24, 2023, the House Natural Resources Committee marked up the legislation. On March 21, 2024, the report to accompany the bill was filed and the bill was placed on the Union Calendar. On April 9, 2024, the full House of Representatives passed the legislation (amended).

Transferring Fisheries Authorities to U.S. FWS:

H.R. 872, the "Federally Integrated Species Health Act" or the "FISH Act", (Rep. Calvert, R-California), a bill to amend the Endangered Species Act of 1973 to vest in the Secretary of the Interior functions under that Act with respect to species of fish that spawn in fresh or estuarine waters and migrate to ocean waters and species of fish that spawn in ocean waters and migrate to fresh or estuarine waters, and for other purposes. Introduced on February 8, 2023, and referred to the House Natural Resources Committee. On April 11, 2023, the House Natural Resources Committee's Subcommittee on Water, Wildlife and Fisheries held a legislative field hearing on the bill.

H.R. 3980, the "National Oceanic and Atmospheric Administration Act of 2023", (Rep. Lucas, R-Oklahoma), a bill to formally establish within statute an independent scientific research and development agency known as the National Oceanic and Atmospheric Administration, and for other purposes. Introduced on June 9, 2023, and referred to the House Science, Space, and Technology Committee; and in addition to the House Natural Resources Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

California Water/Fisheries:

H.R. 215, the "Working to Advance Tangible and Effective Reforms for California Act" or the "WATER for California Act", (Rep. Valadao, R-California), a bill to provide long-term water supply and regulatory reliability to drought-stricken California, and for other purposes. Introduced on January 9, 2023, and referred to the House Natural Resources Committee. On April 11, 2023, the House Natural Resources Committee's Subcommittee on Water, Wildlife and Fisheries held a legislative field hearing on the bill. On April 28, 2023, the House Natural Resources Committee ordered the bill to be reported (Amended) by the Yeas and Nays: 22 – 17.

H.R. 872, the "Federally Integrated Species Health Act" or the "FISH Act", (Rep. Calvert, R-California), a bill to amend the Endangered Species Act of 1973 to vest in the Secretary of the Interior functions under that Act with respect to species of fish that spawn in fresh or estuarine waters and migrate to ocean waters and species of fish that spawn in ocean waters and migrate to fresh or estuarine waters, and for other purposes. Introduced on February 8, 2023, and referred to the House Natural Resources Committee. On April 11, 2023, the House

Natural Resources Committee's Subcommittee on Water, Wildlife and Fisheries held a legislative field hearing on the bill.

Marine Mammal / Sea Turtles Legislation:

- H.R. 7145, (Rep. Schiff, D-California), a bill to amend the Marine Mammal Protection Act of 1972 and the Animal Welfare Act to prohibit the taking, importation, exportation, and breeding of certain cetaceans for public display, and for other purposes. Introduced on January 30, 2024, and referred to the House Natural Resources Committee and the House Agriculture Committee. (Note: The text of the legislation is not yet available so it is unclear whether this bill will affect fisheries or ocean resources management.)
- **S.** 3694, (Sen. Wyden, D-Oregon), a bill to amend the Marine Mammal Protection Act of 1972 and the Animal Welfare Act to prohibit the taking, importation, exportation, and breeding of certain cetaceans for public display, and for other purposes. Introduced on January 30, 2024, and referred to the Senate Commerce, Science, and Transportation Committee. (*Note: The text of the legislation is not yet available so it is unclear whether this bill will affect fisheries or ocean resources management.*)
- S. 2986, the "Warding off Hostile Administrative Leasing Efforts Act" or the "WHALE Act", (Sen. Cassidy, R-Louisiana), a bill to prohibit the issuance of an interim or final rule, and to prohibit the inclusion in certain oil and gas leases, exploration or development plans, or well permits requirements or recommendations, that establish a vessel speed or operational restriction in the Central or Western Planning Area of the Gulf of Mexico of the outer Continental Shelf until the Secretary of the Interior and the Secretary of Commerce complete a study demonstrating that proposed mitigation efforts would have no negative impact on supply chains, United States offshore energy production and generation, military activities, including readiness, and United States commercial and recreational fishing maritime commerce, and for other purposes. Introduced on September 28, 2023, and referred to the Senate Commerce, Science, and Transportation Committee.
- H.R. 6008, the "Requiring Integrity in Conservation Efforts Act" or as the "R.I.C.E.'s Whale Act", (Rep. Graves, R-Louisiana), a bill to prohibit the implementation of certain documents until the Assistant Administrator for Fisheries of the National Marine Fisheries Service issues documents relating to the Rice's whale. Introduced on October 20, 2023, and referred to the House Natural Resources Committee. On November 8, 2023, the House Natural Resources Committee ordered the legislation to be reported with an amendment in the nature of a substitute by the Yeas and Nays: 22 17.
- **H.R. 5239, the "Gulf of Mexico Commerce Protection Act**", (Rep. Higgins, R-Louisiana), a bill to prohibit the issuance of an interim or final rule that establishes a vessel slowdown zone in the Gulf of Mexico until the Secretary of Commerce completes a study demonstrating that proposed mitigation efforts would have no negative impact on supply chains, and for other purposes. Introduced on August 18, 2023, and referred to the House Transportation and Infrastructure Committee.

- S. 2395, the "Wildlife Innovation and Longevity Driver Reauthorization Act" or the "WILD Act", (Sen. Carper, D-Delaware), a bill to reauthorize wildlife habitat and conservation programs, and for other purposes. Introduced on July 19, 2023, and referred to the Senate Environment and Public Works Committee. On July 26, 2023, the bill was ordered to be reported by Senator Carper without amendment and without written report. The bill was placed on the Senate Legislative Calendar. (Note: This legislation includes a reauthorization of the Marine Turtle Conservation Act of 2004.)
- S. 2086, the "Sea Turtle Rescue Assistance Act of 2023", (Sen. Markey, D-Massachusetts), a bill to require the Secretary of Commerce to establish the Sea Turtle Rescue Assistance Grant Program. Introduced on June 21, 2023, and referred to the Senate Commerce, Science, and Transportation Committee.
- **H. Res. 506**, (Rep. Mace, R-South Carolina), a resolution commending the South Carolina Aquarium in Charleston for its outstanding Sea Turtle Care Center and its dedicated efforts in rehabilitating and releasing injured and sick sea turtles, ensuring their return to their natural environment. Introduced on June 13, 2023, and referred to the House Natural Resources Committee.
- S. 1833, the "Protecting Whales, Human Safety, and the Economy Act of 2023", (Sen. Manchin, D-West Virginia), a bill to prohibit the issuance of an interim or final rule that amends, updates, modifies, or replaces the North Atlantic Right Whale vessel strike reduction rule until mitigation protocols are fully developed and deployed. Introduced on June 6, 2023, and referred to the Senate Commerce, Science, and Transportation Committee.
- **H.R. 3119,** (Rep. Soto, D-Florida), a bill to provide for the issuance of a Manatee Semipostal Stamp. Introduced on May 5, 2023, and referred to the House Oversight and Accountability Committee, and in addition to the House Natural Resources Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- H.R. 2560, the "Sea Turtle Rescue Assistance Act of 2023", (Rep. Keating, D-Massachusetts), a bill to require the Secretary of Commerce to establish the Sea Turtle Rescue Assistance Grant Program, and for other purposes. Introduced on April 10, 2023 and referred to the House Natural Resources Committee. On October 24, 2023, the House Natural Resources Committee marked up the legislation. On April 11, 2024, the full House of Representatives passed the legislation.
- H.R. 1383, the "Marine Mammal Climate Change Protection Act", (Rep. Brownley, D-California), a bill to amend the Marine Mammal Protection Act of 1972 to direct the Secretary of Commerce to establish a climate impact management plan for the conservation of certain marine mammal species, and for other purposes. Introduced on March 7, 2023, and referred to the House Natural Resources Committee.
- H.R. 1213, the "Restoring Effective Science-based Conservation Under Environmental laws protecting Whales Act of 2023" or the "RESCUE Whales Act of

- **2023**", (Rep. Grijalva, D-Arizona), a bill to amend the Consolidated Appropriations Act, 2023 by repealing certain provisions relating to North Atlantic right whales. Introduced February 27, 2023, and referred to the House Natural Resources Committee. On April 18, 2023, the House Natural Resources Committee's Subcommittee on Water, Wildlife, and Fisheries held a hearing on the legislation.
- H.R. 131, the "Manatee Protection Act of 2023", (Rep. Buchanan, R-Florida), a bill to designate the West Indian manatee as an endangered species under the Endangered Species Act of 1973, and for other purposes. Introduced on January 9, 2023 and referred to the House Natural Resources Committee.

Seafood Trade Bills:

- **S. 3879, the "Illegal Red Snapper Enforcement Act"**, (Sen. Cruz, R-Texas), a bill to require the Under Secretary of Commerce for Standards and Technology and the Administrator of National Oceanic and Atmospheric Administration to develop a standard methodology for identifying the country of origin of red snapper imported into the United States, and for other purposes. Introduced on March 6, 2024, and referred to the Senate Commerce, Science, and Transportation Committee.
- **S. 3533**, (Sen. Kennedy, R-Louisiana), a bill to appropriate, with an offset, \$36,000,000 for the Seafood Import Monitoring Program of the National Oceanic and Atmospheric Administration to increase audits of imported shrimp and red snapper. Introduced December 14, 2023, and referred to the Senate Finance Committee.
- **S. 3417, the "Ban C-FOOD Act"**, (Sen. Cotton, R-Arkansas), a bill to prohibit the importation of seafood and aquaculture products from the People's Republic of China. Introduced on December 6, 2023, and referred to the Senate Finance Committee.
- **S. 2979, the "India Shrimp Tariff Act"**, (Sen. Cassidy, R-Louisiana), a bill to increase the rate of duty on shrimp originating from India, and for other purposes. Introduced on September 28, 2023, and referred to the Senate Finance Committee. (*Note: this legislation also amends the Country-of-Origin Labeling provisions to add "whole cooked shrimp and crawfish and cooked shrimp and crawfish sections" to the list of seafood requiring COOL labeling.*)
- S. 2847, the "Protecting American Food Producers from Russia's Market Distortions Act of 2023" (Sen. Rubio, R-Florida), a bill to prohibit the importation of agricultural products, raw materials, and food from the Russian Federation if the Russian Federation prohibits the importation of such products, materials, and food from the United States, and for other purposes. Introduced on September 19, 2023, and referred to the Senate Finance Committee.
- **H.R. 4547, the "Laws Ensuring Safe Shrimp Act"**, (Rep. Graves, R-Louisiana), a bill to establish a fund to promote the inspection and consumption of shrimp and products containing shrimp or shrimp parts. Introduced on July 11, 2023, and referred to the House Energy and

Commerce Committee, and in addition to the House Agriculture Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

- **S. 2011, the "United States-Russian Federation Seafood Reciprocity Act of 2023"**, (Sen. Sullivan, R-Alaska), a bill to prohibit the importation of seafood and seafood products from the Russian Federation, and for other purposes. Introduced June 15, 2023, and referred to the Senate Finance Committee.
- H.R. 4165, the "United States-Russian Federation Seafood Reciprocity Act of 2023", (Rep. Graves, R-Louisiana), a bill to prohibit the importation of seafood and seafood products from the Russian Federation, and for other purposes. Introduced on June 15, 2023, and referred to the House Ways and Means Committee.
- **H.R. 1057, the "Imported Seafood Safety Standards Act"**, (Rep. Higgins, R-Louisiana), a bill to amend the Federal Food, Drug, and Cosmetic Act to ensure the safety of imported seafood. Introduced on February 17, 2023, and referred to the House Energy and Commerce Committee.

Aquaculture Legislation:

- **H.R. 6546**, (Rep. Bentz, R-Oregon), a bill to amend the Endangered Species Act of 1973 to allow certain activities to be carried out with regard to certain fish held in captivity or a controlled environment. Introduced on December 1, 2023, and referred to the House Natural Resources Committee.
- H.R. 6393, the "Sturgeon Conservation and Sustainability Act", (Rep. Waltz, R-Florida), a bill to amend the Endangered Species Act of 1973 to allow certain activities to be conducted with respect to sturgeon held in captivity or in a controlled environment in the United States, and for other purposes. Introduced on November 13, 2023, and referred to the House Natural Resources Committee.
- H.R. 5944, the "Science-based Equitable Aquaculture Food Act" or the "SEAfood Act", (Rep. Introduced on February 9, 2023, and referred to the Senate Commerce, Science, and Transportation Committee. Ordered to be reported with an amendment in the nature of a

On September 28, 2023, the House Natural Resources Committee's Subcommittee on Energy and Mineral Resources held a legislative hearing on the bill. On March 5, 2024, the report to accompany the bill was filed and the bill was placed on the Union Calendar.
- H.R. 4031, the "Stop Arctic Ocean Drilling Act of 2023", (Rep. Huffman, D-California), a bill to prohibit drilling in the Arctic Ocean. Introduced on June 12, 2023, and referred to the House Natural Resources Committee.
- H.R. 4030, the "North Pacific Ocean Protection Act of 2023", (Rep. Huffman, D-California), a bill to amend the Outer Continental Shelf Lands Act to prohibit oil and gas leasing in certain areas of the Outer Continental Shelf. - **S. 3642,** (Sen. Lujan, D-New Mexico), a bill to direct the Secretary of Energy and the Administrator of the National Oceanic and Atmospheric Administration to conduct collaborative research to advance weather models in the United States, and for other purposes. Introduced on January 23, 2024, and referred to the Senate Commerce, Science, and Transportation Committee.
- **S. 3633**, (Sen. Carper, D-Delaware), a bill to amend the Coastal Zone Management Act of 1972 to allow the District of Columbia to receive Federal funding under such Act, and for other purposes. Introduced on January 22, 2024, and referred to the Senate Commerce, Science, and Transportation Committee.
- **H.R. 7067**, (Rep. Norton, D-DC-At Large), a bill to amend the Coastal Zone Management Act of 1972 to allow the District of Columbia to receive Federal funding under such Act, and for other purposes. Introduced on January 22, 2024, and referred to the House Natural Resources Committee.
- **H.R. 7066**, (Rep. Newhouse, R-Washington), a bill to prohibit the use of Federal funds to allow or study the breach or alteration of the Lower Snake River dams or implement the Columbia Basin Restoration Initiative, and for other purposes. Introduced on January 22, 2024, and referred to the House Natural Resources Committee.
- **H.R. 7020**, (Rep. McClain, R-Michigan), a bill to direct the Administrator of the National Oceanic and Atmospheric Administration to conduct high-resolution mapping of the lakebeds of the Great Lakes, and for other purposes. Introduced on January 17, 2024, and referred to the House Natural

Resources Committee. On March 21, the House Natural Resources Committee's Subcommittee on Water, Wildlife and Fisheries held a hearing on the legislation.

Fischbach, R-Minnesota), a bill to direct the Secretary of the Interior to establish 2 grant programs to sustain populations of species of migratory waterfowl through the deployment of tools and practices that complement habitat conservation. Introduced on December 12, 2023, and referred to the House Foreign Affairs Committee.
- H.R. 6567, the "Strengthening Capacity for Disaster Resilient Territories Act", (Rep. Velazquez, D-New York), a bill to require the Federal Emergency Management Agency to establish a Territorial Disaster Recovery Program to continuously identify, monitor, and address factors and capability gaps that hinder the execution and completion of recovery activities relating to major disasters by eligible entities located in the territories of the United States. Introduced on December 1, 2023 and referred to the House Transportation and Infrastructure Committee.
- **H. R. 6215, the "No American Climate Corps Act"**, (Rep. Good, R-Virginia), a bill to prohibit Federal funds from being made available for the Justice40 Initiative or for the American Climate Corps. Introduced on November 3, 2023, and referred to the House Energy and Commerce Committee, and in addition to the House Natural Resources Committee, the House Education and the Workforce Committee, and the House Oversight and Accountability Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- H. J. Res. 96, the "Compact of Free Association Amendments Act of 2023", (Rep. Westerman, R-Arkansas), a resolution to approve the 2023 Agreement to Amend the U.S.-FSM Compact, and related agreements, between the Government of the United States of America and the Government of the Federated States of Micronesia, the 2023 Agreement to Amend the U.S.-RMI Compact, and certain related agreements between the Government of the United States of America and the Government of the Republic of the Marshall Islands, and the 2023 U.S.-Palau Compact Review Agreement between the Government of the United States of America and the Government of the Republic of Palau, to appropriate funds to carry out the agreements, and for other purposes. Introduced on November 2, 2023 and referred to the House Natural Resources Committee; the House Foreign Affairs Committee; the House Education and the Workforce Committee; the House Veterans' Affairs Committee; the House Oversight and

Accountability Committee; the House Agriculture Committee; the House Ways and Means Committee. On November 8, 2023, the bill was ordered to be reported by the House Natural Resources Committee by Unanimous Consent.

- H.R. 6062, (Rep. Radewagen, R-American Samoa), a bill to restore the ability of the people of American Samoa to approve amendments to the territorial constitution based on majority rule in a democratic act of self-determination, as authorized pursuant to an Act of Congress delegating administration of Federal territorial law in the territory to the President, and to the Secretary of the Interior under Executive Order 10264, dated June 29, 1951, under which the Constitution of American Samoa was approved and may be amended without requirement for further congressional action, subject to the authority of Congress under the Territorial Clause in article IV, section 3, clause 2 of the United States Constitution. Introduced on September 14, 2023, and referred to the House Natural Resources Committee. On March 21, the House Natural Resources Committee's Subcommittee on Water, Wildlife and Fisheries held a hearing on the legislation.
- **S. 2807, the "Help Our Kelp Act"**, (Sen. Merkley, D-Oregon), a bill to require the Secretary of Commerce to establish and carry out a grant program to conserve, restore, and manage kelp forest ecosystems, and for other purposes. Introduced on September 14, 2023, and referred to the Senate Commerce, Science, and Transportation Committee.
- **H. Res. 688**, (Rep. Posey, R-Florida) A Resolution expressing support for the designation of the week of September 16 through September 23, 2023, as "National Estuaries Week". Introduced on September 14, 2023, and referred to the House Natural Resources Committee.
- H.R. 5441 the "Long Island Sound Restoration and Stewardship Reauthorization Act of 2023", (Rep. LaLota, R-New York), a bill to o reauthorize Long Island Sound programs, and for other purposes. Introduced on September 13, 2023, and referred to the House Transportation and Infrastructure Committee; and the House Natural Resources Committee, for a

period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

- H.R. 5281, the "Lead Endangers Animals Daily Act of 2023" or the "LEAD Act of 2023", (Rep. Lieu, D-California), a bill to require the Secretary of the Interior to prohibit the use of lead ammunition on United States Fish and Wildlife Service lands, and for other purposes. Joyce, R-Ohio), a bill to reauthorize wildlife habitat and conservation programs, and for other purposes. Introduced on July 27, 2023, and referred to the House Natural Resources Committee. On Tuesday, October 24, 2023, the House Natural Resources Committee marked up the legislation.
- **H.R. 5001, the "Special Advisors for Insular Areas Act"**, (Rep. Grijalva, D-Arizona), a bill to establish a position of Special Advisor for Insular Areas in each Executive department, and for other purposes. Introduced on July 27, 2023, and referred to the House Natural Resources Committee.

- S. 2645, the "Preventing Health Emergencies And Temperature-related Illness and Deaths Act of 2023" or the "Preventing HEAT Illness and Deaths Act of 2023", (Sen. Markey, D-Massachusetts), a bill to reduce the health risks of heat by establishing the National Integrated Heat Health Information System within the National Oceanic and Atmospheric Administration and the National Integrated Heat Health Information System Interagency Committee to improve extreme heat preparedness, planning, and response, requiring a study, and establishing financial assistance programs to address heat effects, and for other purposes. Introduced on July 27, 2023, and referred to the Senate Commerce, Science, and Transportation Committee.
- S. 2534, the "Chesapeake Bay Science, Education, and Ecosystem Enhancement Act of 2023", (Sen. Warner, D-Virgina), a bill to amend the National Oceanic and Atmospheric Administration Authorization Act of 1992 to reauthorize the Chesapeake Bay Office of the National Oceanic and Atmospheric Administration, and for other purposes. Introduced on July 26, 2023, and referred to the Senate Commerce, Science, and Transportation Committee.
- S. 2395, the "Wildlife Innovation and Longevity Driver Reauthorization Act" or the "WILD Act", (Sen. Carper, D-Delaware), a bill to reauthorize wildlife habitat and conservation programs, and for other purposes. Introduced on July 19, 2023, and referred to the Senate Environment and Public Works Committee. On July 26, 2023, the bill was ordered to be reported by Senator Carper without amendment and without written report. The bill was placed on the Senate Legislative Calendar. Introduced on July 26, 2023, a referred to the House Judiciary Committee, and in addition to the House Natural Resources Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- H.R. 4916, the "Comprehensive Legislation for Expanding and Advancing Nonrestrictive Energy Act" or the "CLEAN Energy Act", (Rep. Kamlager-Dove, D-California), a bill to amend the Inflation Reduction Act of 2022 to repeal restrictions on onshore wind and solar. Introduced on July 26, 2023, and referred to the House Natural Resources Committee.
- H.R. 4866, the "Fire Weather Development Act of 2023", (Rep. Garcia, R-California), a bill to direct the Administrator of NOAA to establish a program to improve fire weather and fire environment forecasting, detection, and local collaboration, and for other purposes. Introduced on July 25, 2023, and referred to the House Science, Space and Technology Committee. On July 27, 2023, the House Science, Space, and Technology Committee ordered the bill to be Reported (Amended) by the Yeas and Nays: 33 2.

- H.R. 4770, the "Chesapeake Bay Science, Education, and Ecosystem Enhancement Act of 2023", (Rep. Sarbanes, D-Maryland), a bill to reauthorize the Chesapeake Bay Office of the National Oceanic and Atmospheric Administration, and for other purposes. Introduced on July 20, 2023, and referred to the House Natural Resources Committee. On Tuesday, October 24, 2023, the House Natural Resources Committee marked up the legislation. On April 2, 2024, the House Natural Resources Committee filed the report to accompany the legislation.
- H.R. 4538, the "Boosting Long-term U.S. Engagement in the Pacific Act" or the "BLUE Pacific Act", (Rep. Case, D-Hawaii), a bill to establish a comprehensive, long-term United States strategy and policy for the Pacific Islands, and for other purposes. Introduced on July 11, 2023, and referred to the House Foreign Affairs Committee; and in addition, to the House Natural Resources Committee; and the House Ways and Means Committee for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **H.R. 4537, the "American Seabed Protection Act"**, (Rep. Case, D-Hawaii), a bill to prohibit certain mining activities on the deep seabed and Outer Continental Shelf, and for other purposes. Introduced on July 11, 2023, and referred to the House Natural Resources.
- S. 2247, the "Upper Colorado and San Juan River Basins Endangered Fish Recovery Programs Reauthorization Act of 2023", (Sen. Hickenlooper, D-Colorado), a bill to reauthorize the Bureau of Reclamation to provide cost-shared funding to implement the endangered and threatened fish recovery programs for the Upper Colorado and San Juan River Basins. Introduced on July 11, 2023, and referred to the Senate Energy and Natural Resources Committee. Salazar, R-Florida), a bill to amend the Neotropical Migratory Bird Conservation Act to make improvements to that Act, and for other purposes. Murkowski, R-Alaska), a bill to require the Secretary of Commerce to establish a grant program to facilitate the training and employment of veterans for certain conservation activities, and for other purposes. Introduced on June 8, 2023, and referred to the Senate Commerce, Science, and Transportation Committee.
- **S. 1860**, the "Youth Coastal Fishing Program Act of 2023", (Sen. Wicker, R-Mississippi), a bill to direct the National Oceanic and Atmospheric Administration to establish a grant program to fund youth fishing projects. Introduced on June 7, 2023, and referred to the Senate Commerce, Science, and Transportation Committee.
- H.R. 3925, the "Youth Coastal Fishing Program Act of 2023", (Rep. Salazar, R-Florida), a bill to direct the National Oceanic and Atmospheric Administration to establish a grant program to fund youth fishing projects. Introduced on June 7, 2023, and referred to the House Natural Resources Committee.
- H.R. 3918, the "Upper Colorado and San Juan River Basin Endangered Fish Recovery Programs Reauthorization Act of 2023", (Rep. Neguse, D-Colorado), a bill to reauthorize the Upper Colorado and San Juan River Basin endangered fish and threatened fish recovery implementation programs. Introduced on June 7, 2023, and referred to the House Natural Resources Committee.
- H.R. 3746, the "Fiscal Responsibility Act of 2023", (Rep. McHenry, R-North Carolina), a bill to provide for a responsible increase to the debt ceiling. - H.R. 3256, the "Preventing Executive Climate Overreach Act", (Rep. Pfluger, R-Texas), a bill to provide that Executive Order 14096 shall have no force or effect. Introduced on May 11, 2023, and referred to the House Energy and Commerce Committee, and in addition to the House Natural Resources Committee, and the House Science, Space, and Technology Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- S.1421, the "Country Of Origin Labeling Online Act" or the "COOL Online Act", (Sen. Baldwin, D-Wisconsin), a bill to require origin and location disclosure for new products of foreign origin offered for sale on the internet. Introduced on May 3, 2023, and referred to the Senate Commerce, Science, and Transportation Committee. On Thursday, July 27, 2023, the Senate Commerce, Science and Transportation Committee ordered the bill to be reported with an amendment in the nature of a substitute. On December 13, 2023, the Senate Commerce, Science, and Transportation Committee reported the bill with an amendment in the nature of a substitute and without written report. On December 13, 2023, the bill was placed on the Senate Legislative Calendar under General Orders.
- **S. 1416, the "NWR Modernization Act of 2023",** (Sen. Cantwell, D- Washington), a bill to provide guidance for and investment in the upgrade and modernization of the National Oceanic and Atmospheric Administration Weather Radio All Hazards network, and for other purposes. Introduced on May 3, 2023, and referred to the Senate Commerce, Science, and Transportation Committee.
- **H.R. 3026**, (Rep. Plaskett, D-Virgin Islands), a bill to provide for the adoption of the Revised Organic Act of the Virgin Islands as the constitution of the United States Virgin Islands. Introduced on April 28, 2023, and referred to the House Natural Resources Committee.
- H.R. 2990, the "National Oceanic and Atmospheric Administration Sexual Harassment and Assault Prevention Improvements Act of 2023", (Rep. Bonamici, D-Oregon), a bill to amend the National Defense Authorization Act for Fiscal Year 2017 to address sexual harassment involving National Oceanic and Atmospheric Administration personnel, and for other purposes. Introduced April 28, 2023, and referred to the House Natural Resources Committee, and in addition to the House Transportation and Infrastructure Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such

provisions as fall within the jurisdiction of the committee concerned. On October 25, 2023, the House Natural Resources Committee's Subcommittee on Water, Wildlife, and Fisheries held a hearing on the bill.

- S. 1381, the "Coastal Habitat Conservation Act of 2023", (Sen. Cardin, D-Maryland), a bill to authorize the Secretary of the Interior, through the Coastal Program of the United States Fish and Wildlife Service, to work with willing partners and provide support to efforts to assess, protect, restore, and enhance important coastal landscapes that provide fish and wildlife habitat on which certain Federal trust species depend, and for other purposes. Introduced on April 27, 2023, and referred to the Senate Environment and Public Works Committee. On July 26, 2023, the bill was ordered to be reported by Senator Carper without amendment and without written report. The bill was placed on the Senate Legislative Calendar.
- H.R. 2811, the "Limit, Save, Grow Act of 2023", (Rep. Arrington, R-Texas), a bill to provide for a responsible increase to the debt ceiling, and for other purposes. Introduced on April 25, 2023, and referred to the House Ways and Means Committee, and in addition to the House Budget Committee, the House Appropriations Committee, the House Oversight and Accountability Committee, the House Education and the Workforce Committee, the House Agriculture Committee, the Energy and Commerce Committee, the House Judiciary Committee, the House Rules Committee, the House Transportation and Infrastructure Committee, and the House Natural Resources Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned. On April 26, 2023, the bill passed the House of Representatives.
- **H.R. 2757, the "Puerto Rico Status Act"**, (Rep. Grijalva, D-Arizona), a bill to enable the people of Puerto Rico to choose a permanent, nonterritorial, fully self-governing political status for Puerto Rico and to provide for a transition to and the implementation of that permanent, nonterritorial, fully self-governing political status, and for other purposes. Introduced on April 20, 2023, and referred to the House Natural Resources Committee.
- H.R. 2459, the "Hawaii Native Species Conservation and Recovery Act of 2023", (Rep. Case, D-Hawaii), a bill to establish a competitive grant program to support the conservation and recovery of native plant and animal species in the State of Hawaii, and for other purposes. Introduced on April 3, 2023, and referred to the House Natural Resources Committee.
- **H.R. 2215**, (Rep. Biggs, R-Arizona), a bill to provide for a limitation on availability of funds for Related Agencies, Executive Office of the President: Council on Environmental Quality and Office of Environmental Quality for fiscal year 2024. Introduced on March 29, 2023, and referred to the House Natural Resources Committee.
- **H.R. 2179**, (Rep. Biggs, R-Arizona), a bill to provide for a limitation on availability of funds for U.S. Department of Interior, Insular Affairs, Compact of Free Association for fiscal year 2024. Introduced on March 29, 2023, and referred to the House Natural Resources Committee; and in addition to the House Foreign Affairs Committee, for a period to be

subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

- **H.R. 2178**, (Rep. Biggs, R-Arizona), a bill to provide for a limitation on availability of funds for U.S. Department of Interior, Insular Affairs, Assistance to Territories for fiscal year 2024. Introduced on March 29, 2023, and referred to the House Natural Resources Committee.
- **H.R. 2163**, (Rep. Biggs, R-Arizona), a bill to provide for a limitation on availability of funds for U.S. Department of Interior, US Fish and Wildlife Service, Multinational Species Conservation Fund for fiscal year 2024. Introduced on March 29, 2023, and referred to the House Natural Resources Committee.
- **H.R. 2127**, (Rep. Biggs, R-Arizona), a bill to provide for a limitation on availability of funds for Independent Agencies, Morris K. Udall and Stewart L. Udall Foundation, Environmental Dispute Resolution Fund for fiscal year 2024. Introduced on March 29, 2023, and referred to the House Education and the Workforce Committee; and in addition to the House Natural Resources Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- H.R. 1786, the "Get Rewarding Outdoor Work for our Veterans Act" or the "GROW Act", (Rep. Levin, D-California), a bill to direct the Secretary of Veterans Affairs to submit to Congress a report on the Warrior Training Advancement Course, to direct the Secretary of the Interior to administer a pilot program to employ veterans in positions that relate to conservation and resource management activities of the Department of the Interior, and for other purposes. Introduced on March 24, 2023, and referred to the House Veterans' Affairs Committee and in addition to the House Natural Resources Committee for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned. On April 18, 2023, the House Veterans' Affairs Committee's Subcommittee on Economic Opportunity marked up the legislation. On July 20, 2023, the House Natural Resources Committee on Federal Lands held a hearing on the legislation. On September 20, 2023, the House Natural Resources Committee ordered the bill to be reported by unanimous consent.
- H.R. 1762, the "Northwest Energy Security Act", (Rep. Newhouse, R-Washington), a bill to provide for operations of the Federal Columbia River Power System pursuant to a certain operation plan for a specified period of time, and for other purposes. Introduced on March 23, 2023, and referred to the House Natural Resources Committee, and in addition to the House Transportation and Infrastructure Committee for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **H.R. 1760**, (Rep. Moylan, R-Guam), a bill to extend the admission to Guam or the Commonwealth of the Northern Mariana Islands for certain nonimmigrant H-2B workers. Introduced on March 23, 2023, and referred to the House Natural Resources Committee, and in addition to the House Judiciary Committee, for a period to be subsequently determined by the

Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

- H.R. 1705, the "A. Donald McEachin Environmental Justice For All Act", (Rep. Grijalva, D-Arizona), a bill to restore, reaffirm, and reconcile environmental justice and civil rights, and for other purposes. Introduced on March 22, 2023, and referred to the House Energy and Commerce Committee, and in addition to the House Natural Resources Committee, the House Judiciary Committee, the House Transportation and Infrastructure Committee, the House Agriculture Committee, and the House Education and the Workforce Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- H.R. 1673, the "Protection from Cumulative Emissions and Underenforcement of Environmental Law Act of 2023", (Rep. DeGette, D-Colorado), a bill to advance environmental justice by addressing cumulative impacts and underenforcement, and for other purposes. Introduced on March 21, 2023, and referred to the House Energy and Commerce Committee, and in addition to the House Natural Resources Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- H.R. 1560, the "Public Water Supply Invasive Species Compliance Act of 2023", (Rep. Moran, R-Texas), a bill to exempt from the Lacey Act and the Lacey Act Amendments of 1981 certain water transfers between any of the States of Texas, Arkansas, and Louisiana, and for other purposes. Introduced on March 10. 2023, and referred to the House Natural Resources Committee, and in addition to the House Judiciary Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- H.R. 1482, the "NOAA Weather Radio Modernization Act of 2023" or the "NWR Modernization Act of 2023", (Rep. Bice, R-Oklahoma), a bill to provide guidance for and investment in the upgrade and modernization of the National Oceanic and Atmospheric Administration Weather Radio All Hazards network, and for other purposes. On March 29, 2023, the House Science, Space, and Technology Committee ordered the bill to be reported by the Yeas and Nays: 36-0. On May 16, 2023, the report to accompany the legislation was filed and the bill was placed on the Union Calendar.
- H.R. 1400, the "Territories Statistics Collection Equity Act", (Rep. Grijalva, D-Arizona), a bill to direct the Interagency Council on Statistical Policy to develop a plan to collect and publish statistics regarding the Territories of the United States in the same manner as statistics are collected and reported by Federal agencies for the several States, and for other purposes. Introduced on March 7, 2023, and referred to the House Natural Resources Committee, and in addition to the House Oversight and Accountability Committee, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
