FUTURE COUNCIL MEETING AGENDA AND WORKLOAD PLANNING

This agenda item is intended to refine general planning for future Pacific Fishery Management Council (Council) meetings with a focus on finalizing the proposed agenda for the November 2024 Council meeting in Costa Mesa, California. The following primary attachments are intended to help facilitate Council planning:

- 1. Preliminary Year-at-a-Glance (YAG) An abbreviated display of potential agenda items for the next five Council meetings (Attachment 1). Several agenda items have impacts that span across multiple Fishery Management Plans (FMPs) and are labeled "Cross FMP." Shaded items on the YAG indicate uncertainty regarding the availability of materials needed for the advanced briefing book, which is essential for supporting Council action. The uncertainty is related to Council and National Marine Fisheries Service staff capacity and complexity of the action. The Executive Director will suggest removing the shading from an item if or when clarity arises regarding staff capacity to commit to the agenda item as scheduled. The second page of Attachment 1 includes acronyms and the proposed 2025 Advisory Body meeting schedule and meeting formats.
- 2. Quick Reference A preliminary proposed abbreviated display of the November 2024 Council meeting agenda (Attachment 2).

The Executive Director will assist the Council in reviewing the proposed agenda materials and discussing any other matters relevant to Council meeting agendas and workload. After considering supplemental material provided at the Council meeting, and any reports and comments from advisory bodies and public, the Council will provide guidance for future agenda development, the proposed November Council meeting agenda, and workload priorities for Council staff and advisory bodies.

At the June 2024 Council meeting, during the Council Operations and Priorities agenda item, the Council discussed discontinuing their review of exempted fishing permit renewal applications. Under this agenda item, the Council should decide whether to review the Coastal Pelagic Species exempted fishing permit renewals which are scheduled for the November 2024 Council meeting (Attachment 2; Agenda Item J.3).

Council Action:

- 1. Review pertinent information and provide guidance on potential agenda topics for future Council meetings.
- 2. Provide final guidance on the proposed November agenda and plans for future Council meetings.
- 3. Identify priorities for advisory body workload considerations.
